Benefit Specific Eligibility:

• Noted in bold underlined print - must be documented in Section 3 on authorization (1250) form.

Minimum Standards for products provided under Walking Aids and Accessories Approved Product List (APL):

- Warranty: Manufacturer must warrant that the product will be free from defects in material and workmanship for a minimum of three years from the date equipment was purchased.
- Equipment Limitations: Equipment must have been in the North American marketplace for a minimum of one year
- Liability Insurance: Manufacturer must have minimum two million dollars comprehensive general liability insurance on equipment.
- Durability: Equipment must be designed to last a minimum of 3 years under normal use.

AADL vendors:

- Offer clients a choice of products that meets AADL generic description and product standards at or below AADL's price.
- Ensure equipment standards are met by any products provided under catalogue benefit numbers on APL.
