### **Agrology Technologist**

**Registration Process** 

#### **Description of Occupation**

Agrology Technologists provide technology advice and services for a variety of agricultural and environmental applications. They apply technological approaches to the production, improvement, use, processing and marketing of plants and animals, and the management of related resources.

Agrology Technologists work in diverse areas ranging from environmental and agricultural land management and resource conservation. This includes soil, water and wildlife resource protection; crop and livestock development, production and management; business management and financial systems; and contaminated land remediation and reclamation.

#### **Obtaining Registration in Alberta**

In Alberta, Agrology Technologists who meet the registration requirements of the Alberta Institute of Agrologists (AIA) must be registered with the AIA. To obtain the Registered Technologist in Agrology (RTAg) designation you must:

Complete a recognized diploma or applied degree in agriculture or environmental science (or equivalent).	
Apply to AIA for the Agrology Technologist in Training Program.	
Complete the Agrology Technologist in Training Program.	
Submit a proposed Scope of Practice statement.	

Only registered AIA members may call themselves an Agrology Technologist in Training or a Registered Technologist in Agrology.

Complete the **New Member Application Form** and provide detailed and accurate answers to all questions. Applications and required documents can be submitted online through the AIA website, or you can send them to AIA at the following address:

### **Residency Requirement**

You must be a Canadian citizen or lawfully permitted to work or study in Canada in order to start the application process.

### Registration Requirements

Internationally educated Agrology Technologists must meet and confirm the following requirements to be eligible for membership with the AIA:

#### 1. Academic Credentials

The minimum education requirement for admission to the Agrology Technologist in Training program is a two (2) year diploma or applied degree in which you have achieved a minimum of sixty (60) credits. This includes:

- Canada 🖦
- ☐ A minimum of thirty-three (33) credits related to the practice of agrology
  - Eighteen (18) credits must be beyond the introductory level
  - Fifteen (15) credits can be in any agrology courses
- ☐ Nine (9) credits must be in natural sciences
- ☐ Eighteen (18) credits can be in any area
  - Six (6) of these credits should be beyond the introductory level

All courses must have Canadian college or university equivalency. AlA will review your academic transcripts to determine if you meet the academic requirements.

You should contact the academic institution you graduated from and request that an official copy of your academic transcripts be sent directly to the AIA office at:

If AIA determines that you do not meet the academic requirements for membership then:

- You will be advised what courses you need to take.
- You will be asked to submit a plan of course studies which AIA must approve.
- When you successfully complete the courses your academic qualifications will be approved.

#### Note:

AlA is not able to assess foreign credentials before you arrive in Canada. To have your credentials assessed before arriving in Canada, contact the academic institution where you were trained. Have them send your transcripts to the International Qualifications Assessment Service (IQAS) at:

IQAS compares educational qualifications from other countries to provincial educational standards.

An IQAS assessment does not guarantee recognition of your qualifications in Canada. However, it may help speed up the application process with AIA once you arrive in Canada. You are responsible for paying the assessment costs.

#### 2. Work Experience

Agrology Technologists in Training must have a minimum of three (3) years post-graduate agrology work experience to obtain RTAg status. A minimum of one (1) year Canadian work experience is mandatory.

You may be given up to two (2) years credit for verified, equivalent work experience outside of Canada.

When completing the New Member Application Form, you should submit an up-to-date resumé. The resumé should describe your complete employment history, including current employment. You must provide references from professionals who are registered with a professional organization and who can verify your work experience outside of Canada.

#### 3. Good Character and Reputation

Once you complete the Agrology Technologist in Training work experience requirements, you can apply for RTAg status. At this time, three (3) professional references must be provided. One (1) of those references must provide evidence of your good character and reputation.

#### 4. English Language

You must demonstrate an ability to communicate (read and write) in English. English proficiency may be verified by AIA through verbal communication. You may also be asked to demonstrate writing ability in person.

#### **Examinations**

Once your application to become an Agrology Technologist in Training has been approved, you must pass exams in four (4) modules to obtain RTAg status.

The modules and exams are offered by AIA. The minimum passing grade for all exams is 70 per cent. Exams are available in English. Agrology Technologists in Training must pay for the cost of the exams.

#### Note:

Agrology Technologists in Training have a maximum of three (3) years to complete their training.

In addition to passing the exams, there are other requirements Agrology Technologists in Training must meet to obtain RTAg status including but not limited to:

- Attendance at the annual AIA conference and annual general meeting.
- A minimum three (3) years post-graduate agrology work experience, including a minimum of one (1) year Canadian experience.
- Demonstrated competency in communication and project management.
- Three (3) professional references must be provided who will recommend you for RTAg status.

#### Scope of Practice

You will need to identify on the New Member Application Form your primary practice area(s). AIA has identified thirty-three (33) practice areas in four (4) agrology sectors including: Life sciences; environment; agriculture and food. (See Resources section at the end of this document for a complete description of the practice areas.)

Applicants with three (3) or more years post-graduate agrology-related work experience should provide a written description of their current agrology practice. Based on the information received and verified, the AIA Registration Committee will review your Scope of Practice. Agrology Technologists in Training are required to have their Scope of Practice approved by the Registration Committee prior to receiving the RTAg designation.

### **Payment**

The following fees may apply for internationally educated applicants. All fees are in Canadian dollars. Fees are subject to change. See association websites for the most up-to-date fees.

 Agrology Technologists in Training are also responsible for the cost of attending workshops, annual conferences and any other events or activities that may be necessary to complete the program.
