After reviewing the information available to me, I have concluded that the **Hutterian Brethren Church of Alix** has contravened Section 36(1) of the *Water Act*, which is an offence pursuant to 142(1)(h) of the *Water Act* in respect of which an administrative penalty may be imposed. Particulars of the contravention are as follows:

October 12th and 13th, 2022

DETAILS: On October 12th and 13th, 2022, the Party conducted an activity without an approval or authorization by removing or disturbing ground in several waterbodies which changed the location and flow of water.

NE & SE 15-39-23-W4M Lacombe County, Alberta

I am assessing an administrative penalty of **\$10,000.00** pursuant to section 152 of the *Water Act* and the Water (Offences and Penalties) Regulation, A.R. 193/98, and as noted in the attached decision document.

You are required to submit payment for the administrative penalty within thirty (30) days of the date of service of this Notice. If payment has not been received in the thirty (30) day period, the amount payable is recoverable in an action in debt.
