**Re: Deciduous Pulp Dues Rates for the Period October 1 to October 31, 2019**

This letter provides notice of Crown Timber and Forest Resource Improvement Association of Alberta (FRIAA) dues for deciduous pulpwood as established in the Timber Management Regulation and the Forest Resources Improvement Regulation.

Please submit your timber returns for the period October 1 to October 31, 2019 using the following rates:

<b>Timber Dues Type</b>	<b>General Rate of Dues for Deciduous Timber used to make Pulp (\$/m<sup>3</sup>)</b>
<b>Crown Timber Dues</b>	0.82
<b>FRIAA Dues</b>	0.07
<b>Total Dues</b>	0.89

These rates have been calculated in accordance with the Timber Management Regulation and the Forest Resources Improvement Regulation.

The **Crown Timber Dues** are payable to the **Government of Alberta**. Please be sure only to pay the net timber dues to the Government of Alberta.
