Proposed Terms of Reference for Environmental Impact Assessment

Osum Oil Sands Corp. (Osum) is proposing to develop the Taiga In-Situ Project on Oil Sands Leases, located in north-eastern Alberta. The project area is located approximately 20 kilometres north of the City of Cold Lake, Alberta in Townships 65, Ranges 1 and 2, and Township 66, Ranges 1 and 2, west of the 4th meridian. The Taiga Project will utilize thermal recovery techniques. Both Steam Assisted Gravity Drainage (SAGD) and Cyclical Steam Stimulation (CSS) technologies are proposed for extraction of the bitumen. The Taiga Project will include a bitumen processing facility with a capacity of 35,000 barrels per day and a production life of approximately 30 years.

The Director responsible for Environmental Assessment has directed that an Environmental Impact Assessment Report be prepared for the Taiga Project. Osum has prepared proposed Terms of Reference for this Environmental Impact Assessment, and through this public notice, invites the public to review this document.
