After reviewing the information available to me, I have concluded that **Rootselaar Ridge Ltd.** has contravened section 142(1)(e) of the *Water Act* in respect of which an administrative penalty may be imposed. Particulars of the contravention are as follows:

DETAILS: The Party contravened condition 1(a) of Water Act Licence no. 42448-00-00, as amended, by diverting natural flow from Willow Creek at the specified point of diversion when there was not sufficient river flow to meet or exceed the Instream Objective of 28 cubic feet per second (0.8 cubic metres per second) for August, 2023.

I am assessing an administrative penalty of **\$2000.00** pursuant to section 152 of the *Water Act* and the Water (Offences and Penalties) Regulation, A.R. 193/98, and as noted in the attached decision document.

You are required to submit payment for the administrative penalty within thirty (30) days of the date of service of this Notice. If payment has not been received in the thirty (30) day period, the amount payable is recoverable in an action in debt.
