ENFORCEMENT ORDER NO. WA-EO-2019/01-LAR

WHEREAS the Municipal District of Bonnyville No. 87 [the "Municipality"] owns and operates a right-of-way [the "ROW"] on the lands legally described as SE-20-62-5-W4M and SW-21-62-5-W4M located within the Municipal District of Bonnyville No. 87, Alberta [the "Lands"];

WHEREAS the Enforcement Order ("EO") was issued to the Municipality on June 11, 2019,

WHEREAS Amendment #1 to the EO was issued to the Municipality on October 29, 2019,

WHEREAS on June 25, 2020, the Environmental Protection Officer received communication from Paul KALASHNIKOFF, of Wood Environment and Infrastructure Solutions, (the "Consultant" working on behalf of the Municipality), requesting an extension of the EO completions dates;

WHEREAS the Consultant has requested an extension of clause 3, the completion date of the Remedial Plan, from **August 30, 2019**, to **August 26, 2020**;

WHEREAS the Environmental Protection Officer recommends the dates of Clause 3, of the EO be extended as requested by the Consultant;

WHEREAS the Consultant has requested the extension of clause 4 h, of the revised Remedial Plan from **December 20, 2019** to **December 17, 2020**;

WHEREAS the Environmental Protection Officer recommends the dates of Clause 4 h, of the EO be extended as requested by the Consultant;

WHEREAS the Consultant has requested the extension of the clause 4 j; re-vegetation portion (installation of shrub potted stock plantings) of the Remedial Plan from <u>June 30, 2020</u> to <u>June 30, 2021</u>;

WHEREAS Alberta Environment and Parks, Environmental Protection Officer recommends the dates of Clause 4 j, of the EO be extended as requested by the Consultant;

WHEREAS the Consultant has requested the extension of Clause 7, the submission of a written Final Report to the Director from <u>June 30, 2020</u>, to <u>June 30, 2021</u>;

WHEREAS the Environmental Protection Officer recommends the dates of Clause 7, of the EO be extended as requested by the Consultant;

WHEREAS, Simon Tatlow, Compliance Manager, Regulatory Assurance Division, North Region [the "Director"] has been designated as a Director for the purpose of issuing and amending enforcement orders under the *Water Act*.

THEREFORE, I, Simon Tatlow, Director, pursuant to Sections 137(1)(a) of the *Water Act*, DO HEREBY AMEND the EO THAT:

- 1. In clause 3, of the Enforcement Order No. WA-EO-2019/01-LAR, the date of "August 30, 2019" is deleted and "August 26, 2020" is inserted in its place.
- 2. In clause 4 h, of the Enforcement Order No. WA-EO-2019/01-LAR, the date of "December 20, 2019" is deleted and "December 17, 2020" is inserted in its place.
- 3. To be included as clause 4 j, of the Enforcement Order No. WA-EO-2019/01-LAR, that the Municipality shall complete the re-vegetation portion of the Remedial Plan no later than "June 30, 2021"
- 4. In clause 7, of the Enforcement Order No. WA-EO-2019/01-LAR, the date of <u>"June 30, 2020"</u> is deleted and <u>"June 30, 2021"</u> is inserted in its place.
