Shell Scotford Upgrader 2
Environmental Impact Assessment
Proposed Terms of Reference

Shell Canada Limited (Shell Canada) is seeking approval to construct and operate the Scotford Upgrader 2 in the Industrial Heartland of Strathcona County located northeast of Edmonton, Alberta. The project area comprises approximately 1,800 hectares of land owned by Shell Canada covering all or portions of NW 16-056-21W4 (portion), SW 16-056-21W4 (portion), SE 16-056-21W4, NW 09-056-21W4 (portion), SE 09-056-21W4, NE 08-056-21W4 (portion), SE 08-056-21W4 (portion), SW 08-056-21W4 (portion), NW 05-056-21W4 (portion), NE 05-056-21W4, NW 04-056-21W4, NE 04-056-21W4, All 33-055-21W4, North 28-055-21W4, South 30-055-21W4, NW 30-055-21W4.

Subject to regulatory approval, the proposed upgrader facilities will process Shell Canada's share of bitumen from future Athabasca Oil Sands Project bitumen production as well as bitumen from Shell Canada's in situ oil sands developments into synthetic crude oil for the refinery market. At full operational capacity, Scotford Upgrader 2 will produce 400,000 bbl/day of synthetic crude oil over a 30-year period.

The Director responsible for Environmental Assessment (the "Director") has directed that pursuant to Section 44(1)(a) of the Environmental Protection and Enhancement Act (EPEA), an Environmental Impact Assessment report be prepared and submitted for the proposed the Scotford Upgrader 2. Shell Canada has prepared proposed Terms of Reference and a Public Disclosure Document for this Environmental Impact Assessment and through this Public Notice invites the public to review these documents.
