November 2021

Bargaining Update is a monthly report that provides information about the unionized workforce, primarily in Alberta.

The settlement data reported in this issue of Bargaining Update is based on the collective agreement settlement information received by Mediation Services in November 2021.

In November 2021, Mediation Services received settlement information regarding 17 bargaining relationships encompassing 10,474 employees. There were 14 private sector and 3 public sector settlements, covering 10,283 and 191 employees respectively.

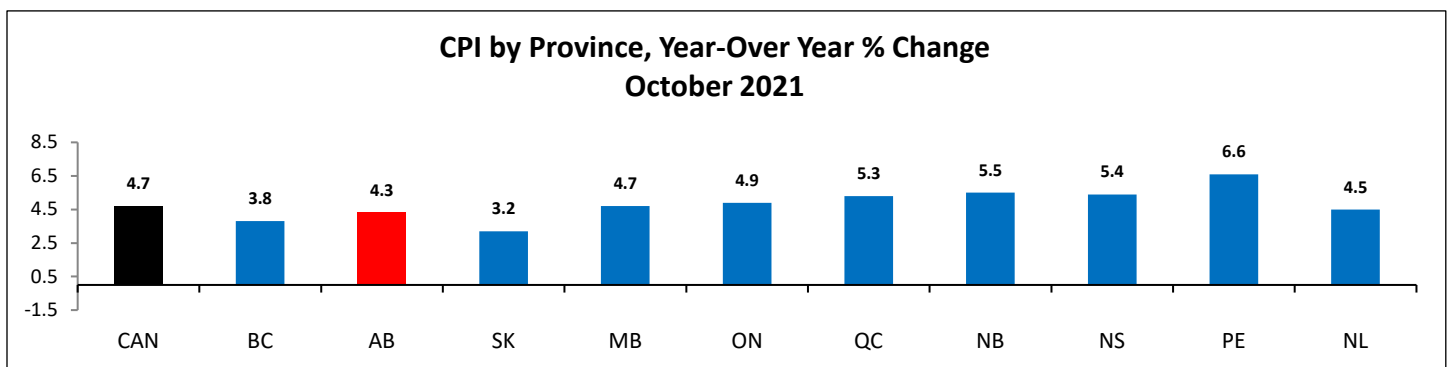
