The AADL Guidelines for Selecting Speech Generating Communication Devices provides a description of communication competencies expected for each category of communication device.

All communication software and communication apps in the SGCD approved product list are selected to support a robust language system.

Catalogue No A400, Alphabet Based Devices

Devices in this category are alphabet/keyboard based systems with synthesized speech output and a display that shows the message created. Features may include a combination of rate enhancement strategies including abbreviation expansion, word prediction, and the ability to pre-store some words and phrases. These devices are primarily used for direct access with a keyboard. Switch access may be an option. Alphabet based devices are used by communicators with sufficient literacy skills to create a message for communication purposes and a preference to use writing as the basis for the message set: typically independent communicators and context dependent 3 communicators.

Catalogue No A402, Simple Static Display Devices

Devices in this category have static displays with a customized printed overlay, digitized speech and simple programming options. Message sets are primarily phrase or word based, and typically represented through pictures or photographs. They are designed for communicators who are able to use a small pre-recorded message set of approximately 50+ messages. They are suitable for individuals who are Content Dependent 2 communicators.

Catalogue No A406, Dynamic Display Devices

Devices in this category are tablet based with a touch screen dynamic display, synthesized and digitized speech, and multiple message formulation options. Features may include direct and indirect access options, internal cameras, Bluetooth, and hardware and software options to support face-to-face and electronic forms of communication. Communication software provides options to create messages based on a combination of core words, pre-stored phrases, spelling with or without word prediction, and grammar support. Symbol sets vary depending on the communication software selected, and may include words, spelling/text, and digital images of pictures or photos.

These SGCDs are suitable for communicators who are able to combine words and phrases to create unique messages and have communication needs for face-to-face communication and electronic forms of communication. The expectation is that communicators will demonstrate skills as independent communicators or context dependent 3 communicators.

Devices are provided with the manufacturer’s standard communication software, symbol sets and voices as indicated in the table below.

The apps have been selected to be suitable for communicators who are able to combine words and phrases to create unique messages, consistent with the communication abilities of context dependent communicator 2, context dependent communicator 3 and independent communicators.

Communication apps have been selected to support communication needs based on these categories for language representation: symbol based, core word based, alphabet with word prediction, or hybrid combinations.

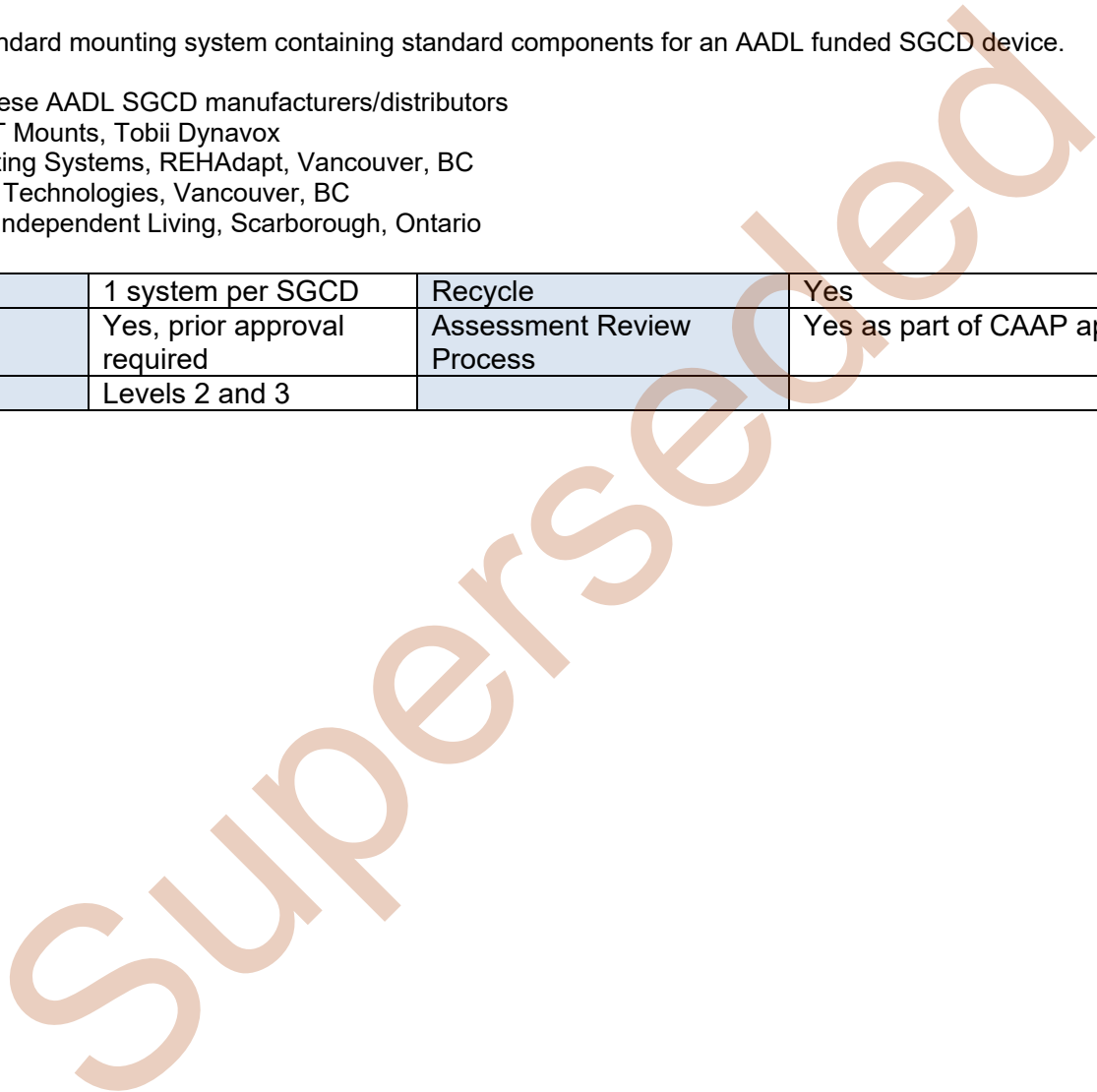
