General

A roadside memorial is an object (typically ornamental) constructed, erected, or placed in the highway right-of-way to memorialize a person fatally injured in a motor vehicle related accident.

Memorial displays can cause safety concerns as they may distract drivers or become a hazard for errant vehicles. For this reason, the erection of roadside memorials is discouraged.

Instead, individuals may consider enrolling in the Adopt-A-Highway program. The program provides an opportunity to display a tab sign stating "In Memory Of..." under a Caring for Alberta Highways sign. More information can be obtained about this program on the department's website at:

Guidelines for Use

Alberta Infrastructure and Transportation follows a policy of maintaining a safe roadside and discourages memorial displays within the highway right-of-way.

Existing memorials which do not pose safety or operational concerns (such as smaller objects or plaques placed at the ground level) will be allowed to remain for a short time (usually one to two months). It is the responsibility of the person erecting a roadside memorial to remove it after this time period has elapsed.

No roadside memorials will be allowed to

remain permanently.

When a roadside memorial poses a hazard to the travelling public, a district representative will contact the person who placed the display, if his or her identity is known, and negotiate relocation to the fence line, installation of a smaller display or removal of the display. All relocated memorials should be removed after a period of approximately one to two months.

The department reserves the right to relocate or remove a memorial display if that display or object poses an immediate danger to the public. Efforts will be made to contact the owner before relocating or removing a display.

The following objects will not be allowed within the highway right-of-way:

- objects placed on the roadway surface
- memorials constructed from heavy materials or any large object that has a solid base or is secured in such manner that creates a hazard to an errant vehicle
- memorials that hinder or impede maintenance operations, restrict driver's sight lines, create a distraction to the travelling public or interfere with or obstruct traffic control devices.
- memorials made of reflective material or illuminated by any means
- memorials placed in the median, on bridges or overpasses, around power poles, culverts, street lighting fixtures, signs or other roadway appurtenances
- memorials that pose concerns for landowners of adjacent properties.
