### NOTICE OF ADMINISTRATIVE PENALTY

After reviewing the information available to me, I have concluded that the **Village of Rycroft** has contravened section 227(e) of the *Environmental Protection and Enhancement Act* in respect of which an administrative penalty may be imposed. Particulars of the contravention are as follows:

DATE (S) OF CONTRAVENTION (S): October 18, 2022 – July 24, 2023

LEGAL DESCRIPTION/LOCATION:

NE-16-78-5-W5M Rycroft, Alberta DETAILS: The Party holds Approval no. 1135-03-00, as amended, for the construction, operation, and reclamation of a waterworks system. On or between October 18, 2022, and July 24, 2023, they contravened sections 6.1.1 and 6.1.3 of the approval by failing to immediately report to the Director any contravention of the approval, and, in addition to immediate reporting, failed to provide written reports within 7 calendar days of the contravention.

I am assessing an administrative penalty of **\$1,000.00** pursuant to section 237 of the *Environmental Protection and Enhancement Act* and the Administrative Penalty Regulation, AR 23/2003, and as noted in the attached decision document.

You are required to submit payment for the administrative penalty within thirty (30) days of the date of service of this Notice. If payment has not been received in the thirty (30) day period, the amount payable is recoverable in an action in debt.
