Bargaining Update is a monthly report that provides information about the unionized workforce, primarily in Alberta.

The settlement data reported in this issue of Bargaining Update is based on the collective agreement settlement information received by Mediation Services in January 2023.

In January 2023, Mediation Services received settlement information regarding 59 bargaining relationships encompassing 10,344 employees. There were 36 private sector and 23 public sector settlements, covering 6,970 and 3,374 employees respectively.

Why Choose Grievance Mediation?

Mediation is a proven method of problem solving. Other labour relations jurisdictions in Canada that use grievance mediation quote very high success rates. Grievance arbitration, while resulting in a binding outcome, is costly, often involving long delays for hearings and the issuing of awards. Grievance mediation is not a replacement for arbitration but an early intervention opportunity that is cost effective, timely and informal. The parties are always in control of the outcome.





Wage Settlements in Alberta Weighted Average % Annual Change by Industry






