WHEREAS on February 26, 2021, the Director signed, and on March 1, 2021, CP was served with an Environmental Protection Order (EPO-EPEA-35819) [the "Order"] setting out requirements to respond to the release of the Substance into the environment;

WHEREAS on March 5, 2021, the Director issued Amendment No. 1 to the Order, requiring the implementation of the Wildlife Plan;

WHEREAS on March 9, 2021, the Director issued Amendment No. 2 to the Order, requiring the implementation of the Railcar Recovery Plan;

WHEREAS on March 11, 2021, the Director issued Amendment No.3 to the Order, requiring the implementation of Potash Recovery Plan;

WHEREAS Clause 13 of the Order required CP, by not later than March 5, 2021, to submit to the Director, for the Directors written approval a written monitoring and sampling plan stamped and signed by both;

- a. an independent third party qualified professional registered and in good standing with the Association of Professional Engineers, Geoscientists of Alberta (APEGA) and;
- b. an independent third party qualified professional currently registered in good standing with the Alberta Society of Professional Biologists (ASPB);

WHEREAS on March 5, 2021, CP submitted to AEP, a document titled "Monitoring and Sampling Plan - Potash Derailment Mile 99, Crowsnest Subdivision Hazell, Alberta – Version – 03.05.2021.1700" which was stamped and signed by both;

- a. an independent third party qualified professional registered and in good standing with the Association of Professional Engineers, Geoscientists of Alberta (APEGA) and;
- b. an independent third party qualified professional currently registered in good standing with the Alberta Society of Professional Biologists (ASPB);

WHEREAS the document titled "Monitoring and Sampling Plan - Potash Derailment Mile 99, Crowsnest Subdivision Hazell, Alberta – Version – 03.05.2021.1700" was reviewed by an AEP Limnologist and Senior Fisheries Biologist who identified concerns including, but not limited to;

- a. Lack of detail regarding the frequency of collection for field blanks during sampling;
- b. Lack of sampling parameters included in the document, specifically metals;

WHEREAS on March 26, 2021, in order to address the concerns regarding the March 5, 2021 "Monitoring and Sampling Plan - Potash Derailment Mile 99, Crowsnest Subdivision Hazell, Alberta – Version – 03.05.2021.1700", CP submitted to AEP, a document titled "Monitoring and Sampling Plan - Potash Derailment Mile 99, Crowsnest Subdivision Hazell, Alberta – Version – 03.26.2021.1700" which was stamped and signed by both;

- a. an independent third party qualified professional registered and in good standing with the Association of Professional Engineers, Geoscientists of Alberta (APEGA) and;
- b. an independent third party qualified professional currently registered in good standing with the Alberta Society of Professional Biologists (ASPB);

WHEREAS the March 26, 2021 "Monitoring and Sampling Plan - Potash Derailment Mile 99, Crowsnest Subdivision Hazell, Alberta – Version – 03.26.2021.1700" rectified the deficiencies identified in the March 5, 2021 plan, and solely forms the Monitoring and Sampling Plan as contemplated by the Order;

WHEREAS The Director accepts and approves the March 29th, 2021 Monitoring and Sampling Plan submitted by CP;

WHEREAS section 243 of the *Environmental Protection and Enhancement Act* [the "Act"] provides authority for the Director to amend an environmental protection order;

THEREFORE I, Coreen Bates, pursuant to section 243 of the Act DO HEREBY AMEND the Order as follows:

- 1. Delete Clause 2 of the Order;
- 2. Adding Clause 22 as follows:

22. CP shall, by March 31, 2021, fully implement each of the actions set out in the Monitoring and Sampling Plan.
