CIRCUMSTANCES UNDER WHICH DEATH OCCURRED

Derrick John MacKinnon, a 34 year old male, was picked up by the Calgary Police Service outside a residence in the Bowness area of Calgary at 7:00 a.m. on January 1, 1998. He appeared cold and apparently had been locked out. He was thought to be intoxicated and taken to the Arrest Processing Unit where he was booked into custody as a drunk. At 0800 he was placed in restraining chair cell number 15 with an altered level of consciousness perceived to be due to alcohol and drugs. His glucose level was measured. Mr. MacKinnon was noted to be jaundiced. He was sent to Foothills Hospital with a paramedic at 1435 hours. At Foothills Hospital Mr. MacKinnon was diagnosed as being in severe liver failure and died in the early morning hours of January 3rd, 1998.

An external examination was performed, and a biopsy done of the liver. The liver microscopy showed massive zonal necrosis consistent with acetaminophen toxicity. Mr. MacKinnon had a former history of hepatitis B, and patients who are known to have liver damage tend to be very sensitive to acetaminophen toxicity, a poison which damages the liver and causes death.
