WHEREAS Enforcement Order NO. WA-EO-2018/07-LAR [the "EO"] was issued to the Parties on July 3, 4, and 5, 2018;

WHEREAS Amendment No. 1 to the EO was issued to the Parties on August 16, 2018;

WHEREAS Amendment No. 2 to the EO was issued to the Parties on November 22, 2018;

WHEREAS Amendment No. 3 to the EO was issued to the Parties on April 2, 2019;

WHEREAS Amendment No. 4 to the EO was issued to the Parties on September 11, 2019;

WHEREAS on December 2, 2019, the consultant for the Parties [the "consultant"] advised Alberta Environment and Parks ["AEP"] that the remedial work was progressing but will not be completed by the January 15, 2020 deadline due to the necessity to consider post-freshet water level into the remediation plan;



WHEREAS I, Simon Tatlow, Compliance Manager, Lower Athabasca Region [the "Director"] has been designated as Director for the purposes of issuing and amending enforcement orders under the *Water Act*;

WHEREAS the Director is of the opinion that the EO must be amended to reflect the approved deadlines within the Remedial Plan;

THEREFORE, I, Simon Tatlow, Director, pursuant to sections 137(1)(a) of the *Water Act*, DO HEREBY AMEND the EO, and ORDER:

1. In Clause 1 of Amendment No. 4 to the EO, "**January 15, 2020**" is deleted and replaced with "**June 1, 2020**";
2. In Clause 2 of Amendment No. 4 to the EO, "**February 12, 2020**" is deleted and replaced with "**July 6, 2020**"

Take notice that this enforcement order is a remedial tool only, and in no way precludes any enforcement proceedings being taken regarding this matter under this Act or any other legislation. Failure to comply with this order may result in further enforcement proceedings. Section 115 of the *Water Act* may provide a right of appeal against this decision to the Alberta Environmental Appeals Board. There may be a strict time limit for filing such an appeal.
