WHEREAS Enforcement Order No. WA-EO-2018/07-LAR [the "EO"] was issued to the Parties on July 3, 4 and 5, 2018;

WHEREAS Amendment No. 1 to the EO was issued to the Parties on August 16, 2018;

WHEREAS the consultant for the Parties [the "consultant"] advised a longer timeframe would be necessary to provide Alberta Environment and Parks ["AEP"] with a written remedial plan ["Remedial Plan"] to the AEP specifications as required in item 3 of the EO.

WHEREAS the consultant emailed the Director on November 20, 2018 requesting an extension to the end of January 2019 to provide AEP with the Remedial Plan;

WHEREAS Environmental Protection Officer [the "EPO"], Jocelyn Beniuk-Elkins, emailed the consultant on November 22, 2018, on behalf of the Director, confirming the request and an extension to January 31, 2019 for the Remedial Plan to be applied to the EO and the other dates remain unchanged;

WHEREAS I, Simon Tatlow, Compliance Manager, Lower Athabasca Region [the "Director"] has been designated as Director for the purposes of issuing and amending enforcement orders under the Water Act;

WHEREAS the Director is of the opinion that the EO must be amended to reflect the new deadlines;

THEREFORE, I, Simon Tatlow, Director, pursuant to sections 137(1)(a) of the *Water Act*, DO HEREBY AMEND the EO, and ORDER:

1. In Clause 1 of Amendment 1 to the EO, "**November 21, 2018**" is deleted and replaced with "**January 31, 2019**".
