NOTICE OF APPLICATIONS

In accordance with the Environmental Protection and Enhancement Act, Maxim Power Corp. has submitted an environmental impact assessment report to Alberta Environment.

In accordance with the Environmental Protection and Enhancement Act, Maxim Power Corp. has applied to Alberta Environment for an amendment to an existing approval for the expansion of the existing H. R. Milner coal fired power generating unit to include a 500 MW coal fired power generating unit and ancillary facilities.

The land locations of the expansion include:

- Plan 3618 RS, Portion of the N ½ Section 10 and S ½ Section 15 of Township 58 Range 8 W6M
- Plan 8622136 in 5 ½ Section 15 Township 58 Range 8 W6M
- Plan 2567TR in SW ¼ Section 14 and SE ¼ Section 15 Township 58 range 8 W6M

In accordance with the Water Act, Maxim Power Corp. has applied to Alberta Environment to construct a temporary storage area (by removing/distributing ground, vegetation or a wetland within the Smoky River flood plain) and to construct a new water intake. An approval will be issued as per Section 36 of the Water Act for this work. Pursuant to Section 54 of the Water Act an amendment to their current water-licence (Licence No. 6496) will be undertaken to update conditions and plans for the new water intake. The work is on the NE of Section 10 Township 58 Range 8 W6M.

Pursuant to section 73 of the Environment Protection and Enhancement Act and section 109 of the Water Act, any person who is directly affected by these operations may submit a written statement of concern regarding these applications. Failure to file a statement of concern may affect the right to file a Notice of Appeal with the Environmental Appeals Board. Such a statement of concern must be submitted to:
