Message from the Minister



It is my pleasure to present the Ministry's annual report, which highlights the department's excellent work and accomplishments in 2010-2011.

Over the past year, International and Intergovernmental Relations (IIR) took a lead role promoting Alberta's interests within Canada and across the globe. Guided by our new international strategy, IIR reinforced to key stakeholders and political leaders that Alberta is a safe, secure and responsible provider of energy and a great place to live, work and invest.

With greater national and international spotlight on Alberta's energy resources, the Ministry expanded our ongoing advocacy work across Europe and the U.S. This included outreach in the United Kingdom and Brussels as well as continued participation in U.S. forums such as the Western Governors' Association and the Council of State Governments. In 2010, Alberta was pleased to host the very successful Pacific Northwest Economic Region annual meeting in Calgary.

Our Ministry understands the importance of taking Alberta's story to the world and also welcoming the world to Alberta. Last year IIR welcomed more than 40 visiting delegations from across the globe and coordinated 21 international missions that focused on trade and investment in key markets including China, India and the Middle East.

Market diversification is a priority for Alberta and was supported by the introduction of Bill 1, the *Asia Advisory Council Act*, which focuses new energy and expertise on the growing economies of Asia by forming a provincial council of trade and business experts. We also continued working diligently on the Canada-European Union Comprehensive Economic and Trade Agreement negotiations, ensuring Alberta's voice is heard at the negotiation table.

One of our biggest achievements within Confederation was the signing of the groundbreaking New West Partnership (NWP) with British Columbia and Saskatchewan at a Joint Cabinet Meeting in April 2010. The NWP creates Canada's largest interprovincial free trade zone and creates a platform for the provinces to work together on innovation, procurement and international cooperation. The agreement is already proving successful with the provinces opening a joint trade and investment office in Shanghai, China.

The Ministry played a key role in protecting Alberta's interests domestically, including challenging and winning Ontario's trade restrictions that prohibited certain Alberta manufactured dairy products from being sold in that province. IIR also worked with other government departments to support Alberta's reference case, challenging the federal government's push for a national securities regulator.

The Ministry also helped coordinate Alberta's participation in the Western Premiers' Conference and the Council of the Federation meeting.

As we move forward, I am confident that IIR will continue to play a key role on behalf of all Albertans, helping to ensure the province remains a leader within Canada and around the globe.

Management's Responsibility for Reporting

- Understandability and Comparability – Current results are presented clearly in accordance with the stated methodology and are comparable with previous results.
- Completeness – Performance measures and targets match those included in Budget 2010.

As Deputy Minister, in addition to program responsibilities, I am responsible for the Ministry's financial administration and reporting functions. The Ministry maintains systems of financial management and internal control which give consideration to costs, benefits, and risks that are designed to:

- provide reasonable assurance that transactions are properly authorized, executed in accordance with prescribed legislation and regulations, and properly recorded so as to maintain accountability of public money;
- provide information to manage and report on performance;
- safeguard the assets and properties of the Province under Ministry administration;
- provide Executive Council, the President of Treasury Board, the Minister of Finance and Enterprise and the Minister of International and Intergovernmental Relations information needed to fulfill their responsibilities; and
- facilitate preparation of Ministry business plans and annual reports required under the *Government Accountability Act*.

In fulfilling my responsibilities for the Ministry, I have relied, as necessary, on the executives within the Ministry.

Ministry Overview

Vision

A strong and prosperous Alberta showing leadership within Canada and throughout the world.

Mission

Advance Alberta's interests by leading government-wide strategies that capitalize on Alberta's regional, national, and global relationships and opportunities.

International Relations

The Ministry works with other Alberta ministries to advance and develop Alberta's strategic international interests and relationships and to facilitate trade promotion and investment attraction in targeted international markets. The Ministry is responsible for advocating Alberta's interests within Canadian foreign policy, building and maintaining key alliances, and identifying strategic growth opportunities for Alberta industry through international partnerships.

The Ministry also manages Alberta's 10 international offices located in Beijing, Hong Kong, Shanghai, Taipei, Tokyo, Seoul, Mexico City, Munich, London, and Washington, D.C. The international offices are responsible for trade promotion, investment attraction, environmental and energy advocacy, and other international relations interests in their respective geographic regions. While all offices are responsible for these activities, each office's mandate has been tailored to meet the opportunities and Alberta's priorities within the region. For example, the Alberta Washington Office focuses on advancing Alberta's policy interests in the U.S., and the Alberta United Kingdom Office has seen its mandate expand to include an increased focus on advocacy, while the other international offices have more of a trade and investment focus. Intergovernmental Relations

The Ministry works with other Alberta ministries to ensure a coordinated provincial approach to intergovernmental relations, representing Alberta's interests in the Canadian federation. Areas of responsibility include:

- Advancing Alberta's interests at meetings of First Ministers, the Council of the Federation, Western Premiers, and the Alberta, Saskatchewan, and British Columbia Cabinets; and
- Coordinating Alberta's overall international and domestic trade policy; fiscal, social, economic and resource policies; and other interprovincial and federal-provincial issues, including national unity.

Discussion and Analysis of Results

Goal One: Albertans compete successfully in Canada and globally

2010-11 remained a year of economic recovery for Alberta. To aid in this recovery, IIR worked on behalf of Albertans to enhance Alberta's national and international presence in areas such as trade promotion, investment attraction and intergovernmental relations. The Ministry focused on increasing opportunities for Albertans through the negotiation, implementation and management of trade agreements that promote the free flow of goods, services, people, and investment within Canada and internationally. IIR also worked with other Alberta ministries to increase exports and attract investment, and to coordinate international missions that promoted opportunities available in Alberta.

Specific accomplishments in 2010-11 included:

- 1) Negotiated the New West Partnership Agreement (NWP)
- 2) Launched the Shanghai-based Western Canada Trade and Investment Office
- 3) Challenged Ontario's trade restrictions of Alberta dairy-edible oil blend products
- 4) Participated in the Canada-EU trade negotiations
- 5) Organized Premier, Minister and other missions
- 6) Organized events and missions to promote trade and attract investment

1) Negotiated the New West Partnership Agreement (NWP)

IIR successfully negotiated the expansion of the groundbreaking Alberta-British Columbia Trade, Investment and Labour Mobility Agreement (TILMA) to include Saskatchewan. The New West Partnership Agreement (NWP) came into force July 1, 2010. The NWP will extend the benefits of labour mobility, business registration, investment and regulatory harmonization across the three most western provinces. The NWP will establish these provinces as an internationally important economic bloc, improving the competitiveness of western businesses and achieving more effective and efficient service delivery to residents of Western Canada. Cabinet members from all three provinces met in Regina on April 30, 2010 to finalize the NWP. The NWP contains four specific schedules:

- The NWP Trade Agreement (which expands the free trade zone created by TILMA to include Saskatchewan);
- An agreement on cooperative international marketing, including the establishment of a joint international office in Shanghai;
- An agreement to build the capacity for innovation in the three provinces through information sharing and the coordination of innovation activities; and
- An agreement committing the three governments to streamline their procurement practices and explore the opportunities for collaboration on joint procurement initiatives.

As part of the transition from TILMA to NWP, the Ministry developed Bill 18: *Government Organization Amendment Act 2010*. This legislation, which was required for Alberta to fully implement its obligations under the NWP Trade Agreement and to carry over its obligations with British Columbia under the former TILMA, was successfully passed in the Legislative Assembly in November 2010.

Alberta's interests were addressed and reflected in the new trilateral agreement through the cross-ministry coordinating committee on internal trade, chaired by IIR. Work continues between IIR and several Alberta ministries including Transportation, Service Alberta, Finance and Enterprise, Agriculture and Rural Development, Environment and Municipal Affairs to fully implement Alberta's commitments, particularly in the area of regulatory reconciliation across the three provinces. The Agreement will be fully implemented by July 1, 2013.

2) Launched the Shanghai-based Western Canada Trade and Investment Office

On May 16, 2010, the Premiers of Alberta, British Columbia and Saskatchewan launched the Shanghai-based Western Canada Trade and Investment Office, the first joint international office for the three provinces. The office is a collaborative initiative under the NWP that sees the three provinces sharing space and resources to promote their commercial interests in the Shanghai region. The office was opened during the joint Alberta-British Columbia-Saskatchewan Premiers' mission to China and Japan from May 12 to 22, 2010.

3) Challenged Ontario's trade restrictions of Alberta dairy-edible oil blend products

Alberta was successful in its challenge of Ontario's trade restrictions that prohibited the sale – in that province – of dairy-edible oil blend products manufactured in Alberta. The Agreement on Internal Trade (AIT) panel found in Alberta's favour. The panel directed Ontario to repeal the restrictions by February 1, 2011 to allow dairy-edible oil blend products to be sold and compete with dairy products. Ontario complied by the deadline and now Alberta oil-seed producers have unimpeded access to Canada's largest provincial consumer market.

4) Participated in the Canada-European Union (EU) trade negotiations

Alberta was an active participant in the Canada-EU Comprehensive Economic and Trade Agreement (CETA) negotiations. IIR attended negotiating rounds and engaged in discussions with the federal government and other provinces and territories to develop the Canadian negotiating position in areas of provincial jurisdictional responsibility and economic interest. The Ministry coordinated the development of Alberta positions within the Government of Alberta through cross-ministry and sub-sector working groups, represented Alberta in bilateral and federal-provincial-territorial meetings, and participated in negotiating rounds in April, July and October 2010 and January 2011.

5) Organized Premier, Minister and other missions

The Ministry provided leadership and coordination for missions undertaken by the Premier and the Minister, and provided advice to other ministries on their ministerial missions. In 2010-11, Premier Stelmach undertook three missions to promote Alberta as an environmentally responsible, global energy centre offering excellent opportunities for investment and trade. The Minister of IIR undertook nine missions in 2010-11 as part of efforts to advance Alberta's trade, investment and intergovernmental interests internationally.

The Ministry also coordinated Alberta's participation at annual meetings of U.S. bilateral councils and multilateral organizations. During 2010-11, Alberta strengthened its relationship and advocated its economic priorities to the U.S. by participating in these meetings.

Premier's Missions

Mission to Chicago, Illinois and Washington, D.C. – May 2010

The Premier highlighted Alberta's bio-industry competitiveness at the 2010 BIO International Convention, the largest global event for biotech, and took the opportunity to meet with the Governor of Illinois and Alberta's top energy customers. In Washington, D.C., the Premier's program focused on energy and included meetings with a number of high level advisors and decision-makers.

Mission to China and Japan – May 2010

The Premier, along with the Premiers of British Columbia and Saskatchewan, led a joint trade mission to China and Japan to promote trade and investment activities between Western Canada and Asia. This was the first joint mission since the three provinces signed the New West Partnership in April 2010.

Mission to India – November 2010

The Premier undertook a mission to India to bolster trade and investment ties with one of the world's fastest growing economies and spoke at the 9th International Petrotech 2010 Oil and Gas Conference in New Delhi.

Minister's Missions

Mission to Broomfield, Colorado – April 2010

The Minister, along with Len Mitzel, MLA for Cypress-Medicine Hat and Alberta's representative on the Ports-to-Plains Alliance, participated in the 2010 Ports-to-Plains Alliance Energy Summit in Broomfield, Colorado.

Mission to Belgium and the United Kingdom – April 2010

The Minister travelled to Belgium and the United Kingdom for meetings with investors, European politicians, and key senior staff of the European Commission.

Mission to Whitefish, Montana – June 2010

The Minister, on behalf of the Premier, represented Alberta at the 2010 Western Governors' Association (WGA) meeting in Montana.

Mission to Denver, Colorado – July 2010

The Minister addressed oil and gas executives at the 22nd Annual Rocky Mountain Energy Epicenter event in Denver, Colorado.

Mission to Sun Valley, Idaho (September 11-14, 2010) and White Sulphur Springs, West Virginia (September 15-17, 2010)

The Minister, along with Ty Lund, MLA for Rocky Mountain House and Alberta's representative to the Council of State Governments-WEST (CSG-WEST), participated in the 2010 CSG-WEST Annual Meeting in Idaho. They updated key U.S. legislators on how Alberta is moving forward in developing a secure, safe and reliable energy supply. The Minister also represented Alberta at the 50th anniversary meeting of the Southern States Energy Board (SSEB) in West Virginia.

Mission to Korea and Japan – November 2010

The Minister undertook a mission to Korea and Japan to provide government and industry with an update on Alberta's clean energy story. In Korea, the Minister signed an agreement to encourage economic cooperation in the energy sector. Other highlights included participation in the Hokkaido Regional Leaders Forum and the 30th anniversary celebration of the Alberta-Hokkaido twinning relationship in Sapporo, Japan; a speaking engagement at the Meiji University; and a 40th anniversary event for the Alberta-Japan office in Tokyo, Japan.

Mission to Washington, D.C. – December 2010

The Minister participated in transitional meetings in the U.S. capital and took the opportunity to meet with nine U.S. governors-elect and one sitting governor to apprise them of Alberta's continued commitment and capacity to serve as a secure, reliable and environmentally responsible supplier of energy to the U.S.

Mission to Thailand, the Middle East and the United Kingdom – January 2011

The Minister undertook a mission to Thailand (Bangkok), the Middle East (United Arab Emirates, Kuwait and Qatar) and the United Kingdom (London) building on previous trade missions to these regions by the Premier and other Alberta Ministers. The Minister promoted trade and investment opportunities with potential consumers, investors and industry leaders, while showcasing Alberta's leadership on resource development, clean energy technologies and innovation.

Mission to Washington, D.C. – February 2011

Building on the December 2010 mission, the Minister continued to promote Alberta's interests in meetings with governors and Canada's Ambassador to the U.S. in Washington, D.C. The mission coincided with the National Governors' Association Winter Meeting, which the Minister attended on behalf of the Alberta government.

Other Missions

Mission to Washington, D.C. – April 2010

Minister of Aboriginal Relations, Len Webber; Diana McQueen, MLA for Drayton Valley-Calmar and Parliamentary Assistant for Energy; Kyle Fawcett, MLA for Calgary-North Hill; and Richard Marz, MLA for Olds-Didsbury-Three Hills, participated in a number of events and advocacy activities in the U.S. capital region. Each official completed the Legislative Energy Horizon Institute certificate program. The Minister of Aboriginal Relations began the course in his previous role as Parliamentary Assistant in Energy.

Mission to Washington, D.C. – April 2010

Len Mitzel, MLA for Cypress-Medicine Hat and Alberta's representative to the Ports-to-Plains (PTP) Trade Corridor Alliance, promoted Alberta's competitiveness with a focus on energy security, agriculture and transportation at PTP meetings in Washington, D.C. that included meetings with Members of Congress from the PTP region.

Mission to Calgary, Alberta – July 2010

The Pacific Northwest Economic Region (PNWER) 20th Annual Summit, held in Calgary, Alberta, provided an opportunity for legislators, business leaders and policy experts to explore key issues such as energy, environment and related topics of climate change, agriculture and trade. Both the Premier and Minister of IIR were featured speakers at the event, which culminated in an oil sands site visit for U.S. state officials with energy responsibilities.

Mission to Rapid City, South Dakota – September 2010

Len Mitzel, MLA for Cypress-Medicine Hat and Alberta's representative to the Ports-to-Plains Trade Corridor Alliance (PTP), participated in the 2010 PTP annual meeting in Rapid City, South Dakota and spoke about agricultural transportation.

Mission to Washington, D.C. – September 2010

Len Mitzel, MLA for Cypress-Medicine Hat, represented Alberta at the Canadian/American Border Trade Alliance (Can/Am BTA) meeting in Washington, D.C., reinforcing Alberta-U.S. ties and promoting effective and efficient border management.

Mission to Stevenson, Washington – November 2010

Minister of Alberta Sustainable Resource Development, Mel Knight; George Groeneveld, MLA for Highwood and chair of the Alberta Delegate Council to PNWER; and Alana DeLong, MLA for Calgary-Bow, represented Alberta at the PNWER Economic Leadership Forum in Stevenson, Washington.

Mission to Barrow, Alaska – December 2010

Ray Prins, MLA for Lacombe-Ponoka and co-chair for the Petrochemical/Chemical Task Team of the Alberta Competitiveness Council, represented Alberta at the PNWER Arctic Caucus Leadership Forum in Barrow, Alaska.

Mission to Olympia, Washington – January 2011

Minister of Alberta Sustainable Resource Development, Mel Knight — who assumed the PNWER presidency in July 2010 — and George Groeneveld, MLA for Highwood and chair of the Alberta Delegate Council to PNWER, represented Alberta at PNWER meetings with Washington state legislators and senior administration officials.

Mission to Salem, Oregon – February 2011

George Groeneveld, MLA for Highwood and chair of the Alberta Delegate Council to PNWER, participated in a series of PNWER meetings with Oregon state legislators focused on trade, transportation and energy issues.

6) Organized events and missions to promote trade and attract investment

The Ministry collaborated with partners to organize and deliver several events and missions to promote trade and attract investment. These events assisted Alberta businesses to develop relationships with potential investors, partners and customers. Efforts were also made to promote Alberta to targeted companies within priority sectors and to capital investors as an attractive destination for foreign direct investment.

Key results for 2010-11 included:

Alberta Economic Developers Association 2010 AGM and Conference, Kananaskis, Alberta – April 2010

Established new relationships and networks with Alberta economic development and business partners and identified economic development priorities, opportunities and intelligence from rural communities.

International ICT Expo, Hong Kong, China – April 2010

Led nine Alberta companies to participate in this event. Alberta Information and Communications Technology (ICT) expertise was showcased through product and service demonstrations, business forums and matchmaking events.

Alberta Green Building Technologies Symposium, Edmonton and Calgary, Alberta – May 2010

Organized participation in this symposium, which targeted innovations and advanced technologies related to the sustainable green building products sector.

Offshore Technology Conference, Houston, Texas – May 2010

Led over 40 companies to participate in the Alberta pavilion at the largest oil and gas exhibition and conference in the world, attracting top level oil and gas executives from all of Alberta's priority international markets.

The World Congress on Industrial Biotechnology and Bioprocessing, Washington, D.C. – June 2010

Assisted in the development of a plenary session that positioned Alberta as a logical and highly attractive investment destination at the world's leading industrial biotechnology event. This event serves as a forum for business leaders, investors and policy makers in bio-fuels, bio-based products and renewable chemicals. Participation provided a networking opportunity with venture capital investors, American bio-fuel companies and other industry representatives.

Global Petroleum Show, Calgary, Alberta – June 2010

Organized the Alberta International House with participation from 10 international partners and eight Alberta industry associations at the largest on-shore oil and gas exhibition and conference.

Computex, Taipei, Taiwan – June 2010

Led four Alberta companies to participate in the largest computer trade exhibit in Asia. Alberta ICT expertise was showcased through panel displays and product and service demonstrations. One-on-one matchmaking events were arranged for Alberta participants with Taiwan industry.

Farnborough International Air Show, Farnborough, United Kingdom – July 2010

Ten aerospace and defence organizations were represented and featured under the Canada West Aerospace and Defence Industries Association exhibit in the Canadian Pavilion at one of the world's largest international air shows. Organizations benefited from networking events, company/market intelligence reports, industry briefings and presentation opportunities.

Gamescom, Cologne, Germany – August 2010

Led nine Alberta companies to participate in the world's largest trade fair for interactive games and entertainment. Participation was jointly organized with British Columbia, Ontario, Quebec and the Department of Foreign Affairs and International Trade (DFAIT).

Association for Unmanned Vehicle Systems International, Denver, Colorado – August 2010

Led over 30 Alberta companies and organizations to the world's largest symposium and exposition on unmanned vehicle systems. Organizations benefited from participating in an Alberta showcase, industry matchmaking and networking events plus industry meetings, company introductions and presentations.

Mexico Expetro Oil and Gas Show, Mexico City, Mexico – August 2010

Led eight Alberta companies (most of which are engaged in enhanced oil recovery technologies), in collaboration with Export Development Canada and DFAIT to this event to participate in the Alberta Pavilion and one-on-one meetings.

IFAT International Trade Fair for Water, Sewage, Refuse and Recycling, Munich, Germany – September 2010

Led 10 Alberta companies to one of the world's largest environment sector event. Alberta companies showcased their products, held a number of one-on-one meetings with top level representatives from the world's leading companies and participated in Canadian matchmaking events.

China International Heavy Oil Symposium, Liaohe, China – September 2010

Led 10 Alberta companies to participate in this conference and showcase Alberta technical expertise in heavy oil production and processing. IIR facilitated onsite meetings and coordinated business exchanges.

Rio Oil and Gas Expo and Conference 2010, Rio de Janeiro, Brazil – September 2010

Organized an Alberta/Canada oil and gas presence at the leading oil and gas industry event in Latin America. In collaboration with the Consulate General of Canada in Rio, Export Development Canada and Industry Canada, Alberta companies showcased their products and services in the Canada Pavilion and networked with Brazil's oil and gas industry.

Aviation Alberta Conference and Trade Show, Kananaskis, Alberta – October 2010

Presented the Alberta Aerospace and Defense Strategy and acquired market intelligence on new developments and future procurement programs from the commercial aerospace and defence sector, including major Crown projects that could create industrial regional benefit prospects for Alberta. Participation provided opportunities to establish new relationships and maintain existing contacts with major Canadian, U.S. and U.K. companies, key government and defence officials.

Colombia Oil and Gas Show, Cartagena and Bogota, Colombia – November 2010

Led 12 Alberta service and equipment companies to participate in the Alberta Pavilion and one-on-one meetings.

Petrotech Exhibition and Conference 2010, New Delhi, India – November 2010

The Premier led a 22-company Alberta delegation to the largest oil and gas event in Southeast Asia, with senior oil and gas executives from around the world participating. Fourteen of the Alberta companies participated in the Alberta Pavilion.

Abu Dhabi International Petroleum Exhibition and Conference, Abu Dhabi, UAE – November 2010

Thirty-two Alberta companies participated in the exhibition showcasing a wide variety of products and services at the largest oil and gas event in the Middle East.

Medica, Dusseldorf, Germany – November 2010

Led eight Alberta health technology and medical device companies to participate in the world's largest event for the health sector. Alberta companies exhibited their products within the Canada Pavilion or jointly with partners and participated in the Canadian and other matchmaking and networking events.

Greenbuild, Chicago, Illinois – November 2010

Led 35 Alberta companies and organizations in collaboration with the Canada Green Building Council-Alberta Chapter and the Canadian Consulate in Chicago to participate in the Alberta Associate Exhibitor program at the world's largest business development event in the sustainable building industry. In addition to the Alberta showcase, participants had an opportunity to acquire market intelligence, benefit from business introductions, and attend a Canadian business matchmaking event.

Unmanned Systems Canada, Montreal, Quebec – November 2010

Supported a delegation of Alberta companies/organizations attending this international conference to discuss unmanned vehicle system technologies, research and development, military/commercial applications, standards and regulations. Participants had an opportunity to acquire market intelligence and benefit from business introductions.

Hong Kong International Medical Devices and Supplies Fair, Hong Kong and Mediphar, Taipei – November 2010

Led six Alberta companies and industry association to participate in this event. Alberta life sciences expertise was showcased through panel displays, product and service demonstrations, business seminars and matchmaking events.

Pollutec, Lyon, France – November - December 2010

Four Alberta companies participated in this exhibition showcasing a wide variety of products and services at one of the largest environmental technology events in Europe.

International Builders Show, Orlando, Florida – January 2011

Led 50 Alberta organizations to explore new U.S. export opportunities in collaboration with the Canada Green Building Council-Alberta Chapter and the Canadian Consulate in Miami. Alberta companies participated in the Alberta Associate Exhibitor program and benefited from a building products display in the Canada Pavilion, business introductions, one-on-one meetings, media interviews, market intelligence briefings, and a Canada business networking event headlined by the Canadian Minister of International Trade.

Mobile World Congress, Barcelona, Spain – February 2011

Led a delegation of eight Alberta companies with 17 representatives to the world's largest event for the wireless sector. Alberta companies showcased their products, held a number of one-on-one meetings with top level representatives from the world's leading companies and participated in Canadian matchmaking events. Participation was organized in partnership with Ontario and DFAIT.

Australasian Oil and Gas Exhibition and Conference, Perth, Australia – February 2011

Led 12 Alberta companies to the largest annual exhibition of its kind in Australasia to meet service providers, engineers, technical professionals and suppliers.

CeBIT, Hanover, Germany – March 2011

Led a delegation of seven Alberta representatives to the world's foremost trade show for digital industry. Participation in CeBIT enabled Alberta companies to promote their products and identify potential business partners. Participation was organized in partnership with British Columbia and Ontario.

Ecobuild, London, England – March 2011

Led six Alberta organizations to participate in an Alberta booth under the Canadian Pavilion at the largest green building event in Europe. Networking events, advertising and presentation/site visit opportunities supported Alberta's efforts to showcase Alberta as a supplier source and investment destination.

China International Petroleum and Petrochemical Technology and Equipment Exhibition (CIPPE), Beijing, China – March 2011

Led 10 Alberta companies and organizations to participate in the Canada Pavilion at CIPPE, the largest petroleum show in Asia and one of the world's top three petroleum exhibitions, showcasing the latest oil and gas technology, products and equipment.

Goal Two: Alberta is a leader in building key relationships

Building and fostering key strategic and economic relationships is critical for the long-term success of Alberta. IIR continued to develop cooperative, collaborative approaches on issues of mutual importance with its partners and clients within Canada and internationally to address challenges and to grow opportunities. For example, the Ministry led the signing of the New West Partnership to further opportunities with Western Canadian trading partners.

Other activities the Ministry undertook in 2010-11 to build key relationships included:

- 1) Introduced Bill 1, *Asia Advisory Council Act*
- 2) Demonstrated that Alberta is a secure, reliable and responsible energy provider
- 3) Coordinated incoming visits
- 4) Supported twinning relationships
- 5) Built industry and government partnerships

1) Introduced Bill 1, *Asia Advisory Council Act*

Bill 1, the *Asia Advisory Council Act*, was introduced in the Legislative Assembly of Alberta by the Premier on February 22, 2011, the first day of spring session. Under the terms of the Bill, the government will establish a 10-person Council of experts, which will advise and make recommendations on how to increase trade and improve transportation and infrastructure linkages to Asia.

Members will represent a cross-section of organizations and interests, including business, cultural and academic communities and will have a keen understanding of Alberta priorities, as well as insights and expertise in Asia. The council will help inform and advise on strategic priorities and how to best tap into the tremendous opportunities available throughout the region.

2) Demonstrated that Alberta is a secure, reliable and responsible energy provider

Working with the ministries of Energy and Environment, IIR planned and led an oil sands mission to southern Ontario in September 2010. Ministers participated in a clean technology forum, media opportunities and local community events in several cities throughout southern Ontario. Participants included three Ministers, several senior industry representatives and government officials. The mission provided a valuable opportunity to clear up misconceptions surrounding oil sands development and speak directly to important decision-makers in Ontario.

In addition to the mission to Ontario, the Ministry continued to build international understanding of Alberta as a secure, reliable and responsible developer and supplier of energy. Briefings on Alberta's energy and environment policies and strategies featured prominently in presentations developed for outgoing missions and incoming VIP delegations of diplomats, elected officials, government and agency administrators, and representatives of non-governmental organizations from various countries. Key initiatives in 2010-11 included:

- September 2010: Oil sands briefing and tour by White House officials responsible for energy and environment issues;
- September 2010: U.S. Senators Graham, Hagan and Chambliss visit to Alberta for oil sands briefing and tour;
- September 2010: Premier's meeting with U.S. House of Representatives Speaker, Nancy Pelosi in Ottawa;
- October 2010: Briefing sessions and oil sands site tours by German Federal and State Parliamentarians;
- October 2010: Oil sands briefing and tour by David Goldwyn, Special Envoy and Coordinator for International Energy Affairs, U.S. State Department; and
- November 2010: Briefing sessions and oil sands site tours by Members of the European Parliament.

3) Coordinated incoming visits

IIR worked with other Alberta ministries to coordinate numerous incoming visits by diplomats, elected representatives and officials from various regions to showcase Alberta's strengths. The Ministry developed and coordinated 44 programs for incoming international visitors to Alberta, including the following notable visits:

- June 2010: His Excellency Dr. Mohammed Bin Saleh Al-Sada, Minister of Energy and Industry Affairs, State of Qatar;
- June 2010: The Honorable Jitin Prasada, Minister of State for Petroleum and Natural Gas, Government of India, Republic of India;
- September 2010: U.S. Senators Graham, Hagan and Chambliss;
- September 2010: White House Officials;
- September 2010: Ms. Yongfeng Liu, Consul General of the People's Republic of China;
- October 2010: German Federal and State Parliamentarians;
- November 2010: Members of the European Parliament; and
- December 2010: His Excellency Kaoru Ishikawa, Ambassador of Japan to Canada.

4) Supported twinning relationships

The Ministry worked with other Alberta ministries and stakeholders to provide leadership and coordination on several of Alberta's twinning relationships with the aim of enhancing government-to-government relations.

During the year, the Ministry hosted several delegations from Alberta's sister provinces/states/prefectures which provided opportunities to share experiences with one another on a range of topics:

- June 2010: Delegation led by Governor Mykhaylo Vyshyvanyuk of Ivano-Frankivsk Oblast, Ukraine;
- July 2010: Delegation led by Vice Governor Osamu Takai from the prefecture of Hokkaido, Japan to celebrate the 30th anniversary of the sister province relationship; and
- October 2010: Governor Dmitry Kobylkin of Yamal-Nenets Autonomous Okrug, Russia.

5) Built industry government partnerships

The Ministry partnered with the Canadian government, other provincial governments, foreign government agencies, international financial institutions, and industry associations to assist Alberta companies in building trade relations and to attract investment to Alberta. Key results for the year included:

- June 2010: Asian Clean Energy Forum, Manila, Philippines – IIR worked with Saskatchewan Trade and Export Partnership (STEP) and the Embassy of Canada in the Philippines to organize a mission of 10 participants to the forum which included a showcase of renewable energy projects that included an example from Alberta.
- October 2010: The Korea Canada Energy Forum, Calgary, Alberta – IIR provided assistance in organizing this forum jointly with the Korean Embassy based in Ottawa, to promote investment, trade, and research and development collaboration between Korea and Alberta in the energy sectors. The event also enhanced mutual understanding of the energy industries and regulatory frameworks.
- October 2010: Private Sector Liaison Officer Energy Mission, Washington, D.C. and New York – IIR worked with the Greater Houston Partnership, Midwest Global Alliance and the Milan Chamber of Commerce to organize a multi-country mission to the World Bank, United Nations and other international financial institutions. Ninety-one participants attended from 13 countries with the largest delegation from Canada and, in particular, Alberta.
- February 2011: Multi-Sectoral Mission to the World Bank and Inter-American Development Bank, Washington, D.C. – IIR worked with Saskatchewan Trade and Export Partnership (STEP), Business Nova Scotia and the Embassy of Canada to organize a multi-sectoral mission in the environmental, agricultural and education sector. Ten of the total 41 participants in the mission were from Alberta.

- March 2011: The Sino-Canada Energy Cooperation Workshop, Beijing, China – IIR organized the 2nd annual Sino-Canada Energy Cooperation Workshop, along with the China National Petroleum Corporation (CNPC)-Alberta Petroleum Centre, which provided an opportunity for senior energy executives from both China and Canada to exchange information and explore commercial opportunities.
- March 2011: The World Heavy Oil Congress, Edmonton, Alberta – IIR coordinated the Alberta government presence at the Congress, the premier forum for business and technical leadership for the development of heavy oil around the world. In collaboration with several other ministries, IIR developed a value-added program for international delegates in an effort to enhance trade and investment attraction initiatives. A VIP networking reception brought together international decision-makers with Alberta companies looking to export products and services.
- March 2011: The Inter-American Development Bank (IDB) and Inter-American Investment Corporation (IIC) Annual Meetings, Calgary, Alberta – IIR worked with federal, provincial and municipal partners to strategize, plan and stage the IDB and IIC annual meetings. These meetings are a main forum for discussion of political, economic and social development in Latin America and the Caribbean. This was the first time since 1990 that a Canadian city hosted this prestigious international financial forum.

Goal Three: Alberta's interests are coordinated and advanced

Alberta takes pride in its ability to effectively promote its interests and priorities nationally and internationally. IIR continued to lead the coordination of Alberta's policies and activities as they relate to other governments within Canada and internationally. The Ministry provided leadership and advice to other ministries and reviewed intergovernmental agreements between Alberta government departments and other provinces, the federal government and agencies, and ministries in foreign countries. IIR also coordinated Alberta's participation within the Canadian Federation.

Specific accomplishments in 2010-11 to advance and coordinate Alberta's interests included:

- 1) Released Alberta's International Strategy
- 2) Provided recommendations and advice to Alberta's Constitutional Reference
- 3) Coordinated Alberta's participation at the Council of the Federation
- 4) Coordinated Alberta's participation at the Western Premiers' Conference

1) Released Alberta's International Strategy

Alberta's International Strategy: Global Advocacy for Alberta was tabled in the Legislature by the Minister on November 16, 2010. Alberta's International Strategy is focused on three strategies:

- Harness international efforts of stakeholders and partners through collaboration;
- Expand Alberta's reach into growing international markets; and
- Strengthen Alberta's international profile.

2) Provided recommendations and advice to Alberta's Constitutional Reference

The Government of Canada proposed new legislation that would regulate the securities industry in Canada by establishing a national securities regulator. The Government of Alberta challenged the constitutional jurisdiction in *Her Majesty the Queen in Right of Alberta v. Her Majesty the Queen in Right of Canada*. IIR participated in the cross-ministry team to provide recommendations and direction to the legal challenge. The Alberta Court of Appeal issued an opinion on March 8, 2011, that declared the federally proposed securities legislation would enter an area of regulation within provincial jurisdiction and fully supported the legal arguments advanced by the Alberta government. The ruling in this case emphasized the importance of the division of power in Canadian federalism. IIR played an integral role in ensuring Alberta's interests were protected and federal intrusion was minimized.

3) Coordinated Alberta's participation at the Council of the Federation

The Premiers of the Council of the Federation met in Winnipeg, August 4-6, 2010. IIR worked to advance agenda items of interest to Alberta and coordinated strategic briefings for the Premier. This included providing briefings to the Premier and support as required. Outcomes from this meeting of particular interest included:

- Premiers agreed that provinces and territories need to have a greater role in decisions regarding immigration policy and planning, including the selection and settlement of immigrants. Premiers also expressed concern over federal efforts to cap the successful provincial nominee programs;
- Premiers directed Finance Ministers, in collaboration with Health Ministers, to develop a critical path for the review of fiscal transfers in 2014, including the Canada Health Transfer; and
- Premiers agreed to develop a framework for provincial-territorial involvement in international treaties in areas of provincial jurisdiction for discussion with the federal government.

4) Coordinated Alberta's participation at the Western Premiers' Conference

Western Premiers met in Vancouver, June 15-16, 2010. The agenda was built around the themes of energy, environment and the economy. IIR worked to advance agenda items of interest to Alberta, coordinated strategic briefing materials, verbally briefed the Premier and confirmed strategic objectives prior to the meeting. Outcomes of the meeting included:

- A declaration by Premiers on the importance of open skies to Western Canada that will provide opportunities for better air services, increased flight options, greater efficiencies for airlines, increased competition and reduced prices for consumers;
- Strong communications on the West as a global energy powerhouse that reinforce Alberta's ongoing advocacy efforts that demonstrate the province is a secure, reliable and responsible energy provider;
- A strong statement on the importance of bringing energy to market – whether by pipeline, rail, through transmission lines and a western power grid – as an important aspect of seizing economic development opportunities; and
- A statement on the importance of provincial nominee programs in supporting economic recovery by helping Western economies meet their needs for skilled labour. Premiers urged the federal government to eliminate the cap on the provincial nominee program, and to work with provinces and territories on establishing immigration levels.

The consolidated budgets and financial statements of the Government of Alberta classify government expenses by function. An expense function is defined as a classification that identifies the principal purpose for which an expense is incurred, rather than the activity involved. For budget purposes, expenses are allocated to 12 functions: Health; Education; Social Services; Agriculture, Resource Management and Economic Development; Regional Planning and Development; Protection of Persons and Property; Transportation, Communications and Utilities; Environment; Recreation and Culture; Housing; General Government; and Debt Servicing Costs.

The Ministry's expenses fall under two functions: Agriculture, Resource Management and Economic Development; and General Government. The Agriculture, Resource Management and Economic Development function includes a wide array of Ministry services related to the development and promotion of the Alberta economy, such as trade promotion and investment attraction and the administration of Alberta's international offices. The General Government function includes expenses pertaining to Alberta's formal relations with the federal government, other provinces and foreign governments.

In support of The Way Forward, the Government of Alberta's plan to position the province for a strong economic recovery, IIR undertook measures in 2010-11 to limit expenditures while minimizing the impact on the level of service provided by the Ministry. Table 1 shows actual expenses by function in 2010-11, compared to the 2010-11 budget and to 2009-10 actual expenses for the Ministry. Actual expenses for 2010-11 were \$22.0 million, which resulted in a \$1.9 million surplus in 2010-11. Actual expenses for 2010-11 were \$2.4 million lower than those for 2009-10. The decrease in expenditures was largely due to a reduction in Ministry staffing levels augmented by reductions in legal contracts and grants. In addition, the Ministry explored new partnership arrangements, which supplemented expenditures for Ministry-mandated initiatives and events (e.g., trade shows, industry information sessions) with financial contributions from industry, and created efficiencies by participating in several cross-ministry international projects. The Ministry continued to streamline domestic and international travel by reducing the number of staff traveling to support events/meetings, collaborating with other ministries to limit the size of delegations traveling to events/meetings, and by increasing the use of teleconferencing.

Report on the Financial Statements

I have audited the accompanying financial statements of the Ministry of International and Intergovernmental Relations, which comprise the statement of financial position as at March 31, 2011, and the statements of operations and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 AUTHORITY AND PURPOSE

The Ministry of International and Intergovernmental Relations operates under the authority of the *Government Organization Act*, Chapter G-10, Revised Statutes of Alberta 2000.

The purpose of the Ministry is to advance Alberta's interests by leading government-wide strategies that capitalize on Alberta's regional, national and global relationships and opportunities. The Ministry fulfills this role by focusing on the following three goals:

- Albertans compete successfully in Canada and globally.
- Alberta is a leader in building key relationships.
- Alberta's interests are coordinated and advanced.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND REPORTING PRACTICES

These financial statements are prepared in accordance with Canadian public sector accounting standards.

(a) Reporting Entity

The reporting entity is the Ministry of International and Intergovernmental Relations, for which the Minister of International and Intergovernmental Relations is accountable. The Ministry Annual Report provides a more comprehensive accounting of the financial position and results of the Ministry's operations, for which the Minister is accountable.

All departments of the Government of Alberta operate within the General Revenue Fund (the Fund). The Fund is administered by the Minister of Finance and Enterprise. All cash receipts of departments are deposited into the Fund and all cash disbursements made by departments are paid from the Fund. Net Financing Provided from (for) General Revenues is the difference between all cash receipts and all cash disbursements made.

(b) Basis of Financial Reporting

Revenues

All revenues are reported on the accrual basis of accounting. Cash received for which goods or services have not been provided by year end is recorded as unearned revenue.

Expenses

DIRECTLY INCURRED

Directly incurred expenses are those costs the Ministry has primary responsibility and accountability for, as reflected in the government's budget documents.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND REPORTING PRACTICES
(continued)

Grants are recorded as expenses when authorized and all eligibility criteria have been met.

In addition to program operating expenses such as salaries, supplies, etc., directly incurred expenses also include:

- amortization of tangible capital assets.
- pension costs, which are the cost of employer contributions for current service of employees during the year.
- valuation adjustments, which include changes in the valuation allowances used to reflect financial assets at their net recoverable or other appropriate value. Valuation adjustments also represent the change in management's estimate of future payments arising from obligations relating to vacation pay, guarantees and indemnities.

INCURRED BY OTHERS

Services contributed by other entities in support of the Ministry's operations are disclosed in Schedule 6 and allocated to programs in Schedule 7.

Assets

Financial assets are assets that could be used to discharge existing liabilities or finance future operations and are not for consumption in the normal course of operations. Financial assets of the Ministry are limited to financial claims, such as advances to and receivables from other organizations, employees and other individuals.

Assets acquired by right are not included. Tangible capital assets of the Ministry are recorded at historical cost and amortized on a straight-line basis over the estimated useful lives of the assets. The threshold for capitalizing new systems development is \$250,000 and the threshold for major systems enhancements is \$100,000. The threshold for all other tangible capital assets is \$5,000.

Liabilities

Liabilities are recorded to the extent that they represent present obligations as a result of events and transactions occurring prior to the end of the fiscal year. The settlement of liabilities will result in sacrifice of economic benefits in the future.

Net Liabilities

Net liabilities represent the difference between the carrying value of assets held by the Ministry and its liabilities.

Valuation of Financial Assets and Liabilities

Fair value is the amount of consideration agreed upon in an arm's length transaction between knowledgeable, willing parties who are under no compulsion to act.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND REPORTING PRACTICES
(continued)

The fair values of cash and cash equivalents, accounts receivable, advances, and accounts payable and accrued liabilities are estimated to approximate their carrying values because of the short term nature of these instruments.

Foreign Currency Transactions

The Ministry uses the temporal method to translate foreign currency transactions as follows:

- monetary items are translated at the rate of exchange in effect at the balance sheet date; and
- expense items and non-monetary items are translated at the rate of exchange in effect in the period they occur.

NOTE 3 PROGRAM TRANSFER AND PRIOR PERIOD RESTATEMENT

(in thousands)

Effective April 1, 2010, the Ministry of Service Alberta transferred the budgetary responsibilities for funding one full-time equivalent (FTE) to the Ministry. The 2010 comparatives have been restated as if the Ministry had always been assigned with its current responsibilities. Expenses for 2009-10 were increased by \$56 and the Net Financing Provided from General Revenue was increased by \$56, resulting in no change in net liabilities at March 31, 2010.

NOTE 8 OTHER BUSINESS RELATIONSHIPS

(in thousands)

Effective February 2009, the Province of Alberta renewed the agreement with the China National Petroleum Corporation (CNPC) for an additional 10-year period, expiring in February 2019. The CNPC-Alberta Petroleum Centre (CAPC) is located in Beijing, People's Republic of China. The main purpose of CAPC is to promote the transfer of advanced petroleum- and environment-related science and technology between China and Alberta. The CAPC Board of Directors includes up to eight Alberta directors appointed by the Province of Alberta and up to 10 CNPC appointed directors. As at March 31, 2011, the Province of Alberta had eight directors on the CAPC Board.

Effective September 2009, Alberta reduced its operational involvement with the CAPC office, significantly reducing expenditures for this joint arrangement. During the year, the Ministry contributed \$80 (2010 – \$457) towards operations, board meetings and training programs. This amount is included in the Ministry's financial statements under the element "International Relations" (Schedule 4).

NOTE 9 BENEFIT PLANS

(in thousands)

The Ministry participates in the multi-employer pension plans: Management Employees Pension Plan and Public Service Pension Plan. The Ministry also participates in the multi-employer Supplementary Retirement Plan for Public Service Managers. The expense for these pension plans is equivalent to the annual contributions of \$1,743 for the year ended March 31, 2011 (2010 - \$1,776).

At December 31, 2010, the Management Employees Pension Plan reported a deficiency of \$397,087 (2009 – deficiency \$483,199) and the Public Service Pension Plan reported a deficiency of \$2,067,151 (2009 – deficiency \$1,729,196). At December 31, 2010, the Supplementary Retirement Plan for Public Service Managers had a deficiency of \$39,559 (2009 – deficiency \$39,516).

The Ministry also participates in two multi-employer Long Term Disability Income Continuance Plans. At March 31, 2011, the Bargaining Unit Plan reported an actuarial deficiency of \$4,141 (2010 – deficiency \$8,335) and the Management, Opted Out and Excluded Plan an actuarial surplus of \$7,020 (2010 – surplus \$7,431). The expense for these two plans is limited to the employer's annual contributions for the year.

NOTE 10 COMPARATIVE FIGURES

Certain 2010 figures have been reclassified to conform to the 2011 presentation.

NOTE 11 APPROVAL OF FINANCIAL STATEMENTS

The financial statements were approved by the Senior Financial Officer and the Deputy Minister of International and Intergovernmental Relations.
