Purpose

The purpose of this Directive is to provide the public with information regarding *Forests Act* penalties in support of an open and transparent regulatory system. Doing so will increase public confidence in the enforcement of existing legislation and will improve compliance with the *Forests Act* and the associated Regulations.

Policy

Section 65 of the *Forests Act* enables the Minister to publish particulars of enforcement action taken under the *Act*. Forest Stewardship and Trade Branch has assumed responsibility for this Departmental requirement.

The information is publicly disclosed once the respondent has received a Notice of Penalty Assessment letter and accompanying invoice.

Requests for additional information are governed by the <u>Freedom of Information and Protection of Privacy Act (FOIPPA)</u>, and responded to through the Department's FOIPPA office.

Disclosure occurs through weekly posting on Alberta Agriculture and Forestry (AF) website: (https://www.alberta.ca/forest-management-compliance-and-enforcement.aspx).

The Department may also issue a news release, notifying the public of a penalty, in its discretion.

Procedure

The Respondent will be notified that a penalty has been assessed by means of registered mail. The registration number is tracked on the Canada Post website to confirm Delivery.

Information to be disclosed includes (where applicable):

- Name of the person or corporation on the Notice;
- Area in which the contravention occurred;
- Description of the contravention, citing the section of the Act or Regulation and a capsule description of the section's contents (e.g. "operations not in accordance with an approved annual operating plan");
- Date of the contravention; and
- Amount of penalty

Where a case has or may develop a high public profile (due to the nature of the infraction, size of penalty, etc.) the Forest Area Manager should inform the Forest Stewardship and Trade Branch Executive Director. In consultation with Communications Division they will decide if a news release is appropriate. The news release should be issued concurrent with confirmation of service of the Notice of Penalty Assessment.

Authorities

Forests Act s. 65 - requires the Minister to disclose information on penalties for contravention of the *Act* or the regulations.
