Data was suppressed so that the 2013 and 2014 data has considerably less detail than what was available in 2012 and earlier. From 2013, US data is not available by State, but by region.

**South Central** (Alabama, Kentucky, Mississippi, Tennessee, Arkansas, Louisiana, Oklahoma, Texas)

**Mountain** (Arizona, Colorado, Idaho, Montana, Nevada, New Mexico, Utah, Wyoming)

**Pacific, Alaska and Hawaii** (California, Oregon, Washington, Alaska, Hawaii)
