Re: Deciduous Pulp Dues Rates for the Period August 1, 2013 to August 31, 2013

This letter provides notice of Crown Timber and Forest Resource Improvement Association of Alberta (FRIAA) dues for deciduous pulpwood as established in the *Timber Management Regulation* and the *Forest Resources Improvement Regulation*.

Please submit your timber returns for the period August 1 to August 31, 2013 using the following rates:
