Re: Deciduous Pulp Dues Rates for the Period October 1 to October 31, 2013

This letter provides notice of Crown Timber and Forest Resource Improvement Association of Alberta (FRIAA) dues for deciduous pulpwood as established in the *Timber Management Regulation* and the *Forest Resources Improvement Regulation*.

Please submit your timber returns for the period October 1 to October 31, 2013 using the following rates:
