1.000 DEFINITIONS AND EXPLANATORY NOTES

1.001 DEFINITIONS

In this Part,

- (a) Act means the Municipal Government Act (RSA 2000 Ch.M-26);
- (b) **assessment year modifier** means the factor which is applied to the base cost of railway property in order to adjust its base cost to the assessment year;
- (c) *railway* has the meaning given to it in the Act.

1.002 CALCULATION OF ASSESSMENT

The assessed value of railway property in a municipality shall be calculated by:

- (a) establishing the base cost as prescribed in Schedule A of the 2005 Alberta Railway Property Assessment Minister's Guidelines;
- (b) multiplying the base cost by the appropriate Assessment Year Modifier prescribed in Schedule B of the 2005 Alberta Railway Property Assessment Minister's Guidelines to adjust the base cost to the assessment year;
- (c) multiplying the amount determined in clause (b) by the appropriate annual traffic factor prescribed in Schedule C of the 2005 Alberta Railway Property Assessment Minister's Guidelines.
