Bargaining Update is a monthly report that provides information about the unionized workforce, primarily in Alberta.

The settlement data reported in this issue of Bargaining Update is based on the collective agreement settlement information received by Mediation Services in January 2024.

In January 2024, Mediation Services received settlement information regarding 52 bargaining relationships encompassing 4,750 employees. There were 31 private sector and 21 public sector settlements, covering 2,766 and 1,984 employees respectively.

Grievance arbitration, while resulting in a binding outcome, is costly, often involving long delays for hearings and the issuing of awards. Grievance mediation is not a replacement for arbitration but an early intervention opportunity that is cost effective, timely and informal. The parties are always in control of the outcome.

Consumer Price Index (CPI)*, 2002=100






