Cattle:	Approximately 8,700 Animal Unit Months (AUMs)
Minimum number of Patrons:	21 patrons

Within the reserve there are 7,700 acres (3,116.1 hectares) that were developed into tame pasture. The reserve was designed to provide improved habitat for upland and big game, as well as grazing livestock.

Development of the tame pastures, using the integrated resource planning model, was a real challenge given the existence of hundreds of oil wells on the reserve. There's an on-going exploration program, along with winter seismic work. Recreational users are advised to exercise caution when using the access roads in the area as the reserve is situated in the heart of the West Pembina Oilfield.

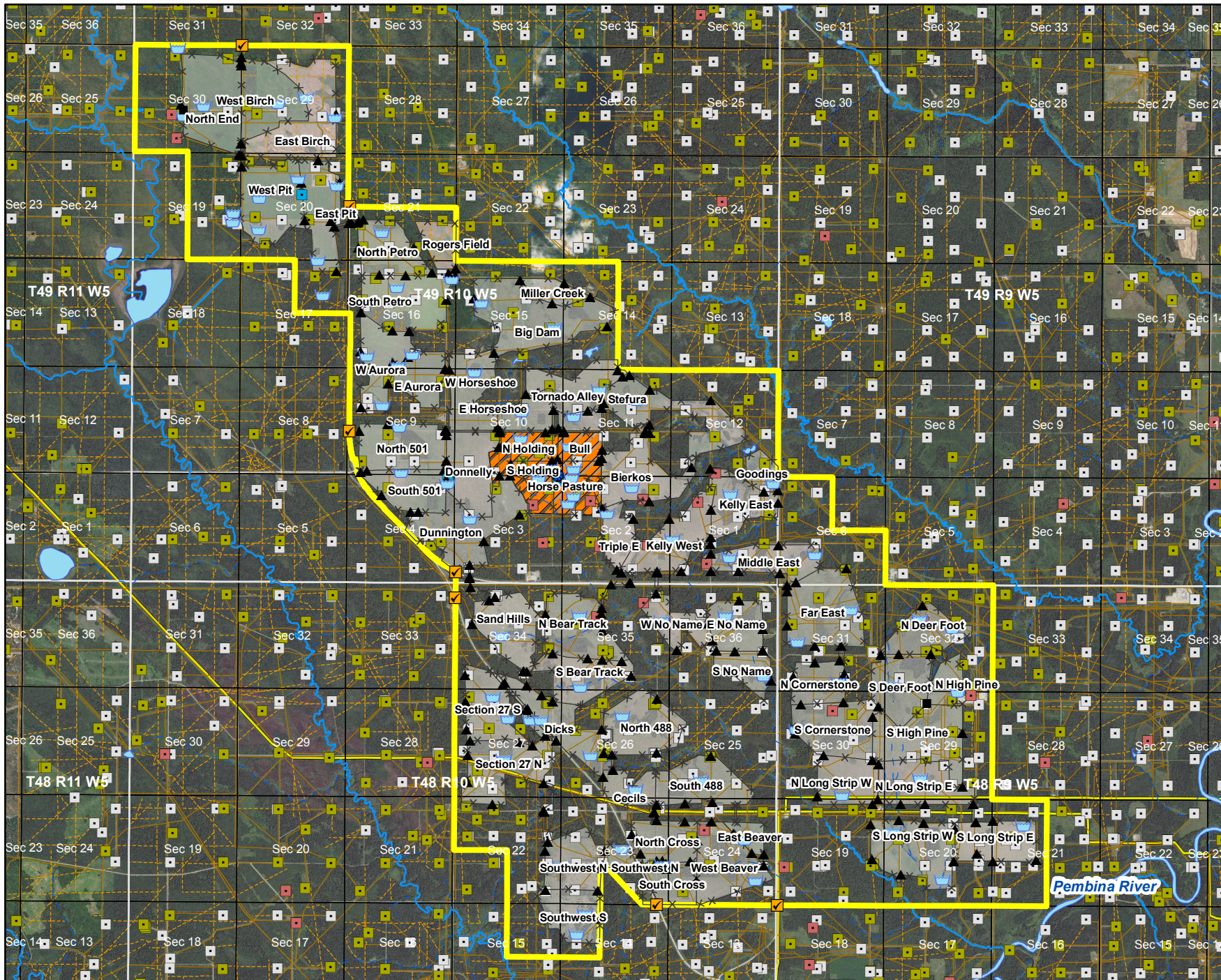
