3. Facts, Trends and Outlook

According to Statistics Canada's National Economic Accounts, the Public Administration industry accounted for approximately 4.2% of Alberta's Gross Domestic Product in 2016, up from 3.6% in 2006. Its contribution to Alberta's total employment increased from 4.1% in 2007 to 4.5% in 2017.

Total employment (the total number of employees and self-employed people, 15 years and over) in 2017 was 5.5% higher than its level in 2016. Over the last 10 years, employment increased by 20,000 from 2007, a 19.5% increase. There were 102,400 employed in the industry in 2017, of whom 94.3% were full time and 5.7% were part time.

2. Demographics: Gender and Age

According to the Labour Force Survey, the gender breakdown in the Public Administration industry in 2017 was as follows:

women employed: 48,500 people, or 47.4%men employed: 53,900 people, or 52.6%

Overall in Alberta, women accounted for 45.5% and men made up 54.6% of total employment (for all industries).


