# Minister's Teacher Advisory Council Overview

The Minister's Teacher Advisory Council is a group of 40 Alberta teachers who provide input to the Minister of Education and government on provincial education initiatives. The council members bring diverse interests, identities, backgrounds and perspectives from all across Alberta.

#### **Member Expectations**

The Minister's Teacher Advisory Council has an important role in the education system. Working at the provincial level, all council members will:

- offer diverse perspectives to Minister and ministry staff on current and emerging topics relevant to Alberta's education system;
- attend all meetings;
- foster open, respectful and constructive dialogue with one another, as well as with the Minister and ministry staff; and,
- not discuss matters pertaining to collective bargaining negotiations. Alberta's government recognizes the ATA's role as
  bargaining agent, and the council's role and purpose are not to undermine the bargaining relationship and effectiveness of
  the bargaining agent.

#### **Member Time Commitment**

Council members will serve a 10-month term, aligned with the school year. They will attend four meetings over the course of the term. 2022/23 dates are to be determined and are subject to change.

#### **Meeting Format**

The first meeting will be held in-person in Edmonton or Calgary. Remaining meetings will be held through Zoom and members will be able to access them through any browser or device as long as there is an internet connection.

## Guidelines and Expectations to Ensure Welcoming, Caring, Respectful and Safe Environments

All council members will be made aware of expectations for behavior and conduct, including the use of digital technologies.

Council members will receive information to understand their responsibilities and be required to sign a code of behavior expectations and a confidentiality agreement. Both documents assure all participants feel safe to engage in respectful, collaborative, open conversation with one another in council meetings.

#### **Meeting Expectations**

Council members will work with the Minister and government staff to provide input on education topics that will not include items that are related to collective bargaining negotiations.

# **Diversity and Representation**

The members of the Minister's Teacher Advisory Council will form a representative group of Alberta teachers, not their school districts.

## **Application Information**

#### **Application Deadline**

The application deadline is August 5, 2022.

Please plan to spend a few hours to work on your application to ensure it is the best possible and most accurate representation of yourself. This is the information used for the selection process.

Each applicant must complete and submit their own application.

#### **Application Question Limit**

Each question has a 2,000-character response limit. Please be as concise as possible.

#### Withdrawing from the Council

## **Selection Process**

After the application deadline of August 5, 2022, government staff will review and evaluate the applications received.

## **Open, Transparent and Inclusive Selection Process**

The Minister is committed to a transparent process for selecting council members.

To ensure the selection process is open, transparent and inclusive, teachers will be selected for the council based on:

- Diversity: The recruitment and selection process will honour and promote diversity on the council.
- **Competency**: The criteria for selecting council members will be based on creating a council that, collectively, has the skill-set and the mind-set needed to meet the needs and nature of the council as a whole.
- **Consistency**: The recruitment and selection processes will be applied consistently for all individuals selected by the provincial selection team to the council.
- **Transparency & Openness**: The recruitment and selection process will be clear and publicly available. The final 40 teachers selected for the council will be disclosed to the public.

To help with your application, here are some qualities, knowledge and skills the Minister hopes to see. You may also identify other qualities and the Minister is interested in hearing about those too.

#### Relevant Experience and Knowledge

Your experience and knowledge	You have life and relevant professional experiences that give insight into the education system. You value people and ideas and take action to learn more.
Personal Effectiveness Skills	
Relationship and Teamwork Skills	You have a demonstrated ability to foster positive and welcoming environments that encourage the sharing of ideas and different perspectives. You can demonstrate an understanding of the importance of teamwork. This may include an ability to inspire a shared vision for a better world, the skill of recognizing and valuing the contributions of others and or a demonstrated ability to support the success of a group when you are not the leader

#### After Applications are Reviewed

Applicants will be selected to be interviewed. If you are chosen to proceed to this second stage of the selection process, you will be contacted.

#### Interview Overview

You will be asked more questions related to your relevant experience and knowledge, and personal effectiveness skills. The interview will be a 15-minute video conference.

## **Interview Preparation**

Similar to your completed application, we want to learn as much as we can about your unique interests, identities, background and perspectives to create a diverse Minister's Teacher Advisory Council.

#### **Notification of Selection**

Teachers chosen as council members will be contacted in fall 2022. All applicants will receive notification the process has been completed and the council has been selected.

## **Financial Information**

There is no pay associated with being a member.

#### **Personal Information and Privacy**

As stated in the collection notice included at the bottom of each page of the application package, the personal information provided by the applicant will be used for two purposes:

- selecting members of the Minister's Teacher Advisory Council and
- administering the Minister's Teacher Advisory Council program, including communicating with members of the Council.

#### **Publication of Personal Information**

This information is included in the authorization and declaration form that is included in the application package. By signing, the applicants understands that if they are selected to be a council member, a public profile limited to name and hometown will be publicly disclosed by the Alberta government through newsletters, news releases, websites, and social media accounts to promote and advertise the Minister's Teacher Advisory Council and its activities.
