Family Violence Death Review Committee's Recommendations and Responses

The Family Violence Death Review Committee (FVDRC) is a multi-disciplinary, expert body, composed of individuals with extensive knowledge or experience in the area of family violence. Established under the *Protection Against Family Violence Act* (PAFVA) and reporting to the Minister of Community and Social Services (CSS), the FVDRC reviews incidents of family violence deaths in Alberta. Of those incidents, the FVDRC selects individual cases for an in-depth case review to determine why the deaths occurred and what measures can be taken to prevent similar deaths. Specific to each case, the FVDRC makes recommendations to the Minister of CSS for intervention and prevention strategies to support the reduction of family violence.

Government ministries impacted by the recommendations provide a response to the Minister of CSS. The following table tracks the FVDRC recommendations and government responses commencing with Case Review Report No. 7 and onwards. Case Review Report No. 7

Release Date: July 2019

Incident: In 2012, a female victim was found by the police deceased in her home from multiple stab wounds. The perpetrator was later found in a different location, having died as a result of suicide.
