# **GOA** Consultation Policy-A **Quick History**

**SEPT.** '00: In Strengthening *Relationships: The Government* of Alberta's Aboriginal Policy Framework, Alberta committed to consult with Aboriginal people when land management and resource development decisions may infringe their existing treaty or other constitutional rights. MAY '02: Alberta started development of a made-in-Alberta consultation policy. SEPT. - DEC. '03: First round of discussions about the policy with First Nations and industry. JAN. - JULY '04: Second round of discussions with First Nations and industry. AUG. '04: Draft consultation

policy is refined based on input from First Nations and industry. NOV. '04 - MAY '05: Discussions begin with First Nations and industry on developing Consultation Guidelines. MAY 16, '05: The Government of Alberta's First Nations Consultation Policy on Land Management and Resource Development is approved. Nov. '05: An Interim Approach is completed and posted at www.aand.gov.ab.ca/

### Consultation Guidelines

Since approval of the Consultation Policy, we have been working with First Nations and industry to develop a Framework for Consultation Guidelines. To focus the discussions, the GOA engaged in dialogue with the following groups:

- Treaty 6 Perspectives Group • Individual Treaty 7 First
- Nations
- Treaty 8 Technical Committee on Consultation and
- Industry Guidelines Advisory Group.

The Framework for Consultation Guidelines will identify the procedures, criteria or tests that will be common in each of the industry- or regulation-specific Guidelines. Once the Framework is completed, Alberta's resource development and land management departments will begin a process to develop the Guidelines themselves. The Guidelines will set out the detailed procedures for a specific regulated subject area.

Thank you to everyone who provided feedback in the last few months. We are considering

all feedback collected and hope to complete a draft Framework for Consultation Guidelines by early December. In the new year, we will circulate the Framework and then begin to develop the Guidelines, with completion targeted for 2006.

### Traditional Use Studies (TUS)

A traditional use study can identify where Aboriginal people hunt, fish, trap or gather on public land. Information contained in a TUS can also inform resource management decision-making and flag where potential conflicts might occur, including mapping where historical activities such as ceremonial or burial sites exist.

During consultation, a TUS can help avoid infringements of Aboriginal and treaty rights in Alberta, especially where the Aboriginal community shares the identity of significant sites with the province. TUS information can help resource management decisionmaking and help build positive relationships between the First Nation, government and industry that serve as the foundation to future consultation activities.

In 2003, Alberta developed its *Best Practices Handbook for Traditional Use Studies* through sponsorship under the Western Economic Partnership Agreement (federal and provincial funding). This handbook is available through Land and Resource Issues, and an electronic copy is available on the AAND website. A Traditional Use Directory is also available at www.aand.gov.ab.ca/PDFs/TUS0.pdf.

### A CONSULTATION CASE STUDY Protecting Buffalo Ribstones

Alberta Community Development became aware through local enforcement efforts of vandalism to the Buffalo Ribstones site near Viking. The site is of great significance to both Aboriginal and non-Aboriginal people. The good news is this: Through consultation, ACD and some First Nations Elders worked through some challenges of protecting this and other historic sites.

How so? The Confederacy of Treaty Six First Nation's Elders Council was asked to provide advice to ACD about protecting the Ribstones. Meetings were held with the representatives of the Elders Council to determine how best to protect them. The Elders, together with ACD, decided that two fences would prevent the Ribstones from being removed from the site. The Elders were happy that ACD worked with them respectfully to protect an important part of their First Nation's history. And ACD was pleased to report an example of consultation that worked for everyone involved. �

### First Nations Economic Partnerships Initiative

The Government of Alberta's new First Nations Economic Partnerships Initiative (FNEPI) focuses on developing effective partnerships between First

Nations, industry, governments and other stakeholders and on building greater economic capacity in First Nations communities. AAND's three new programs—and complementary programs of Alberta Economic Development and Alberta Human Resources and Employment have been discussed with First Nations and industry groups since early spring. AAND's programs will be introduced this fall.

**Program 1:** AAND is working with interested First Nations Tribal Councils to pilot the *Regional Partnership Development (RPD) Program*, which would deploy a network of up to 10 regional partnership coordinators, with central support. **Program 2:** Application information for the *Strategic Economic Initiatives (SEI) Program* is now available. SEI provides financial support for economic partnership initiatives and projects with significant strategic value. Contact Karen MacKenzie, Program Director, at (780) 427-8407.

Program 3: The Economic Capacity-Building (ECB) Program will support RPD and SEI by facilitating First Nations professional / learning networks; identifying and developing economic capacity-building tools, products and training modules; and identifying and disseminating best practices and current research.
