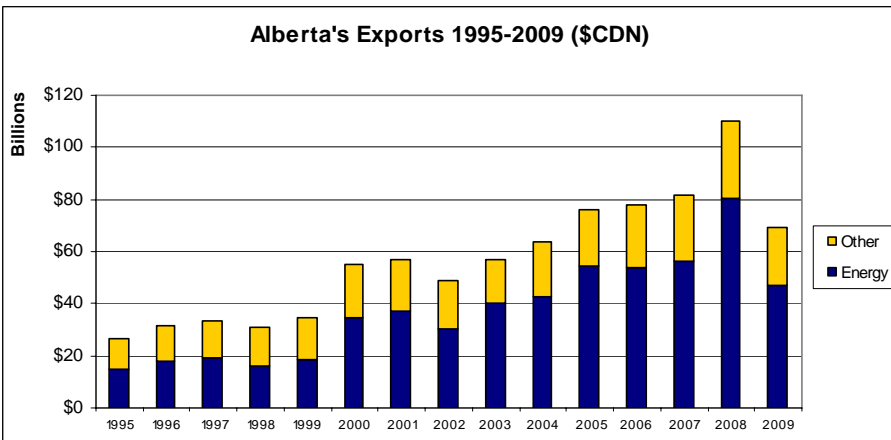


Fact Sheet: Alberta's Exports in 2009



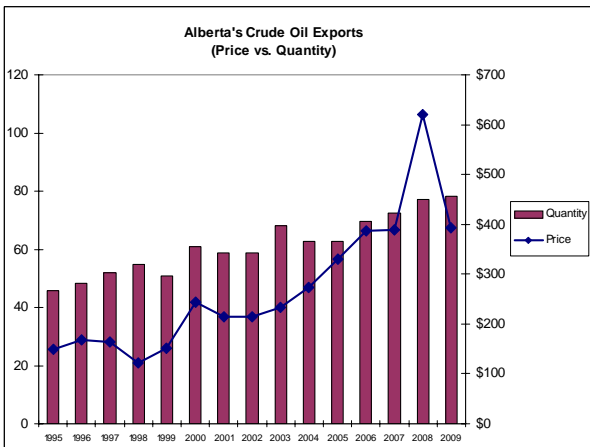
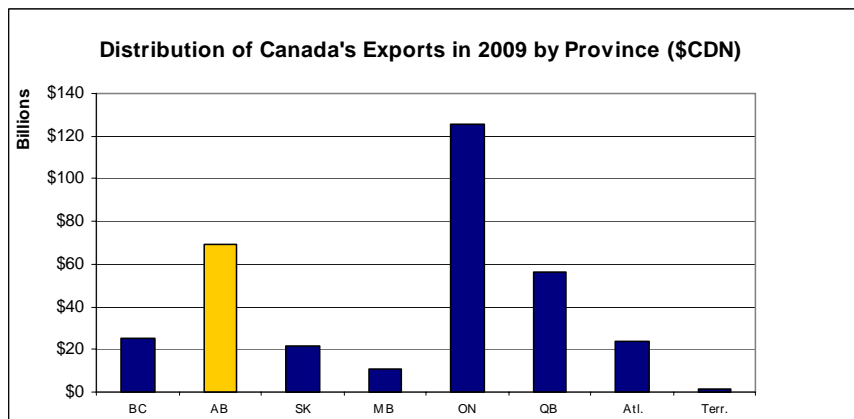
Alberta exported \$69.1 billion worth of goods in 2009, down 37.3% from 2008. Alberta's exports are still greater than they were in 2004.

Lower energy prices accounted for much of the decrease. Energy exports declined from \$80.1 billion in 2008 to \$47.0 billion in 2009.

Non-energy exports also decreased at a rate of 35.9%, from \$30.0 billion to \$22.1 billion.

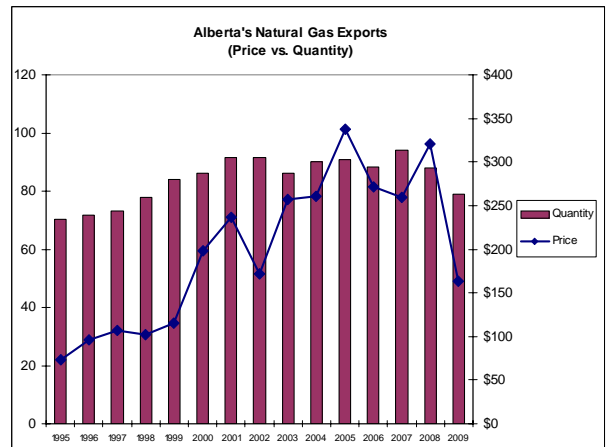
Alberta was the second largest provincial exporter in 2009 behind Ontario, and accounted for 20.7% of Canada's total exports in 2009.

Canada as a whole exported \$333.4 billion worth of goods in 2009, a decrease of 26.8% from 2008 exports.



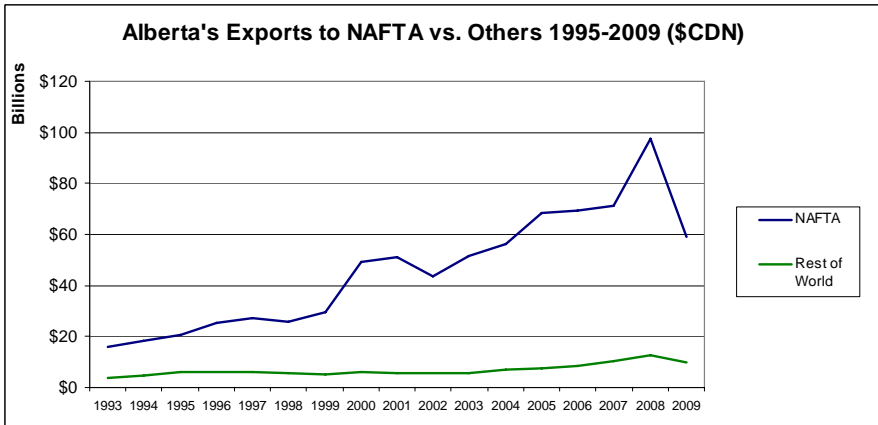
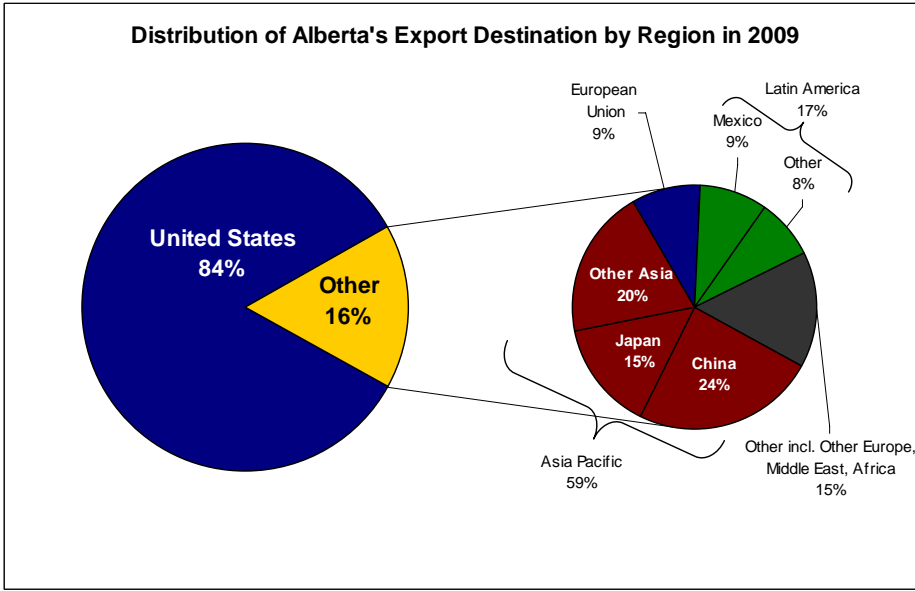
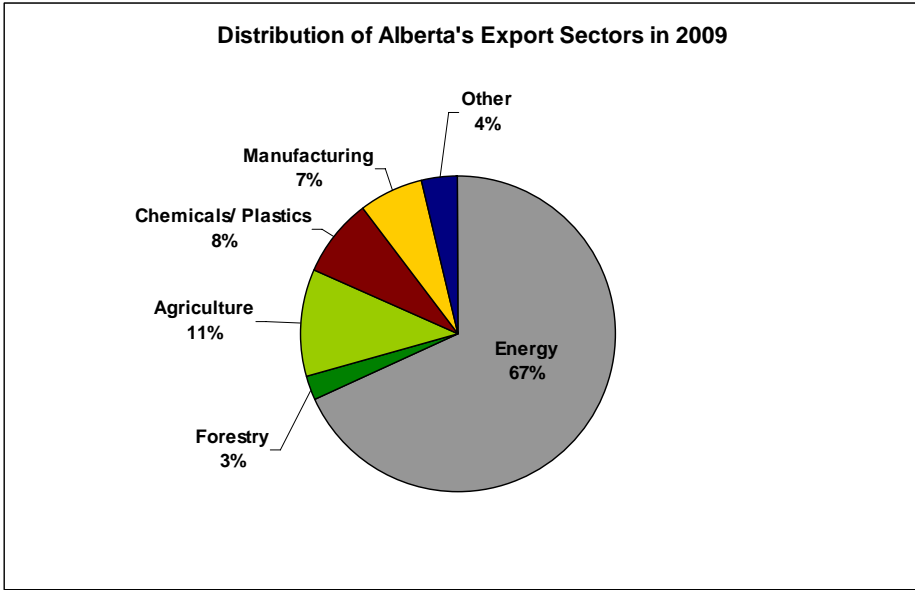
Alberta exported \$30.7 billion worth of crude oil in 2009, down 35.7% from \$47.8 billion in 2008. The volume of crude oil exports increased 1.3% from 2008 to 2009, but price declined 36.5% over the same time period. Note that the price is the average for 2009 and disguises large variations throughout the year.

Refers to HS 270900. Quantity is in billions of cubic meters. Price is in Canadian dollars per thousand cubic meters.



Alberta exported \$12.9 billion worth of natural gas in 2009, down 54.1% from \$28.1 billion in 2008. The volume of natural gas exports decreased 10.2%, while the average price decreased 48.8%. Export values decreased 54.1% from \$28.1 billion to \$12.9 billion in 2009.

Since 1993, the year before the implementation of the NAFTA, Alberta's exports to NAFTA (the US and Mexico) have increased 267% to \$59.0 billion in 2009. From 1993 to 2009, Alberta's exports to the rest of the world increased 175% to \$10.1 billion.
