ENVIRONMENTAL PROTECTION ORDER NO. EPO-2016/04-LAR

WHEREAS Environmental Protection Order No. EPO-2016/04-LAR [the "EPO"] was issued to the Cold Lake Regional Utility Services Commission ["CLRUSC"] on September 2, 2016;

WHEREAS Environmental Protection Order No. EPO-2016/04-LAR was to be completed on or before June 1, 2017;

WHEREAS on January 14, 2019, the Director issued Amendment No. 1, extending the completion date to March 31, 2019;

WHEREAS on March 26, 2019, Environmental Protection Officer, Dean LITZENBERGER received communication from the Chief Administration Officer [the "CAO"] of the Municipal District of Bonnyville No. 87, that works to restore the natural water flow from the wetland impacted by the 2016 wastewater release, is causing an increased flow of water into Crawford Lake;

WHEREAS the increased flow from the wetland, and the spring runoff, has the potential to raise the water level of Crawford Lake [the "Lake"], and may impact the residences on the shores of the Lake;

WHEREAS the CAO has the CAO has requested that the berm that was breached be restored to reduce the natural flow of water from the wetland to the Lake until spring runoff is complete to reduce the impact of high water on the residence of the Lake,

WHEREAS Alberta Environment and Parks staff recommend the completion date of condition 7(f), of the EPO, be extended to after the restricted wildlife period for the area, to allow for the waters in the Lake to naturally recced and to ensure minimal impact to wildlife;

WHEREAS I, Neil Brad, Regional Compliance Manager, Lower Athabasca Region [the "Director"] has been designated as Director for the purposes of issuing and amending Environmental Protection Orders under the *Act*;

WHEREAS the Director is in the opinion that the EPO must be amended to reflect this new information;

THEREFORE, I, Neil Brad, Director, pursuant to section 113 of the *Environmental Protection and Enhancement Act* DO HEREBY AMEND the EPO and ORDER:

 In Clause 7(f) of the Environmental Protection Order No. EPO-2016/04-LAR, Amendment No. 1, the date of "March 31, 2019 at 4:00PM" is deleted and replaced with "September 30, 2019 at 4:00PM"
