OVERVIEW

The Construction industry¹ in Alberta includes establishments that:

- construct, repair or renovate residential buildings (i.e. houses, apartment buildings, condominiums);
- construct, repair or renovate business and commercial buildings
- (i.e. office towers, shops, malls);
- construct, repair or renovate industrial buildings (i.e. oil refineries, petrochemical plants, power plants);
- perform engineering works (i.e. highways, bridges, pipelines); and
- subdivide and develop land.

2. Industry's Growth

- The Construction industry accounted for 11.3% of total employment in Alberta in 2015.
- Employment in this industry is expected to decrease at an average rate of -0.4% from 2016 to 2019⁴.
- The industry is expected to account for 10.3% of total employment in Alberta in 2016.

3. Facts, Trends and Outlook

According to Statistics Canada's National Economic Accounts, the Construction industry accounted for approximately 10.1% of Alberta's Gross Domestic Product in 2015, up from 9.5% in 2005. Its contribution to Alberta's total employment increased from 9.0% in 2005 to 11.3% in 2015.

Total employment (the total number of employees and self-employed people, 15 years and over) in 2015 was 1.4% higher than its level in 2014. Over the last 10 years, employment increased by 96,700 from 2005, a 59.3% increase. There were 259,900 employed in the industry in 2015, of whom 94.5% were full time and 5.5% were part time.

2. Demographics: Gender and Age

According to the Labour Force Survey, the gender breakdown in the Construction industry in 2015 was as follows:

- women employed: 36,400 people, or 14.0%
- men employed: 223,500 people, or 86.0%

Overall in Alberta, women accounted for 45.1% and men made up 54.9% of total employment (for all industries).


