This letter is notice of Crown Timber and Forest Resource Improvement Association of Alberta (FRIAA) dues for timber that is used or will be used to make lumber, pulp or roundwood timber products as established in the Timber Management Regulation and the Forest Resources Improvement Regulation. Please submit your timber returns for the period April 1 to April 30, 2013 using the following rates:

For the month of April 2013, these net timber dues are \$3.15 per cubic meter for sales under 107 296 m³ and \$4.76 per cubic meter for sales over 107 296 m³.
