# Overview

The 2021 and 2022 Industry Profile for the Public Administration Industry provides statistics and trends in the labour market for the public administration sector in Alberta. Topics include employment, unemployment, number of businesses, occupation, wages and demographics. All statistics provided are 12-month averages for the year. The statistics are from Statistics Canada's Labour Force Survey and the Alberta Wage and Salary Survey.

The public administration<sup>1</sup> industry in Alberta includes federal, provincial and local government services such as:

- defence services;
- police, judicial, correctional and other protective services;
- labour, employment and immigration services;
- foreign affairs and international assistance;
- fire-fighting services; and
- regulatory services.

## Facts, Trends and Outlook

According to the most recent Statistics Canada's National Economic Accounts,<sup>2</sup> the public administration industry accounted for 5.2% of Alberta's Gross Domestic Product (GDP) in 2021, an increase from 4.3% in 2011. Between 2012 and 2022, this industry's contribution to Alberta's employment rose from 4.4% to 4.6%.

Total employment in the public administration industry (the total number of employees and self-employed people 15 years and over) in 2022 was 4.8% higher than its level in 2021. Over the last 10 years, employment in this industry rose by 12,100, a 12.6% increase. There were 108,200 people employed in the industry in 2022, of whom 94.5% were full-time and 5.5% were part-time.

## **Occupational Growth**

Some occupations in the public administration industry with above average forecasted growth<sup>3</sup> between 2023 and 2025 include:

- land surveyors;
- translators, terminologists and interpreters; and
- natural and applied science policy researchers, consultants and program officers.

## **Demographics: Gender and Age**

In 2022, workers in the public administration industry are:

- slightly more likely to be female than the general workforce; and
- more likely to be of core working age than the workforce as a whole.


