# Canadian Agricultural Partnership (CAP) in Alberta: Next Policy Framework Engagement

CAP is a five-year, \$3 billion federal-provincial-territorial investment in the agriculture, agri-food and agri-based products sector that began in April 2018. We are gathering feedback to help inform the development of the Next Policy Framework, set to replace CAP in April 2023, and continue investing in Alberta's agriculture industry. Through this engagement, representatives of Alberta's agriculture, agrifood and agri-products sector have the opportunity to share feedback on the five priority areas identified in the <u>Guelph Statement</u>, a policy document endorsed by the federal, provincial and territorial agriculture ministers to help guide the development of the Next Policy Framework.
