Manual wheelchairs

Policy Statement

Wheelchairs are recyclable benefits. Wheelchairs funded by AADL that are no longer required by the client must be returned to the AADL recycle vendor to be recycled, except for upgrade/grant wheelchairs, which are considered client owned. Refer to AADL Program Manual Sections WM, ZN and ZR for processes.

Eligibility

Wheelchair eligibility is based on usage and clinically assessed needs, which determines the category funded by AADL. See eligibility under each category. Authorizers must upload the corresponding AADL Eligibility Summary form for each benefit type (A, B, C, tilt-in-space, heavy-duty or grant).

Wheelchairs can only be replaced if deemed not cost-effective to repair or the client's clinical needs have changed. A quantity and frequency review request is required only if the client's current wheelchair has been registered to them for less than five years.

Costs

Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual wheelchair specification sheets available on manufacturers' websites. All AADL-funded wheelchairs must meet the equipment standards listed below.

Adult clients preferring a higher category (B or C) wheelchair than they are eligible for may be able to receive a grant of \$2,000 (subject to cost-share) to be used towards the purchase. These wheelchairs will be considered upgrade wheelchairs. Tilt-inspace wheelchairs may be considered in this process. See page 11 for grant wheelchairs.

Equipment standards

- Wheelchairs must meet RESNA standards.
- Product must have been on the North American market for a minimum of one year.
- Manufacturer must have an active representative in the province includes regular visits to AADL vendors and availability
 for consults.
- Minimum warranties: Five years on frame and 12 months on wheels and casters.

Manual wheelchairs: Adult category A

Category A wheelchairs have a weight capacity listed with each chair. Using a heavy-duty package will increase the weight capacity of the wheelchair. See page 13 for more information.

Eligibility (category A)

Clients must require a wheelchair for part-time use, or full-time indoor use with occasional outdoor use.

Clients who have an AADL-funded power wheelchair or are applying for power wheelchair funding are only eligible for a category A wheelchair from the recycle inventory

Occasional users are not eligible for a new category A wheelchair. Clients may be eligible for a category A wheelchair through the recycle inventory, or pursue the private purchase of a transport chair.

Clients must be willing to accept a comparable substitute for category A wheelchairs.

Authorizations

Authorizers must inquire with the recycle vendor first to search the recycle inventory for a suitable match before submitting an authorization. The authorization type will be for either "recycle" or "new" equipment. New equipment can only be ordered after the recycle inventory has been searched and the authorizer has received a written confirmation that there is no suitable equipment available.

If an authorizer is only searching through the recycle inventory (such as per client's request, client is an occasional user or to locate a back-up option for a client who has a power wheelchair), the authorizer must check off the "recycle only" box on the generic specification form and provide an explanation in the comments. Note that there are wheelchairs for palliative clients available in the recycle inventory.

Wheelchairs can only be replaced if deemed not cost-effective to repair or the client's clinical needs have changed. A quantity and frequency review request is required only if the client's current wheelchair has been registered to them for less than five years. A search of the recycle inventory to find a replacement is required prior to submitting a quantity and frequency review request.

Authorizers must upload the AADL Eligibility Summary for Category A Manual Wheelchair Benefits form through the Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. They must also notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs

The maximum funding paid by AADL for an adult category A wheelchair is \$2,500, subject to cost-share, and includes the vendor discount.

Clients are responsible for any upcharges or options not funded by AADL. Costs above this amount are the responsibility of the client. AADL funds repairs for wheelchair that are considered AADL-owned.

Funding for additional options on category A adult wheelchairs are separate. See Manual wheelchair options on page 25 for category A wheelchair options..

Manual wheelchairs: Adult category B

Category B chairs will not be ordered from the recycle inventory unless requested by the client, but must be returned to the recycle vendor when no longer required by the client.

Eligibility (category B)

Full-time wheelchair use, independent mobility (able to self-propel indoors and outdoors). See AADL Program Manual Section WM – Manual Wheelchair Benefits for full eligibility.

Wheelchairs can only be replaced if deemed not cost-effective to repair or the client's clinical needs have changed. A quantity and frequency review request is required only if the client's current wheelchair has been registered to them for less than five years.

Authorizations

Authorizers must upload the AADL Eligibility Summary for Category B Manual Wheelchair Benefits form to the Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. They must also notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs

The maximum funding paid for a category B AADL wheelchair is \$3,300, subject to cost-share, and includes the vendor discount.

Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual wheelchair specification sheets available on the manufacturers' websites. Costs above this amount are the responsibility of the client. AADL funds repairs for wheelchair that are considered AADL-owned.

Funding for some additional options on category B wheelchairs are separate and are found under Manual wheelchair options on page 25.

Manual wheelchairs: Adult category C

Category C chairs will not be ordered from the recycle inventory unless requested by the client, but must be returned to the recycle vendor when no longer required by the client.

Eligibility (category C)

Full-time wheelchair use, independent mobility (able to self-propel indoors and outdoors) and client has a risk of upper extremity overuse/injury. In addition, the client frequently (and independently) goes out in the community – at least four out of seven days a week.

Wheelchairs can only be replaced if deemed not cost-effective to repair or the client's clinical needs have changed. A quantity and frequency review request is required only if the client's current wheelchair has been registered to them for less than five years.

Authorizations

Authorizers must upload the AADL Eligibility Summary for Category C Manual Wheelchair Benefits form to the Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. They must also notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs

The maximum funding paid for a category C wheelchair is \$3,900, subject to cost-share, and includes the vendor discount.

Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual wheelchair specification sheets available on the manufacturer website. Costs above this amount are the responsibility of the client. AADL funds repairs for wheelchair that are considered AADL-owned.

Funding for some additional options on category C wheelchairs are separate and are found under Manual wheelchair options on page 25.

Manual wheelchairs: Grant wheelchairs - Adult category A and B

Adult clients preferring a higher category (B or C) wheelchair than they are eligible for may be able to receive a grant of \$2,000 (subject to cost-share) to be used towards the purchase. This wheelchair will be considered an upgrade wheelchair. Tilt-in-space wheelchairs may be considered in this process.

Grants require prior approval from AADL. Approval status will appear on the Alberta Blue Cross online health portal following document submission, and authorizers will receive an email from Alberta Blue Cross when a decision has been made.

Authorizations

Authorizers must upload the AADL Eligibility Summary – Wheelchair Grants form to the Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. The form must be signed by both the client and the authorizer. Authorizers must notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

All AADL-funded wheelchairs must meet the same equipment standards and must be from an approved manufacturer.

Clients are responsible for all maintenance, parts changes and repairs (refer to AADL Program Manual Section WM – Manual Wheelchair Benefits for details).

Clients are not eligible for a replacement for five years and are not eligible for the quantity and frequency review process.

Manual wheelchairs: Grant wheelchairs - Adult category D

Eligibility (category D)

Adults with a non-progressive condition only. Full-time wheelchair use, independent mobility (able to self-propel indoors and outdoors) and client has a risk of upper extremity overuse/injury. In addition, the client frequently (and independently) goes out in the community (at least four to seven days a week).

Clients eligible for category C wheelchairs may apply for the higher-level category D wheelchairs, and may be able to receive a grant of \$4100 (subject to cost-share) to be used towards the purchase. This wheelchair will be considered an upgrade wheelchair. See Policy Manual-WM: Manual Wheelchair Benefits-Adult/Pediatric for further details. The client becomes the owner of category D wheelchairs.

Grants require prior approval from AADL. Approval status will appear on the Alberta Blue Cross online health portal following document submission and the authorizer will receive an email from Alberta Blue Cross when a decision has been made.

Authorizations

Authorizers must upload the AADL Eligibility Summary – Wheelchair Grants form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. The form must be signed by both the client and the authorizer. Authorizer must notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Wheelchairs provided under category D must meet the equipment standards listed on page 4.

Clients are responsible for all maintenance, parts changes and repairs (refer to AADL Program Manual Section WM – Manual Wheelchair Benefits for details).

Clients are not eligible for replacement for five years and are not eligible for the quantity and frequency review process.

Manual wheelchairs: Heavy-duty

Eligibility

Clients must weigh more than 250 lbs. Clinical justification is required if a client is less than 250 lbs. and needs a heavy-duty wheelchair.

Authorizations

Authorizers must inquire with the recycle vendor first to search the recycle inventory for a suitable match before submitting an authorization. The authorization type will be for either "recycle" or "new" equipment. New equipment can only be ordered after the recycle inventory has been searched and the authorizer has received a written confirmation that there is no suitable equipment available. This confirmation must be uploaded with the authorization. A search of the recycle inventory for a suitable match is also required prior to submitting a quantity and frequency review request.

Authorizers must upload the AADL Eligibility Summary for Category A High Weight/Heavy Duty Manual Wheelchair Benefit Type form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. They must also notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs

Costs are based on the manufacturer specification sheets and vendor discounts. Costs related to options for heavy-duty wheelchairs are included on the manufacturer specification sheets.

Authorizers must add the appropriate heavy-duty package for the vendor. The maximum price is \$2,500 plus the price of the HD option package. Heavy-duty wheelchairs are eligible for options listed under Manual wheelchair options on page 25. Heavy-duty packages cannot be combined with the extra-wide option (W111).

Clients are responsible for any upcharges or options not funded by AADL.

Sizing is in 1" increments.

The authorization type will be for either "recycle" or "new" equipment. New equipment can only be ordered after the recycle inventory has been searched and the authorizer has received written confirmation from the recycle vendor that there is no suitable equipment available. This confirmation must be uploaded with the authorization. A search of the recycle inventory for a suitable match is also required prior to submitting a quantity and frequency review request.

Authorizers must upload the AADL Eligibility Summary for Category A High Weight/Heavy Duty Manual Wheelchair Benefit Type form to the Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. They must also notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs

Clients are responsible for any upcharges or options not funded by AADL. Costs are based on the manufacturer specification sheets and vendor discounts. Costs related to heavy-duty options are included on the manufacturer spec sheets.

Eligibility

Clients must be willing to accept a comparable substitute for tilt-in-space wheelchairs.

Authorizations

Authorizers must inquire with the recycle vendor first to search the recycle inventory for a suitable match before submitting an authorization. The authorization type will be for either "recycle" or "new" equipment. New equipment can only be ordered after the recycle inventory has been searched and the authorizer has received written confirmation from the recycle vendor that there is no suitable equipment available. This confirmation must be uploaded with the authorization. A search of the recycle inventory for a suitable match is also required prior to submitting a quantity and frequency review request.

Authorizers must upload the AADL Eligibility Summary for Category A Manual Wheelchair Benefit Type form to the Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. They must also notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs

AADL pays \$2,500 or 51 per cent of the costs (subject to cost-share) for a tilt-In-space/recline wheelchair, whichever is greater to maintain AADL-ownership.

Clients are responsible for the costs of any options not funded by AADL. These are listed on the individual wheelchair specification sheets available on the manufacturer website.

The option codes under Manual wheelchair options (page 25) are available for tilt-in-space.

New equipment can only be ordered after the recycle inventory has been searched and the authorizer has received written confirmation from the recycle vendor that there is no suitable equipment available. This confirmation must be uploaded with the authorization. A search of the recycle inventory for a suitable match is also required prior to submitting a quantity and frequency review request.

Power Wheelchairs

Eligibility

Refer to AADL Program Manual Section WP – Power Wheelchair Benefits for details on eligibility. A Power Mobility Application form is required to determine if a client is eligible for power mobility. Tilt options eligibility is determined through the AADL Power Tilt-in-Space Request form and is a separate authorization.

Clients must be willing to accept a comparable substitute for power wheelchairs to be eligible for AADL funding.

Power wheelchairs must be trialed first with the preferred vendor, and then a search of the recycle inventory must be completed by sending a Generic Specification form – Power Wheelchair to the recycle vendor before submitting an authorization on Alberta Blue Cross online health portal. New equipment can only be ordered after the recycle inventory has been searched and the authorizer has received a written confirmation from the recycle vendor that there is no suitable equipment available. The confirmation must be uploaded with the authorization.

The authorization is for a "power wheelchair" for both recycle and new purchases.

All power wheelchair authorization requests must be approved by AADL prior to equipment being provided. Once the Power Mobility Application form and manufacturer specifications are uploaded with the authorization to the Alberta Blue Cross online health portal, the request will be reviewed by AADL. The authorizer will receive an email from Alberta Blue Cross once the decision has been made. The authorizer is then responsible for ordering a wheelchair with the recycle vendor, or a vendor of the client's choice if purchasing new. AADL does not search the recycle inventory or complete orders for equipment.

Power wheelchair categories

AADL-funded power wheelchairs are divided into four categories:

- Adult basic: The client requires a standard power wheelchair only and does not currently require tilt options. The client may
 require additional seating benefits.
- Adult heavy-duty: The client requires heavy-duty features to accommodate weight. They may also require tilt or tilt and recline.
- Adult complex: Client requires tilt, tilt and recline or complex electronics to accommodate drive controls. Complex also includes clients who use front-wheel drive wheelchairs.
- Pediatric: For clients aged 17 and under. Adult clients who may benefit from a wheelchair with a smaller frame may request a pediatric wheelchair, but there must be sufficient clinical justification provided for AADL review.

Costs

Clients are responsible for any upcharges or options not funded by AADL. These include seat elevators, high-speed motors, power elevating leg rests and foot platforms. Tilt options are funded for adult clients only.

See AADL Program Manual Section WP – Power Wheelchair Benefits for a complete list of options not covered by AADL. Other options may be covered depending on clinical rationale. See code W100 on page 33 for specialty control coverage.

AADL does not provide funding for repairs for any privately purchase wheelchair or options, including no-charge options.

Refer to AADL Program Manual Section WP – Power Wheelchair Benefits for details on eligibility. A Power Mobility Application form is required to determine if a client is eligible for power mobility.

Power wheelchairs must be trialed first with the preferred vendor, and then a search of the recycle inventory must be completed by sending a Generic Specification form – Power Wheelchair to the recycle vendor before submitting an authorization on Alberta Blue Cross online health portal.

All power wheelchair authorizations must be approved by AADL prior to the equipment being provided. Clients must be willing to accept a comparable substitute for power wheelchairs to be eligible for AADL funding.

Costs

Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual power wheelchair specification sheets available on the manufacturer's website and include seat elevators, power elevating leg rests, and foot platforms.

The tilt option is not funded for pediatric clients. Other options may be covered depending on clinical rationale. See code W100 for specialty control coverage on page 33. See AADL Program Manual Section WP – Power Wheelchair Benefits for a complete list of options not covered by AADL.

Clients are provided with one type of control, and only one type of specialty control is funded. Clients funded for specialty controls own the controls and must be willing to accept responsibility for repairs. A client is not funded for both a basic joystick and specialty control.
