## WHEELCHAIRS

**Wheelchairs are Recycle Benefits:** Wheelchairs funded by AADL and are no longer required by the client are returned to an AADL vendor to be recycled except Upgrade wheelchairs that are considered as client owned.

**Eligibility:** Wheelchair eligibility is based on usage and clinically assessed needs, which determines the category funded by AADL. See eligibility under each category.

Must attach the AADL Eligibility Summary for Manual Wheelchair Benefits

**Costs:** Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual wheelchair spec sheets available on the AADL website. Adult clients preferring a higher category (B or C) than they are eligible for are handled as upgrade wheelchairs; a grant of \$2000.00 (subject to cost-share) may be provided toward the purchase. All AADL funded wheelchairs must meet the equipment standards listed below.

Clients are responsible for all maintenance, parts changes and repairs on upgrade wheelchairs (refer to Policy WM-Manual for details).

V-codes are for keyhole and K-backs only. Regular adjustable tension back upholstery for a new wheelchair must be ordered on the spec sheet. AADL will not accept work orders for new back upholstery for a minimum one year after initial order.

**Equipment Standards for all AADL funded Wheelchairs:**

Wheelchairs must meet RESNA standards. Product must have been on the North American market for a minimum of one year.

Manufacturer must have an active representative in the province – includes regular visits to AADL Vendors and availability for consults.

Distribution of equipment is through AADL Approved Vendors with a facility maintained in Alberta.

Parts must be available from a Canadian Distributor warehouse.

Minimum warranties: 5 years on frame and 12 months on wheels and casters.

### MANUAL WHEELCHAIRS: ADULT CATEGORY A

**Category A wheelchairs** have a weight capacity of 250 lbs. unless otherwise stated. Using a Heavy Duty package will increase the weight capacity of the wheelchair.

Funding for additional options on Category A adult wheelchairs are separated and are found under Wheelchair Options benefit codes on page APL W-11.

**Clients must be willing to accept a comparable substitute for Category A wheelchairs.**

**Eligibility Category A:** Part time wheelchair use or full time indoor use with occasional outdoor use or for use as back up when power wheelchair is in for repairs.

The W-code and clinical rationale must be written on the 1251 form for elevating leg rests and angle adjustable foot plates.

**Basic Price:** based on seat width (15-18") x depth (16-18"), 24" mag wheels, adjustable height armrests, 8" casters, composite handrims, standard 70° footrests, angle adjustable back canes, urethane tires and anti-tippers. This price is used for comparison purposes only and is not the final cost of an individualized wheelchair order.

**Costs:** Max.funding paid by AADL for an adult Category A wheelchair is \$2500.00. Calculating client costs is required on Category A spec sheets.

**Category A wheelchairs** have a weight capacity of 250 lbs. unless otherwise stated. Using a Heavy Duty package will increase the weight capacity of the wheelchair. Funding for additional options on Category A adult wheelchairs are separated and are found under Wheelchair Options benefit codes on page APL W-11.

**Clients must be willing to accept a comparable substitute for Category A wheelchairs.**

**Eligibility:** Category A: Part time wheelchair use or full time indoor use with occasional outdoor use or for use as back up when power wheelchair is in for repairs.

Must attach the AADL Eligibility Summary for Manual Wheelchair Benefits. AADL will not accept work orders for new back upholstery for a minimum one year after initial order.

**Basic Price:** Based on seat width (15-18") x depth (16-18"), 24" mag wheels, adjustable height armrests, 8" casters, composite handrims, standard 70° footrests, angle adjustable back canes, urethane tires and anti-tippers. This price is used for comparison purposes only and is not the final cost of an individualized wheelchair order.

**Costs:** Maximum funding paid by AADL for an adult Category A wheelchair is \$2500.00 subject to cost share and including vendor discount. The price maximum does not include the W-option codes on APL W-11. Calculating client costs is required on Category A spec sheets. V-codes are keyhole and K-backs only. Regular adjustable tension back upholstery for a new wheelchair must be ordered on the spec sheet.

Must attach the AADL Eligibility Summary for Manual Wheelchair Benefits

**Basic Price:** Based on seat width (15-18") x depth (16-18") w/c with 24" mag wheels, adjustable height armrests, casters, composite handrims, standard footrests and back. **Eligibility:** Category C: Full time wheelchair use, independent mobility (able to self-propel indoors and outdoors) and has a risk of U/E overuse/injury

In addition, the client frequently (and independently) goes out in the community – at least 4/7 days a week.

Must attach the AADL Eligibility Summary for Manual Wheelchair Benefits

**\*Basic Price:** based on 18" x 18" w/c with wheels, casters, armrests, footrests and back. Maximum funding paid (for Category C clients) for a Category C wheelchair is \$3900.00 subject to cost share and including vendor discount.

**Costs:** Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual wheelchair spec sheets available on the AADL website. Costs above this amount are the responsibility of the client. AADL funds repairs for wheelchair that are considered AADL owned. V-codes are for keyhole and K-backs only. Regular adjustable tension back upholstery for a new wheelchair must be ordered on the spec sheet.

**MANUAL WHEELCHAIRS: ADULT CATEGORY D**

**Eligibility** Category D: Adults with a non-progressive condition only - full time wheelchair use, independent mobility (able to self-propel indoors and outdoors) and has a risk of U/E overuse/injury. In addition, the client frequently (and independently) goes out in the community – at least 4/7 days a week.

Requests from clients **eligible for Category C** Wheelchairs may apply for the higher-level category D wheelchairs, which are **considered and funded as Upgrade**

**Wheelchairs**—see Policy WM-Manual. Clients become the owner of Category D wheelchairs - repairs are the responsibility of the client.

Wheelchairs provided under Category D must meet the wheelchair standards listed on page W-1.

### MANUAL WHEELCHAIRS: ADULT HIGH WEIGHT CAPACITY

**Adult High Weight Capacity Manual Wheelchairs** have a weight capacity of 600 lbs. or more.

Sizing is in 1" increments unless otherwise indicated\* (indicates 2" increments)

**Eligibility:** Clients must weigh over 350 lbs. to be eligible for Adult High Weight Capacity wheelchairs.

Must attach the AADL Eligibility Summary for Manual Wheelchair Benefits

**Costs:** Costs are based on the Manufacturer spec sheets and vendor discounts. Costs related to heavy duty options are included on the Manufacturer spec sheets.

Additional W-codes not required.

V-codes are for keyhole and K-backs only. Regular adjustable tension back upholstery for a new wheelchair must be ordered on the spec sheet. . AADL will not accept work orders for new back upholstery for a minimum one year after initial order.

Clients are responsible for any upcharges or options not funded by AADL.

### MANUAL WHEELCHAIRS: ADULT TILT-IN-SPACE (Includes Back/seat/headrest)

Tilt-in-Space wheelchairs are provided to clients who are unable to maintain a sitting position with any other back types or seating device, or to clients with chronic wounds that cannot be managed in a non-tilt wheelchair using basic pressure redistribution strategies (pressure redistribution cushions, nutrition, incontinence management and regular repositioning). These wheelchairs are authorized with the back, seat and headrest included.

**Eligibility:** Manual Tilt-in-Space form must be attached to authorization to confirm eligibility for tilt and/or recline feature.

Clients must be willing to accept a comparable substitute for Tilt-in-Space wheelchairs.

Must attach the AADL Eligibility Summary for Manual Wheelchair Benefits

**Maximum Wt. Capacity:** See individual spec sheets for maximum weight capacities.

**Costs:** Clients are responsible for the costs of any options not funded by AADL. These are listed on the individual wheelchair spec sheets available on the AADL website.

AADL pays \$2500.00 or 51% of the costs for an AADL T-I-S/Recline (subject to cost-share) whichever is greater to maintain ownership. W-codes are not used unless for OAD.

### MANUAL WHEELCHAIRS: ADULT TILT-IN-SPACE (Base only)

Tilt-in-Space wheelchairs are provided to clients who are unable to maintain a sitting position with any other back type or seating devices or to clients with chronic wounds that cannot be managed in a non-tilt wheelchair using basic pressure redistribution strategies (pressure redistribution cushions, nutrition, incontinence management and regular repositioning).

Adult Tilt-in-Space Wheelchairs in this section do not come with a back or headrest. Level A authorizers may authorize these wheelchairs bases. Authorizers would then choose the back, seat and headrest as Level A components or refer to Level B or C Seating Authorizers for Level B or C components.

Eligibility: Tilt-in-Space wheelchairs must be supported by a Manual Tilt-in-Space Form to confirm eligibility.

Clients must be willing to accept a comparable substitute for Tilt-in-Space wheelchairs.

Must attach the AADL Eligibility Summary for Manual Wheelchair Benefits

**Maximum Wt. Capacity:** See individual spec sheets for maximum weight capacities.

**Costs:** Clients are responsible for the costs of any options not funded by AADL. These are listed on the individual wheelchair spec sheets available on the AADL website. W-codes are not used except for OAD option.

AADL pays \$2500.00 or 51% of the costs for an AADL T-I-S/Recline (subject to cost-share) whichever is greater to maintain ownership.

### MANUAL WHEELCHAIRS: PEDIATRIC

**Eligibility:** Category A: Part time wheelchair use or full time indoor use with occasional outdoor use or for use as back up when power wheelchair is in for repairs. Under the age of 18 years. Family of the client must be willing to accept a comparable substitute for Category A wheelchairs. W-codes are not used on pediatric wheelchairs.  
 Rigid frame or One Arm drive - Must be independent (self-propelling), Tilt-in-Space form required when authorizing tilt option.  
 Category B wheelchairs: may be provided to children requiring SGCD mounting (Children already prior approved by AADL SLP consultant for A406 and A410)  
 Must attach the AADL Eligibility Summary for Manual Wheelchair Benefits  
 Authorizer may request AADL hold authorization pending Seating Clinic verification of spec sheets – request must be in writing on 1251 under section 5.

### MANUAL WHEELCHAIRS OPTIONS ON ADULT WHEELCHAIRS

**Eligibility:** The AADL Eligibility Summary for Manual Wheelchair Benefits must reflect the clinical justification for each W code selected. Clients are eligible for additional funding using W-codes on adult wheelchairs **except for** upgrade grants, Tilt-in-Space (see note under OAD below) and High Weight Capacity Wheelchairs.

**Heavy Duty (HD) Packages:** Client's weight must support request for HD Packages (e.g., clients must weigh more than 250 lbs. to be eligible for HD1, more than 350 lbs. to be eligible for HD2, etc.) Client's weight must be on the 1251 form.

**One Arm Drive (OAD):** Client must be a full time user, have a unilateral U/E impairment and be independent in mobility (self-propelling).

A One Arm Drive Code (W105) may be added to the Tilt-in-Space manual wheelchair for self-propelling full time clients.

Not all wheelchairs accommodate HD packages or OAD. Ensure the model chosen is appropriate if adding either of these options.

**Costs:** AADL funds options based on Manufacturer MSRP and vendor discounts **UP TO** the maximum price listed. Clients are responsible for costs over the maximum price. Costs for HD options/packages and OAD are listed on individual wheelchair spec sheets.

V-codes are available for keyhole and K-backs only on new wheelchairs. Regular adjustable tension back upholstery for a new wheelchair must be ordered on the spec sheet.

## POWER WHEELCHAIRS

**Eligibility:** A Power Wheelchair Application is reviewed to determine if a client is eligible for power mobility. Tilt options eligibility is determined by the Tilt-in-Space Form attached to the application. All power wheelchairs must be prior approved by AADL. Refer to the Policy Manual for details on eligibility. Clients must be willing to accept a comparable substitute for power wheelchairs to be eligible for AADL funding. Contoured backs must be ordered through the seating clinic to be eligible for funding. The tilt option is funded for Adult clients only. High Speed Motors are not covered by AADL.

**Costs:** Clients are responsible for any upcharges or options not funded by AADL. These include seat elevators, power elevating legrests and foot platforms. See the WP-manual for a complete list of options not covered by AADL. Other options may be covered depending on clinical rationale. See W100 for Specialty Control coverage.

**Warranties:** Batteries: 1 year; Actuators: 18 months; Controllers/Joysticks/Motors: 3 years (manufacturers have until October 2018 to comply).

### POWER WHEELCHAIRS: PEDIATRIC

**Eligibility:** A Power Wheelchair Application is reviewed to determine if a client is eligible for power mobility.

All power wheelchairs must be prior approved by AADL. Refer to the Policy Manual for details on eligibility.

Clients must be willing to accept a comparable substitute for power wheelchairs to be eligible for AADL funding.

The tilt option on pediatric wheelchairs is considered an upgrade.

**Costs:** Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual power wheelchair spec sheets available on the AADL website and include seat elevators, power elevating legrests, and foot platforms. The tilt option is not funded for pediatric clients. Other options may be covered depending on clinical rationale. See W100 for Specialty Control coverage on page APL W-12.

Clients funded for Specialty Controls own the controls and must be willing to accept responsibility for repairs.

Clients are provided with one type of control and only one type of specialty control is funded. A client is not funded for both a basic joystick and specialty control.

A separate AADL 1251 form when the option is provided as a retrofit.

**Costs:** Clients are responsible for any upcharges or options not funded by AADL. Options for each type of power wheelchair on the AADL program are listed on the individual power wheelchair spec sheets available on the AADL website.
