#### **WHEELCHAIRS**

Wheelchairs are recycle benefits: Wheelchairs funded by AADL that are no longer required by the client are returned to the AADL Recycle Vendor to be recycled except upgrade wheelchairs that are considered client-owned. Refer to Policy Manual WM, ZN and ZR for processes.

**Eligibility:** Wheelchair eligibility is based on usage and clinically assessed needs, which determines the category funded by AADL. See eligibility under each category. Authorizers must upload the corresponding AADL Eligibility Summary form for each benefit type (A, B, C, tilt, heavy duty, grant).

Costs: Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual wheelchair specification sheets available on the manufacturer website. All AADL-funded wheelchairs must meet the equipment standards listed below.

Adult clients preferring a higher category (B or C) wheelchair than they are eligible for may be able to receive a grant of \$2,000 (subject to cost-share) to be used towards the purchase. These wheelchairs will be considered upgrade wheelchairs. Tilt-in-space wheelchairs may be considered in this process. See W-5 for grant wheelchairs.

#### Equipment standards for all AADL-funded wheelchairs:

- Wheelchairs must meet RESNA standards.
- Product must have been on the North American market for a minimum of one year.
- Manufacturer must have an active representative in the province includes regular visits to AADL vendors and availability for consults.
- Minimum warranties: Five years on frame and 12 months on wheels and casters.

#### MANUAL WHEELCHAIRS: ADULT CATEGORY A

Category A wheelchairs have a weight capacity listed with each chair. Using a heavy duty package will increase the weight capacity of the wheelchair. See W-6 for heavy duty chairs.

Eligibility (category A): Part-time wheelchair use or full-time indoor use with occasional outdoor use or for use as back up when power wheelchair is in for repairs.

Clients must be willing to accept a comparable substitute for Category A wheelchairs.

Authorizers: Inquire with the Recycle Vendor first to search the recycle inventory. Authorization type will be for either "recycle" or "new" equipment. New equipment can only be ordered after the recycle inventory has be searched and authorizer has received a written confirmation that there is no suitable equipment available.

Authorizers must upload the AADL Eligibility Summary for Category A Manual Wheelchair Benefits form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. Notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs: The maximum funding paid by AADL for an adult category A wheelchair is \$2,500, subject to cost-share, and includes the vendor discount. Clients are responsible for any upcharges or options not funded by AADL. Costs above this amount are the responsibility of the client. AADL funds repairs for wheelchair that are considered AADLowned.

Note: Funding for additional options on category A adult wheelchairs are separate. See APL W-16 for option codes for category A wheelchairs.

#### MANUAL WHEELCHAIRS: ADULT CATEGORY B

Category B chairs will not be ordered through recycle unless requested by the client, but must be returned to the Recycle Vendor when no longer required by the client.

Eligibility (category B): Full-time wheelchair use, independent mobility (able to self-propel indoors and outdoors). See Policy Manual WM: Manual Wheelchair Benefits-Adult/Pediatric for full eligibility.

Authorizers: Authorizers must upload the AADL Eligibility Summary for Category B Manual Wheelchair Benefits form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. Notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs: The maximum funding paid for a category B AADL wheelchair is \$3,300, subject to cost-share, and includes the vendor discount. Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual wheelchair spec sheets available on the manufacturer website. Costs above this amount are the responsibility of the client. AADL funds repairs for wheelchair that are considered AADL-owned.

#### MANUAL WHEELCHAIRS: ADULT CATEGORY C

Category C chairs will not go through recycle unless requested by the client, but must be returned to the Recycle Vendor when no longer required by the client.

Eligibility (category C): Full-time wheelchair use, independent mobility (able to self-propel indoors and outdoors) and has a risk of upper extremity overuse/injury. In addition, the client frequently (and independently) goes out in the community – at least four out of seven days a week.

Authorizers: Authorizers must upload the AADL Eligibility Summary for Category C Manual Wheelchair Benefits form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. Notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs: The maximum funding paid for a category C wheelchair is \$3,900, subject to cost-share, and includes the vendor discount. Clients are responsible for any upcharges or options not funded by AADL. These are listed on the individual wheelchair specification sheets available on the manufacturer website. Costs above this amount are the responsibility of the client. AADL funds repairs for wheelchair that are considered AADL-owned.

Note: Funding for some additional options on category C wheelchairs are separate and are found under Wheelchair Options benefit codes on page APL W-16.

# MANUAL WHEELCHAIRS: GRANT WHEELCHAIRS GROUP: ADULT CATEGORY A and B Upgrade/Grant

Adult clients preferring a higher category (B or C) wheelchair than they are eligible for may be able to receive a grant of \$2,000 (subject to cost-share) to be used towards the purchase. This wheelchair will be considered an upgrade wheelchair. Tilt-in-space wheelchairs may be considered in this process.

Grants require prior approval from AADL. Approval status will appear on the Alberta Blue Cross online health portal following document submission.

**Authorizers:** Authorizers must upload the AADL Eligibility Summary – Wheelchair Grants form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. **Notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically.** Authorizations are not vendor specific.

All AADL-funded wheelchairs must meet the same equipment standards and must be from an approved manufacturer.

Clients are responsible for all maintenance, parts changes and repairs (refer to Policy Manual-WM: Manual Wheelchair Benefits-Adult/Pediatric for details).

Clients are not eligible for replacement for five years.

## MANUAL WHEELCHAIRS: GRANT WHEELCHAIRS GROUP: ADULT CATEGORY D

Eligibility (category D): Adults with a non-progressive condition only. Full-time wheelchair use, independent mobility (able to self-propel indoors and outdoors) and has a risk of upper extremity overuse/injury. In addition, the client frequently (and independently) goes out in the community (at least 4-7 days a week).

Clients eligible for category C wheelchairs may apply for the higher-level category D wheelchairs, and may be able to receive a grant of \$3,900 (subject to cost-share) to be used towards the purchase. This wheelchair will be considered an upgrade wheelchair. See Policy Manual-WM: Manual Wheelchair Benefits-Adult/Pediatric for further details. The client becomes the owner of category D wheelchairs.

Grants require prior approval from AADL. Approval status will appear on the Alberta Blue Cross online health portal following document submission.

**Authorizers:** Authorizers must upload the AADL Eligibility Summary – Wheelchair Grants form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. **Notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically.** Authorizations are not vendor specific.

Wheelchairs provided under category D must meet the wheelchair standards listed on page W-1.

Clients are responsible for all maintenance, parts changes and repairs (refer to Policy Manual-WM: Manual Wheelchair Benefits-Adult/Pediatric for details).

Clients are not eligible for replacement for five years.

Eligibility: Clients must weigh over 250 lbs. Clinical justification is required if a client is under 250 lbs. and needs a heavy duty wheelchair.

**Authorizers:** Inquire with the Recycle Vendor first to search the recycle inventory. Authorization type will be for either "Recycle" or "New" equipment. New equipment can only be ordered after the recycle inventory has be searched and authorizer has received a written confirmation that there is no suitable equipment available.

Authorizers must upload the AADL Eligibility Summary for Category A High Weight/Heavy Duty Manual Wheelchair Benefit Type form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. Notify the vendor when the authorization is submitted and approved as the vendor is no longer **notified automatically.** Authorizations are not vendor specific.

Costs: Costs are based on the manufacturer specification sheets and vendor discounts. Costs related to options for heavy duty wheelchairs are included on the manufacturer specification sheets.

For W153, W270, W151 and W114, you must add the appropriate heavy duty package for your vendor. The maximum price is \$2,500 plus the price of the HD option package. These four chairs are the only chairs eligible for W options on page W-16

New equipment can only be ordered after the recycle inventory has be searched and authorizer has received a written confirmation that there is no suitable equipment available.

Authorizers must upload the AADL Eligibility Summary for Category A High Weight/Heavy Duty Manual Wheelchair Benefit Type form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. **Notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically.** Authorizations are not vendor specific.

Costs: Clients are responsible for any upcharges or options not funded by AADL. Costs are based on the manufacturer specification sheets and vendor discounts. Costs related to heavy duty options are included on the manufacturer spec sheets.

High weight capacity wheelchairs are not eligible for W options listed on page W-16.

#### MANUAL WHEELCHAIRS: ADULT TILT-IN-SPACE (Includes Back/Headrest)

Tilt-in-space wheelchairs are provided to clients who are unable to maintain a sitting position with any other back types or seating device, or to clients with chronic wounds that cannot be managed in a non-tilt wheelchair using basic pressure redistribution strategies (pressure redistribution cushions, nutrition, incontinence management and regular repositioning). These wheelchairs are authorized with the back, seat and headrest included. Sizing is in 1" increments.

Eligibility: Clients must be willing to accept a comparable substitute for tilt-in-space wheelchairs.

Maximum weight capacity: See individual specification sheets for maximum weight capacities.

**Authorizers:** Inquire with the Recycle Vendor first to search the recycle inventory. Authorization type will be for either "recycle" or "new" equipment. New equipment can only be ordered after the recycle inventory has be searched and authorizer has received a written confirmation that there is no suitable equipment available.

Authorizers must upload the AADL Eligibility Summary for Category A Manual Wheelchair Benefit Type form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. Notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Costs: AADL pays \$2,500 or 51 per cent of the costs (subject to cost-share) for a tilt-In-space/recline wheelchair, whichever is greater to maintain AADL-ownership. Clients are responsible for the costs of any options not funded by AADL. These are listed on the individual wheelchair specification sheets available on the manufacturer website.

#### MANUAL WHEELCHAIRS: ADULT TILT-IN-SPACE (Base only)

Tilt-in-space wheelchairs are provided to clients who are unable to maintain a sitting position with any other back type or seating devices, or to clients with chronic wounds that cannot be managed in a non-tilt wheelchair using basic pressure redistribution strategies, such as pressure redistribution cushions, nutrition, incontinence management and regular repositioning.

Adult tilt-in-space wheelchairs in this section do not come with a back or headrest. Level A Authorizers may authorize these wheelchairs bases. Authorizers then choose the back, seat and headrest as Level A components or refer to Level B or C Seating Authorizers for Level B or C components.

Clients must be willing to accept a comparable substitute for Tilt-in-Space wheelchairs. Sizing is in 1" increments.

Authorizers: Inquire with the Recycle Vendor first to search the recycle inventory. Authorization type will be for either "recycle" or "new" equipment. New equipment can only be ordered after the recycle inventory has be searched and authorizer has received a written confirmation that there is no suitable equipment available.

Authorizers must upload the AADL Eligibility Summary for Category A Tilt in Space Base Only Manual Wheelchair Benefit Type form to Alberta Blue Cross online health portal to confirm client eligibility for funding assistance from AADL. Notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically. Authorizations are not vendor specific.

Maximum Wt. Capacity: See individual specification sheets for maximum weight capacities.

Costs: AADL pays \$2,500 or 51 per cent of the costs (subject to cost-share) for a tilt-In-space/recline wheelchair, whichever is greater to maintain AADL-ownership. Clients are responsible for the costs of any options not funded by AADL. These are listed on the individual wheelchair specification sheets available on the manufacturer website.

#### MANUAL WHEELCHAIRS OPTIONS ON ADULT WHEELCHAIRS

**Eligibility:** The corresponding AADL Eligibility Summary for Manual Wheelchair Benefits Type form submitted must reflect the clinical justification for each W-code selected. This includes elevating leg rests and angle adjustable footplates.

Clients are eligible for additional funding using W-codes on adult wheelchairs except for upgrade grants, tilt-in-space (see One Arm Drive below) and high weight capacity wheelchairs.

One Arm Drive (OAD): Client must be a full-time user, have a unilateral U/E impairment and be independent in mobility (self-propelling). Code W105 (One Arm Drive for Tilt-in-Space) may be added to the tilt-in-space manual wheelchair for self-propelling full-time clients.

Costs: AADL funds options based on manufacturer MSRP and vendor discounts up to the maximum price listed. Clients are responsible for costs over the maximum price. Costs for OAD are listed on individual wheelchair specification sheets.

#### **POWER WHEELCHAIRS**

**Eligibility:** Refer to Policy Manual WP: Power Wheelchair Benefits-Adult/Pediatric for details on eligibility. A Power Mobility Application form is required to determine if a client is eligible for power mobility. Tilt options eligibility is determined through the AADL Power Tilt-in-Space Request form, which must be attached to the application.

All power wheelchairs must be prior approved by AADL. Once the Power Mobility Application form is uploaded with the authorization to the Alberta Blue Cross Online Health Portal, it will be placed under "pending" and reviewed by AADL. Once approved, AADL will determine if the equipment will be new or come from the recycle inventory.

Clients must be willing to accept a comparable substitute for power wheelchairs to be eligible for AADL funding.

All private options, including no-charge options, are not covered for repairs by AADL. The tilt option is funded for adult clients only. High-speed motors and repairs to high speed motors are not covered by AADL.

Costs: Clients are responsible for any upcharges or options not funded by AADL. These include seat elevators, power elevating leg rests and foot platforms. See Policy Manual WP: Power Wheelchair Benefits-Adult/Pediatric for a complete list of options not covered by AADL. Other options may be covered depending on clinical rationale. See code W100 for Specialty Control coverage.
