All October 2009 updates are identified with the word "**Updated**" in the left-hand margin of the applicable page.

Significant Updates:

- **1. 2009/2010 Fiscal Correction Changes** (as communicated in the Deputy Minister's email on August 27, 2009)
 - a. **Section 1.13** (pg. 30-32) Socio-Economic Status Allocation
 - The allocation criteria have been updated and new indices implemented.
 - b. **Section 1.14** (pg. 33-35) Relative Cost of Purchasing Adjustment Allocation
 - New indices implemented.
 - c. **Section 1.27** (pg. 46) Fuel Price Contingency Allocation
 - This grant is discontinued effective September 1, 2009.
 - d. **Section 3.11** (pg. 67-69) Relative Cost of Purchasing Adjustment Allocation for Level 2 Private Schools
 - New indices implemented.
 - e. **Section 8.2** (pg. 92) Private ECS Operators
 - The base instruction rate has been reduced by 0.9%.
 - f. **Section 8.3** (pg. 93) Accredited Funded Private Schools
 - The base instruction and home education rates have been reduced by 0.9%.
 - g. **Section 8.4** (pg. 94-95) Funding reduction for school jurisdictions for the period September 2009 through March 2010.
- 2. Definition of "Independent Student"

Section: Glossary (pg. 154) – Definition revised to reflect that funded students, ages 16 to 20 and living apart from their parents, will be considered "independent students."
