EXISTING FACILITIES

1. GENERAL

1.1 Capitalized Terms

Capitalized terms used in this Schedule that are the same as the capitalized terms used in the Agreement to Design, Build, Finance and Operate Evan-Thomas Water and Wastewater Treatment Facilities Upgrade, Kananaskis Country, Alberta (the "**DBFO Agreement**") between Her Majesty the Queen in right of Alberta and the Contractor, as defined therein, and for clarity as defined in Schedule 18 (Technical Requirements) to the DBFO Agreement, have the definitions as set out in the DBFO Agreement or Schedule 18, as applicable, unless expressed otherwise

1.2 DBFO Agreement Reference

This Schedule is referenced in sections 1.1 and 1.3 of the DBFO Agreement.

1.3 Section References

Unless otherwise provided, references to section numbers are references to sections in this Schedule.

2. GENERAL DESCRIPTION

2.1 Evan-Thomas Water and Wastewater Treatment Plants and Associated Wastewater Collection and Water Distribution Systems

The Existing Facilities include the following:

- (a) the existing Evan-Thomas water treatment plant including, but not limited to, two existing raw water wells located adjacent to the said existing Evan-Thomas water treatment plant;
- (b) the existing Evan-Thomas wastewater treatment plant including, but not limited to, two existing aerobic sludge digesters;
- (c) the existing Barrier Lake Lagoons and Sludge Drying Beds;
- (d) the existing Kananaskis potable water reservoir;

- (e) the existing Evan-Thomas potable water distribution system, including the following components:
 - (i) pumping stations;
 - (ii) hydrants;
 - (iii) valves and valve chambers;
 - (iv) inter-connecting pipework up to the Existing Facilities End-users' service valves; and
 - (v) all other appurtenances to deliver and convey treated water to the following facilities within or adjacent to the Evan-Thomas Provincial Recreation Area:
 - (A) Kananaskis Village;
 - (B) Kananaskis Village Staff Housing;
 - (C) Mount Kidd R.V. Park;
 - (D) Kananaskis Golf Course;
 - (E) Kananaskis Emergency Services Centre; and
 - (F) Boundary Ranch;
- (f) the existing wastewater collection network, including gravity sewer mains, sewage manholes, and all other appurtenances to receive and convey sewage and untreated wastewater, except the following components which shall not form part of the Existing Facilities:
 - (i) any existing lift stations located at the following facilities within or adjacent to the Evan-Thomas Provincial Recreation Area:
 - (A) Mount Kidd R.V. Park;
 - (B) Kananaskis Golf Course;
 - (C) Nakiska Ski Hill;
 - (D) Kananaskis Emergency Services Centre; and
 - (E) Boundary Ranch;

- (ii) all existing wastewater collection infrastructure including, but not limited to, pipes, force and gravity mains located upstream of the said existing lift stations that collect and discharge wastewater into the said existing lift stations; and
- (iii) all existing lift station force and gravity mains that carry wastewater from the said existing lift stations to the existing 200 mm polyvinyl chloride sewer trunk main.

3. DRAWINGS

The Existing Facilities referred to in Sections 2.1(a) - (d) are as shown on Drawings 7-A-2.01 to 7-A-2.03 inclusive of Appendix A - Existing Facilities to this Schedule. The Existing Facilities referred to in Section 2.1(e) are shown on Drawings 12-B-2.01 to 12-B-2.19 inclusive and Drawings 12-B-2.37 and 12-B-2.38 of Schedule 12 Appendix B – Lands and Work Sites Drawings. The Existing Facilities referred to in Section 2.1(f) are as shown in Schedule 12 Appendix B - Lands and Work Sites Drawings. The Imit of the existing wastewater collection network referred to in Sections 2.1(f)(ii) and (iii) are shown in Schedule 18 Appendix A - Infrastructure and Existing Facilities Limits.

4. DRAWINGS PREVAIL OVER DESCRIPTIONS

In the event of any inconsistency between the descriptions of the Existing Facilities at Section 2 above, and the drawings included at Appendix A - Existing Facilities, Schedule 12 (Lands), or the drawings included at Appendix B - Lands and Work Sites Drawings, the drawings at Appendix A - Existing Facilities, Schedule 12, and the drawings at Appendix B - Lands and Work Sites Drawings, shall govern.
