(collectively, RCCC and SWS will be referred to as "the Parties")

WHEREAS RCCC is the owner of the "West Kakwa Camp", located at SW-30-63-5-W6M, in the M.D. of Greenview No. 16, which is a field camp providing temporary housing for workers in the Kakwa area south of Grande Prairie, and includes a wastewater treatment plant ("the Facility");

WHEREAS on March 10th, 2020, the Director issued this Enforcement Order No. EPEA-EO-2020/02-PR, to the Parties jointly ("the Order") to provide interim authorization for the operation of the Facility in accordance with attached terms and conditions set out in Schedule 1 to the Order, while Alberta Environment & Parks is reviewing an application for an approval to operate under *EPEA*;

WHEREAS on March 10th, 2020, SWS was the operator of the Facility at the West Kakwa Camp on behalf of RCCC;

WHEREAS since that time, RCCC has advised the Director that SWS is no longer its operator and it has replaced SWS with a new contract operator for the Facility;

WHEREAS the Director has also received internal advice from AEP staff reviewing the approvals application for the Facility that a decision on the application will not be made on or before September 1, 2020;

WHEREAS Jack McNaughton, Compliance Manager, Peace Region, (the "Director") is of the opinion that an amendment to this Order is required to remove SWS as a party, to extend the expiry date, and to insert a contravention reporting requirement in Schedule 1;

THEREFORE, I, Jack McNaughton, the Director, pursuant to Section 212 of the Act, DO HEREBY AMEND THIS ORDER AS FOLLOWS:

1. Sustainable Water Solutions Inc. ("SWS") is removed as a party from this Order.
2. All references to "the Parties" in Schedule 1 to the Order is amended to "RCCC".
3. Clause 2 of the Order is amended by extending the expiry date of the Order from September 1, 2020, to the soonest of September 1, 2021 or the date upon which RCCC is issued an *EPEA* approval for the Facility.
4. Schedule 1 to the Order is amended by adding the following new condition 5:
 5. RCCC shall immediately report to the Director by telephone any contravention of the terms and conditions of Schedule 1 at 1-780-422-4505.
