Message from the Minister



lberta is committed to being a good neighbour to the rest of Canada and to countries around the globe. The job of International and intergovernmental Relations is to help build and promote mutually supportive relationships. From hosting visiting delegations to supporting foreign missions to working with our colleague governments across Canada, this annual report details a world of achievements in 2005-06.

In its centennial year, Alberta had the privilege of chairing the Council of the Federation and hosting a highly successful meeting in Banff. We also chaired the Western Premiers' Conference in Lloydminster that brought western concerns to national attention. At a meeting

of First Ministers and Aboriginal leaders, Alberta confirmed its commitment to the health, well-being and economic participation of Aboriginal people.

Seven of Alberta's 15 twinned provinces accepted Premier Klein's invitation to visit Alberta and experience our centennial celebrations. The Premier also promoted Alberta energy in Bavaria, Germany, renewed our twinning relationship in Mpumalanga, South Africa, and reviewed health records management in Ireland.

In its first full year of operation, the Alberta Office in Washington, D.C. significantly raised Alberta's profile among decision and policy makers in the head office of Alberta's largest trading partner. The Premier emphasized Alberta's growing importance to the U.S. as a safe, secure and reliable source of energy, and promoted Alberta's film and tourism industries, during visits to Colorado and New York.

On the trade front, Alberta successfully concluded negotiations on the B.C.-Alberta Trade, Investment and Labour Mobility Agreement, signed on April 28, 2006. We continued our efforts with the federal government to resolve the softwood lumber dispute with the United States. Previous Minister Ed Stelmach attended the World Trade Organization Ministerial Conference in Hong Kong to promote Alberta interests, especially in agriculture.

As Alberta continues to redefine its place in a dynamic Canadian confederation and a changing world, we will build on the achievements of 2005-06. I invite you to visit the Ministry website at www.iir.gov.ab.ca to see how the foundations laid or strengthened in 2005-06 are being developed into new opportunities.

Management's Responsibility for Reporting

he Ministry of International and Intergovernmental Relations is a single entity and does not have regulated funds, provincial agencies or government entities as part of its operations.

The executives within the Ministry have the primary responsibility to ensure the Ministry complies with all relevant legislation, regulations and policies.

Ministry business plans, annual reports, performance results and the supporting management information are integral to the government's fiscal and business plans, annual report, quarterly reports and other financial and performance reporting.

Responsibility for the integrity and objectivity of the financial statements and performance results for the Ministry rests with the Minister of International and Intergovernmental Relations. Under the direction of the Minister, I oversee the preparation of the Ministry's annual report, including financial statements and performance results. The financial statements and the performance results, of necessity, include amounts that are based on estimates and judgments. The financial statements are prepared in accordance with the government's stated accounting policies.

As Deputy Minister, in addition to program responsibilities, I establish and maintain the Ministry's financial administration and reporting functions. The Ministry maintains systems of financial management and internal control which give consideration to costs, benefits and risks that are designed to:

- provide reasonable assurance that transactions are properly authorized, executed in accordance with prescribed legislation and regulations, and properly recorded so as to maintain accountability of public money;
- provide information to manage and report on performance;
- safeguard the assets and properties of the Province under Ministry administration;
- provide Executive Council, Treasury Board, the Minister of Finance and the Minister of International and Intergovernmental Relations any information needed to fulfill their responsibilities; and
- facilitate preparation of Ministry business plans and annual reports required under the *Government Accountability Act*.

In fulfilling my responsibilities for the Ministry, I have relied, as necessary, on the executive of the individual sections within the Ministry.

This section of the Ministry is composed of four teams working under the direction of an Assistant Deputy Minister.




The International Relations Section

Works with other Alberta government ministries to advance Alberta's strategic international interests, and develop and advance Alberta's international relationships. This section of the Ministry is composed of three teams working under the direction of an Assistant Deputy Minister.



The Trade Policy Section

Deals with domestic and international trade and investment agreements, negotiations and disputes affecting Albertans. It pursues policies that meet Alberta's objectives of reducing trade and investment barriers. This section of the Ministry is composed of four teams working under the direction of Alberta's Trade Representative.



The Corporate Services Section

Provides a variety of services to assist other sections of the Ministry in achieving their goals.

Through shared services arrangements with the ministries of Education, and Restructuring and Government Efficiency, the section coordinates provision of:

- · Financial services
- Human resource services
- Information technology services
- Administrative services

Financial, information technology and administrative services of this section also support the Ministry of Aboriginal Affairs and Northern Development.

The Corporate Communications Section

Provides a wide range of services to the Ministry, including writing support, strategic communications planning and issues management, media monitoring and media relations, advertising and printing services, responding to public inquiries, and coordination of the Internet home page at www.iir. gov.ab.ca. Staff members in this section are deployed to work in the Ministry by the Public Affairs Bureau.

SUMMARY OF KEY ACTIVITIES

GOAL 1: Promoting the interests of, and securing benefits for, Alberta as an equal partner in a strengthened, united Canada.

Meeting of First Ministers and National Aboriginal Leaders

First Ministers met with Aboriginal leaders from the five national organizations to discuss Aboriginal issues. The meeting focused on closing the socioeconomic and living standards gap between Aboriginal and other Canadians over the next 10 years. The final communiqué from the meeting reflects Alberta's priority of continuing to work with Alberta First Nations, Métis, and non-status groups and organizations to ensure that efforts to enhance the health, well-being and economic participation of Aboriginal people will result in better outcomes at the local level. Alberta will continue building upon these relationships as we move forward in our commitment to close the gap in the quality of life and living standards of Aboriginal people and other Albertans.

Council of the Federation

Alberta served as Chair of the Council of the Federation during 2005-06. As Chair, Alberta hosted the 2005 Council of the Federation annual summer meeting in Banff. The conference was attended by over 300 delegates, including Premiers, Ministers, officials, their families and media. At the highly successful Banff meeting, Premiers agreed to an ambitious agenda of initiatives for the Council of the Federation in the areas of transportation, post-secondary education and skills training, energy and crystal methamphetamine. During the year, the Council also established an Advisory Panel on Fiscal Imbalance to review and make recommendations on how to address the fiscal imbalance in Canada.

Western Premiers' Conference

Alberta had the privilege of hosting the 2005 Western Premiers' Conference in Lloydminster, Alberta. Western Premiers discussed several key issues of concern to western Canadians, including BSE, control of the mountain pine beetle, energy, transportation, post-secondary education and skills training, Canada-U.S. relations, emerging markets and crystal methamphetamine. Western Premiers successfully elevated many of these key issues to the national spotlight through the Council of the Federation.

Senate Reform Advisory Committee

The Ministry provided support for the Senate Reform Advisory Committee, which was comprised of Alberta's four elected Senate nominees. The advisory committee travelled across the country to meet with provincial and territorial representatives to discuss issues and opportunities in relation to Senate reform. The advisory committee submitted a report to Premier Klein on its consultations, and that report provided the foundation for a discussion among Premiers at the Summer 2005 Council of the Federation meeting in Banff. At that meeting, Premiers reiterated their concern that the current appointment processes for key national institutions, including the Senate and the Supreme Court of Canada, do not reflect the federal nature of Canada. Premiers also expressed their belief that the federal government must show leadership on these issues and has an obligation to engage in a discussion with provincial and territorial governments on these important issues.

GOAL 2: Promoting the interests of, and securing benefits for, Alberta from strengthened international relations.

Alberta Office in Washington, D.C.

In its first full year of operation, the Alberta Office in Washington, D.C., (AWO) has significantly raised Alberta's profile in the U.S. by promoting Alberta's energy sector, garnering major U.S. media coverage and facilitating meetings with high level U.S. policy makers. The AWO also provided leadership to the planning and execution of Alberta's participation at the 2006 Smithsonian Folklife Festival.

Premier's Mission to Colorado and New York

During the June mission to Colorado and New York, Premier Klein participated in the Western Governors' Association annual meeting, which provided an opportunity to discuss Canada-U.S. relations and to raise awareness among governors of issues and priorities important to western provinces. In New York, Premier Klein focused on marketing Alberta at meetings and events with Wall Street investors, analysts and business media. The Premier emphasized Alberta's growing importance to the U.S. as a safe, secure and reliable source of energy. Alberta's film and tourism industries also were promoted.

Centennial Celebrations and Alberta's Special Relationships

Delegations from seven of Alberta's special relationship provinces and states (Heilongjiang, Hokkaido, Khanty-Mansii, Lviv, Montana, Mpumalanga, and Saxony) accepted Premier Klein's invitation to visit Alberta in August to take part in a five-day program celebrating the province's centennial. In addition to the five-day program, the visit also provided an opportunity to strengthen bilateral relations. Premier Klein and Governor Zhang renewed the Alberta-Heilongjiang twinning agreement, and Premier Klein and Governor Olyinyk signed a Memorandum of Understanding establishing a new sister province relationship between Alberta and Lviv, Ukraine.

Premier's Mission to Germany, South Africa and Ireland

During the September mission to Germany, South Africa and Ireland, Premier Klein discussed opportunities to further Alberta-Germany commercial ties, promoted Alberta's energy industry at the World Petroleum Congress, renewed the Alberta-Mpumalanga twinning agreement, and reviewed the health records management system in Ireland with a view to assessing best practices for Alberta.

GOAL 3: Promoting the interests of, and securing benefits for, Alberta from greater trade and investment liberalization, both internationally and domestically.

Domestic Trade

Following the direction of the joint Alberta-B.C. Cabinet, and following extensive consultations with other departments, Alberta successfully concluded negotiations on the British Columbia-Alberta *Trade, Investment and Labour Mobility Agreement* (TILMA). This agreement has since been finalized and was signed at the Alberta-B.C. joint Cabinet session held in April 2006.

In response to the Council of the Federation direction to improve the operation of the *Agreement on Internal Trade* (AIT), Alberta continued to lead negotiations on the completion of the energy chapter, addressed gaps in the AIT, and recommended improvements regarding the AIT's dispute settlement mechanism. All of Alberta's proposals were well received and will be considered either for incorporation into the AIT, or as models for improving the AIT, at future meetings of the Committee on Internal Trade (CIT).

Canada-U.S. Softwood Lumber Dispute

Alberta continued in its efforts to resolve the softwood lumber dispute. The Government of Alberta worked with its legal counsel to defend provincial programs and to ensure that Alberta positions were reflected in legal challenges made by Canada in the World Trade Organization (WTO) and under the North American Free Trade Agreement (NAFTA).

In August 2005, an Extraordinary Challenge Committee established under the NAFTA upheld the decision of a NAFTA dispute resolution panel that compelled the U.S. International Trade Commission to reverse its finding that imports of Canadian softwood lumber posed a threat of "material injury" to U.S. producers. This should have led to the revocation of the U.S. countervailing and anti-dumping duty orders, and a refund of all duties collected. The U.S. unwillingness to abide by the NAFTA decision resulted in a suspension of Canada-U.S. discussions. Near the end of the reporting period, efforts resumed to find a basis for the resumption of discussions between Canada and the U.S.

World Trade Organization Negotiations

Alberta attended the World Trade Organization (WTO) Ministerial Conference in December 2005, as part of the Canadian delegation. At the ministerial conference, the Minister was able to meet with federal ministers, negotiators and delegations from other WTO members, and to promote Alberta priority issues (agriculture, trade remedy rules, and market access for services and industrial products). The outcome of the ministerial conference was an agreement to strive for agreement on the means (or "modalities") to conclude the WTO Doha Round of trade liberalization negotiations by July 2006.

Alberta participated in a federal/provincial/ territorial meeting of trade ministers prior to the Hong Kong Ministerial Conference to outline its priorities in these negotiations directly with the federal ministers.



Report of the Auditor General on the Results of Applying Specified Auditing Procedures to Performance Measures

To the Members of the Legislative Assembly

Management is responsible for the integrity and objectivity of the performance results included in the *Ministry of International and Intergovernmental Affair's 2005-06 Annual Report*. My responsibility is to carry out the following specified auditing procedures on performance measures in the annual report. I verified:

Completeness

1. Performance measures and targets matched those included in Budget 2005. Actual results are presented for all performance measures.

Reliability

- 2. Information in reports from external organizations, such as Statistics Canada, matched information that the Ministry used to calculate the actual results.
- 3. Information in reports that originated in the Ministry matched information that the Ministry used to calculate the actual results. In addition, I tested the processes the Ministry used to complete the results.

Comparability and Understandability

4. Actual results are presented clearly and consistently with the stated methodology and are presented on the same basis as targets and prior years' information.

I found no exceptions when I performed these procedures.

As my examination was limited to these procedures, I do not express an opinion on whether the set of measures is relevant and sufficient to assess the performance of the Ministry in achieving its goals.

INTEGRATED RESULTS ANALYSIS

The Ministry's financial performance was within budget targets for the fiscal year ended March 31, 2006.

Increases in Ministry expenses in 2005-06 over the previous fiscal year can be attributed to three main areas; intergovernmental meetings; the Alberta Office in Washington; and trade negotiations. Each of these areas corresponds to a Ministry Core Business and Business Plan goal.

Canadian Intergovernmental Relations

One-time funding of \$215,000 was provided for Alberta to host the Western Premier's Conference in Lloydminster in May 2005. In addition, one-time funding of \$695,000 was provided for Alberta to host the Council of the Federation meeting in Banff in August 2005. The actual cost to Albertan's for these events was \$138,000 and \$678,000, respectively.

The Canadian Intergovernmental Relations Core Business supports Goal 1 of the Ministry Business Plan. Significant activities undertaken in 2005-06 include Alberta's assumption of the chair of both the Premiers' Council of the Federation and the Western Premiers' Conference. As chair, Alberta was in a strong position to influence the intergovernmental agenda and to ensure that the main priorities identified by Premiers are consistent with Alberta's intergovernmental priorities. The Premiers' meetings hosted by Alberta were also excellent opportunities to showcase the province in its centennial year.

Other activities included working with Alberta ministries to develop coordinated and consistent government-wide strategies that advance Alberta's interests, developing strategies and policy options in conjunction with Alberta ministries with respect to key intergovernmental policy issues, and assisting Alberta ministries in the development of intergovernmental agreements.

The ongoing activities of the Canadian Intergovernmental Relations Core Business also support progress on Strategic Priority 1 of the Ministry Business Plan. Achievements on Strategic Priority 1 are chronicled over several years to demonstrate the long term nature of the Ministry's strategic priorities.

Client satisfaction with services provided by the Canadian Intergovernmental Relations Section exceeded the Ministry's target. The Ministry met its target of reporting 100 per cent of reports/narrative records from First Ministers' or Premiers' intergovernmental meetings in the annual report.

International Relations

The International Relations Core Business supports Goal 2 of the Ministry Business Plan. An increase in funding of \$380,000 annually was approved to support the operational needs of the Alberta Office in Washington, which in 2005-06 was in its first full year of operations. Among the many benefits of the Alberta Office in Washington, the office played a significant role in raising Alberta's profile as a leading supplier of secure energy to the U.S.

Other initiatives undertaken in 2005-06 included partnering with Alberta Community Development to prepare for Alberta's participation in the 2006 Smithsonian Folklife Festival in Washington, D.C. This marks the first time a Canadian jurisdiction has been featured in the 40-year history of the festival. Alberta used the platform created by the festival to stage a wide variety of other events in Washington to profile the province's strong economic, academic and cultural relationships with the U.S.

The International Relations Section also was involved in the planning and coordination of a number of the Premier's international missions, including the U.S., Europe and South Africa. As well, the International Relations Section was responsible for the planning and delivery of a program for seven delegations from Alberta's sister provinces that visited as part of Alberta's centennial celebrations, two missions to mark the 25th anniversary of Alberta's twinning with Hokkaido, Japan, and one mission to mark the 30th anniversary of twinning with Gangwon, Korea. These activities provided an opportunity to advance Alberta's strategic international interests and to further develop Alberta's international relationships.

The ongoing activities of the International Relations Core Business also support progress on Strategic Priority 2 of the Ministry Business Plan. Some of the ongoing activities include working with Alberta ministries to provide leadership and coordination for ministerial missions, advising Alberta ministries on the development of international government-to-government agreements, and coordinating translation and interpretation services for all ministries. Achievements on Strategic Priority 2 are chronicled over several years to demonstrate the long term nature of the Ministry's strategic priorities.

Client satisfaction with services provided by the International Relations Section exceeded the Ministry's target. The Ministry met its target of achieving 75 significant events/opportunities that advance Alberta's interests through the work of the Alberta Office in Washington. Twenty-five per cent of international mission expense reports for the Premier and Minister of International and Intergovernmental Relations were posted on the Ministry's website within two months of the mission's conclusion. The Ministry met its target of reporting 100 per cent of reports/narrative records from the Premier's international missions, transboundary meetings and newsletters produced by the International Governance Office and the Advisory Council on Alberta-Ukraine Relations.

Trade Policy

Additional ongoing funding of \$150,000 was provided to continue Alberta's involvement in the World Trade Organization (WTO) multilateral trade liberalization negotiations (the Doha Development Agenda). These negotiations are important to the economic health of Alberta, especially in our agricultural community. Resources were also applied to Alberta's successful challenge of Quebec's coloured margarine regulations under the dispute resolution proceedings of the Agreement on Internal Trade, and to the preparatory negotiations for the British Columbia-Alberta Trade, Investment and Labour Mobility Agreement (TILMA).

These activities took place under Goal 3 of the Ministry Business Plan, which calls on the Ministry to promote the interests of, and secure benefits for, Alberta from greater trade and investment liberalization, internationally and domestically. These activities were also undertaken in the context of Strategic Priorities 3 and 4 of the Ministry business plan. These long term priorities include: participating in international negotiations to advance Alberta's interests with important trading partners; expanding Canadian internal trade liberalization that promotes the free flow of goods, services, capital and labour across Canada; and building upon and enhancing the benefits from the Agreement on Internal Trade with like-minded Canadian jurisdictions.

Client satisfaction with services provided by the Trade Policy Section exceeded the Ministry's target. The Ministry met its target of reporting 100 per cent of reports/narrative records from international and domestic trade policy meetings in the annual report.

• May 4-6, 2005 – Lloydminster, Alberta

Meeting of First Ministers and National Aboriginal Leaders

First Ministers met with Aboriginal leaders on November 24-25, 2005, in Kelowna, British Columbia to discuss Aboriginal issues. The meeting was attended by the Prime Minister and the Premiers of each province and territory, as well as the five leaders of the National Aboriginal Organizations: Assembly of First Nations, Inuit Tapiriit Kanatami, Métis National Council, Congress of Aboriginal Peoples, and Native Women's Association of Canada.

Chief Sandford Big Plume of the Tsuu T'ina First Nation, representing Alberta Treaty Areas 6, 7 and 8, and Alden Armstrong, President of the Métis Settlements General Council, attended the First Ministers' Meeting as members of the Alberta delegation. Audrey Poitras, President of the Métis Nation of Alberta, attended as a member of the Métis National Council's delegation.

Education, health, housing, economic opportunities and relationships were on the meeting agenda. Alberta supports the overall goal of closing the socio-economic and living standards gap between Aboriginal and other Canadians over the next 10 years.

Along with Aboriginal Affairs and Northern Development, the Ministry coordinated Alberta's policy position and planning for the special meeting. The Ministry will continue to work closely with Aboriginal Affairs and Northern Development and with Alberta First Nations, Métis, and non-status groups and organizations to ensure that commitments made at the meeting result in better outcomes for Aboriginal people at the local level.

Council of the Federation

The Council of the Federation's objectives are to:

- Promote interprovincial/territorial cooperation and closer ties among members of the Council, to ultimately strengthen Canada;
- Foster meaningful relations between governments based on respect for the Constitution and recognition of the diversity within the federation;
- Show leadership on issues important to all Canadians.

The Council continues to be effective in advancing Alberta's issues within the Canadian federation. During 2005-06, Alberta continued to lead or co-lead on continuing Council work in the areas of BSE, appointments to national institutions, and the provincial/territorial role in international trade negotiations, agreements and fora.

Alberta's most significant role, however, was in its role as Chair of the Council of the Federation. As Chair, Alberta hosted a highly successful annual summer meeting of the Council of the Federation at Banff, Alberta, attended by over 300 delegates, including Premiers and their families, officials and their families, and media. The Ministry worked closely with a Volunteer Organizing Committee, which coordinated the work of almost 100 volunteers on the ground. Their work was instrumental in making the conference a great success.

Since its inception in December 2003, the Council of the Federation has brought about increased communication, cooperation and intergovernmental activity between provinces and territories.

At the Council's summer meeting in Banff, Premiers agreed to an ambitious agenda of initiatives. These included:

- the development of a national transportation strategy;
- a pan-Canadian strategy for post-secondary education and skills training;
- the establishment of a Council Committee on Energy; and
- work to combat crystal methamphetamine and other drug addictions, including sponsoring a national conference and undertaking a national awareness campaign.

At Banff, Premiers also discussed international trade and emerging markets, the need for a national pharmaceutical strategy, and softwood lumber. They were updated on the Council's ongoing work in: domestic trade flows, BSE, appointments to national institutions, the green economy, environmental assessment, and a provincial-territorial role in international trade negotiations, agreements and fora. Premiers also discussed improving Canada-U.S. relations, and hosted U.S. Ambassador to Canada David H. Wilkins to share perspectives and priorities.

Progress was made quickly on a number of Council initiatives agreed to at Banff. On December 8, 2005, the Council released its National Transportation Strategy, which identifies a strategic transportation network for Canada.

The Council also held a Summit on Post-Secondary Education and Skills to gather input from stakeholders across the country towards the development of a pan-Canadian strategy on post-secondary education and skills training. The Council also sponsored a national conference on January 30-February 1, 2006, in Saskatoon on preventing and treating drug addictions, including crystal methamphetamine.

The Council of the Federation also took steps this year to bring attention to the fiscal imbalance in Canada. On May 27, 2005, the Council established its Advisory Panel on Fiscal Imbalance to look at the underlying causes of fiscal imbalance and make recommendations on how to address it. The advisory panel submitted its final report to Premiers at the end of March 2006.

In order to support the work of the Council, the Ministry worked closely with other ministries in preparing for meetings and conferences, and providing briefing information for the Premier. The Ministry worked to support the Premier at conferences to help ensure that Alberta's priorities are not only met, but remain at the forefront of the Council's agenda. The Ministry has been instrumental in ensuring that Alberta is an active participant in the Council.

Intergovernmental Agreements

The Ministry assisted other provincial government ministries in negotiating and finalizing a number of intergovernmental agreements over the past year. A list of agreements concluded in 2005-06 is shown in Appendix 2. Based on the results of a joint Ministry-Office of the Auditor General review of the processes for handling intergovernmental agreements conducted in 2002-03, the Ministry successfully implemented its work plan to update its management of intergovernmental agreements. This included legislative changes that were made to strengthen the Ministry's intergovernmental agreement approval processes.

Municipalities and Infrastructure

The Ministry continued to work closely with Infrastructure and Transportation to secure federal support for the development of infrastructure throughout the province. Together with all provinces and territories, Alberta advocated strongly for major new infrastructure funding from the federal government more in line with the amount of revenue the federal government collects from its fuel tax. This led towards the creation of a bilateral agreement with the federal government that provides increased federal funding for municipal infrastructure under the federal New Deal for Cities and Communities.

As the federal government wants to develop new partnerships with municipalities through the New Deal, and as municipalities are an area of provincial jurisdiction, the Ministry worked with Infrastructure and Transportation, and Municipal Affairs to develop frameworks for positive federal relationships with Alberta and its municipalities. The Ministry assisted Infrastructure and Transportation in the drafting of bilateral agreements and continues to provide advice to Municipal Affairs and other ministries on issues related to federal involvement with municipal governments.

Alberta also joined other western provinces in developing a western transportation strategy to guide cooperative intergovernmental efforts in the area of infrastructure. This strategy offers the federal government the opportunity to invest a greater portion of fuel taxes in western infrastructure as a matter of national priority. This strategy was later expanded to the national level and endorsed by the Council of the Federation. The Ministry provided advice and assistance to Infrastructure and Transportation to establish agreements with B.C. that would increase cooperation and efficiency of management of border transportation issues, such as joint weigh scales and traveler information messaging.

Securities

Chaired by Alberta's Minister of Finance, provincial ministers responsible for securities regulation continued to work toward a better securities regulation system for Canada. In September 2005, rule and policy changes came into effect in provinces and territories (with the exception of Ontario) implementing the passport system of regulation. The passport system gives market participants access to capital markets in multiple jurisdictions by dealing with the regulator and the law of its principal jurisdiction. The system allows issuers and registrants to deal only with the regulator in their principal jurisdiction and exempts them from certain legal requirements in other provinces and territories. The Ministry provided advice and assistance, as Finance continues provincial leadership in regulatory reform.

Climate Change

In December 2002, the federal government decided to proceed with ratification of the Kyoto Protocol without the agreement of provincial governments. With Russia's ratification, the agreement came into force in February 2005. The Ministry has worked to limit the impacts of the Kyoto Protocol on areas of provincial jurisdiction and to ensure federal recognition of the need to limit the long term risks to investors and industry. The Ministry assisted Environment in the process of ensuring federal cooperation in Alberta's ongoing activities to implement an action plan on climate change and provided advice on intergovernmental issues related to the Kyoto Protocol.

Agricultural Policy Framework

The Ministry continued to work with Agriculture, Food and Rural Development and other ministries in collaborating with Agriculture and Agri-Food Canada to implement the Agricultural Policy Framework (APF). Revisions to the business risk management program were discussed to help farmers and others in agriculture deal more effectively with the vagaries of agricultural business operations and low commodity prices. The Ministry participated in a federal/provincial APF Advisory Committee and provided independent advice and assistance to Agriculture, Food and Rural Development to ensure that federal agricultural policies and programs reflect Alberta's strategic interests and priorities. The Ministry is also providing intergovernmental advice on the development and negotiation of a renewed APF by summer 2007.

Marketing Choice for Wheat and Barley Producers

Alberta continued to push for marketing choice for its wheat and barley producers. Amongst producer groups, farmers should have the option to sell their grain through either the Canadian Wheat Board or privately. The Ministry continued to work with Agriculture, Food and Rural Development to advocate for Alberta's position.

Security

Alberta continues to monitor world events and will take the necessary steps to protect Albertans, in cooperation with federal and municipal authorities. Under Alberta's Security Task Force, chaired by the Minister of International and Intergovernmental Relations, Alberta continues an ongoing review of security issues and put solid response plans in place.

MLA Committee on Strengthening Alberta's Role in Confederation

On November 15, 2003, Premier Klein appointed a nine-member MLA Committee on Strengthening Alberta's Role in Confederation. The committee was established to solicit Albertans' views about the status of federal/provincial relations, and how the relationship might be improved or changed. The committee also heard Albertans' ideas about how to strengthen Alberta's position within the Canadian federation. The committee's final report, released in August 2004, made 26 recommendations concerning a variety of federalprovincial issues, including Senate reform, health care, federal transfer payments and provincial/ municipal relations. Alberta released its response to the committee's report on October 19, 2004, in which the government accepted all 26 recommendations.

During 2005-06, the Ministry continued to work with other Alberta ministries to pursue appropriate follow-up actions to the committee's report and recommendations.

Senate Reform and Senate Nominee Election

Alberta remains committed to pursuing meaningful Senate reform. The Ministry continues to lead the government's efforts towards achieving comprehensive constitutional reform of the Senate of Canada, while in the interim, exploring and advocating non-constitutional options to democratize the Senate.

The Ministry provided support for the Senate Reform Advisory Committee, which was comprised of Alberta's four elected Senate nominees. In May and June 2005, the advisory committee travelled across the country to meet with provincial and territorial representatives to discuss issues and opportunities in relation to Senate reform. The advisory committee submitted a report to Premier Klein on its consultations, and that report provided the foundation for a discussion among Premiers at the Summer 2005 Council of the Federation meeting in Banff. At that meeting, Premiers reiterated their concern that the current appointment processes for key national institutions, including the Senate and the Supreme Court of Canada, do not reflect the federal nature of Canada. Premiers also expressed their belief that the federal government must show leadership and has an obligation to engage in a discussion with provincial and territorial governments on these important issues.

Child Care Negotiations

Through 2005, Alberta continued to negotiate with the federal government on a new child care agreement that would implement the federal Liberal government's 2004 election promises concerning child care. The Ministry worked closely with Children's Services during the negotiations. Although Alberta signed an Agreement in Principle on child care, this work came to a halt during the 2005 federal election. Following the election, the new federal Conservative government cancelled the Liberal's approach to child care. The Ministry continues to work with Children's Services as the new federal government's Universal Child Care Plan is implemented.

Regulatory Gap

Increasingly, the lack of regulatory schemes for developments on reserve lands is adversely affecting the economic well-being of Aboriginal peoples. The Ministry assisted and provided advice to Aboriginal Affairs and Northern Development in its analysis of new federal legislation (First Nation Oil and Gas Money Management Act and the First Nation Commercial and Industrial Development Act). With the passage of the new federal legislation, the Ministry now is providing advice on possible federal regulations, and on development of potential agreements to implement federal regulations.

PROGRESS ON STRATEGIC PRIORITY 1:

Successfully Conducting, Coordinating and Participating in Intergovernmental Negotiations and Discussions to Advance Alberta's Interests in Confederation

The focus of intergovernmental initiatives this past year was on three non-constitutional priorities identified by Premier Klein:

- Regular annual First Ministers' Meetings, with agendas that are jointly determined between Premiers and the Prime Minister, and standing items on health, trade, finance, justice and the economy;
- A formalized provincial role in international agreements related to areas of provincial jurisdiction; and
- 3. Consultations with provinces on federal appointments, including Senate appointments, that affect their jurisdictions.

The Ministry continued to advance these priorities throughout the year when working with other provinces (e.g. Western Premiers' Conference, Council of the Federation meetings, and more).

2003-04

June 2003

Western Premiers' Conference: Future First Ministers' meetings discussed. The Prime Minister later agreed to hold annual meetings of First Ministers.

January 2004

First Ministers' Meeting: Prime Minister committed to working with provinces to develop a framework for a provincial role in international agreements. Alberta and New Brunswick, representing provinces/territories, involved in discussions with federal minister of intergovernmental relations.

Council of the Federation Meeting: Premiers granted Alberta and New Brunswick a mandate to develop a position on a provincial role in federal appointments. Status report will be presented at the Council of the Federation meeting in July 2006.

2004-05

May 2004

Alberta/British Columbia Joint Cabinet Meeting: Five agreements were concluded (re: mutual assistance during public health emergencies or natural disasters; harmonized oil/gas regulations; environmental cooperation and harmonization; trade, investment and labour mobility; e-learning). Two agreements were signed before the meeting (re: mountain park traveller information; oil and gas sector skills training).

July 2004

Western Premiers' Conference: Premiers discussed possible action on a variety of issues including health care, BSE, securities, strengthening the federation and energy. Premiers drafted an open letter to the Prime Minister regarding the devolution of federal control over northern lands to the territories.

Meeting of Premiers and Aboriginal Leaders: Premiers met with national Aboriginal leaders to discuss Aboriginal health issues in anticipation of the September 2004 First Ministers' Meeting on Health Care.

Council of the Federation: Premiers discussed health care reform efforts aimed at improving health care services and outcomes. Premiers also discussed other issues including improving Canada-U.S. relations, domestic trade flows, BSE, literacy and appointments to national institutions.

September 2004

Council of the Federation: Possible reforms to the health care system were discussed.

Special Meeting of First Ministers and Aboriginal Leaders: First Ministers and Aboriginal leaders agreed on the need for an action plan to improve health services for all Aboriginal peoples, and adopted specific measures to close the gap between the health status of Aboriginal peoples and other Canadians.

First Ministers' Meeting on Health: First Ministers agreed on a 10-year, \$41 billion plan to strengthen health care across the country.

October 2004

Council of the Federation: Possible equalization funding arrangement was discussed.

First Ministers' Meeting on Equalization: First Ministers agreed on a \$33 billion, 10-year equalization deal that will increase support to the provinces and territories under the Equalization and Territorial Financing Formula (TFF).

March 2005

Alberta/British Columbia Joint Cabinet Meeting: The meeting resulted in initiatives and funding to mitigate mountain pine beetle infestation, and expand export gateways to Asia.

2005-06

May 2005

Western Premiers' Conference: Premiers agreed to prepare a comprehensive transportation strategy, to meet with western governors to advance Canada-U.S. relations, to build ties with emerging trade markets and to develop a national training strategy to address the issue of labour shortages. The Premiers also agreed to push the federal government to increase penalties for those trafficking in crystal meth.

August 2005

Meeting of Premiers and National Aboriginal Leaders: Premiers met with National Aboriginal Leaders in advance of the fall meeting of First Ministers and National Aboriginal Leaders. The National Aboriginal Leaders provided Premiers with an overview of the issues facing their peoples.

Council of the Federation: Premiers unveiled their comprehensive strategies to enhance transportation and infrastructure development, energy, trade, post-secondary education, prevention and treatment of drug addiction, and to address the fiscal imbalance. Premiers also reviewed progress and set out next steps for continued work on several key initiatives. This included national institutions, international negotiations, domestic trade flows, BSE, green economy, environmental assessment, and Alberta reported on its Senate nominee advisory committee's consultations with provincial and territorial governments for pursuing how future Senate appointments are made.

November 2005

Council of the Federation: Premiers discussed the upcoming First Ministers' Meeting with National Aboriginal Leaders, received an overview of the National Transportation Strategy, and received an update from Premiers Charest and McGuinty on the post-secondary education and skills training initiative.

Meeting of First Ministers and National Aboriginal Leaders: First Ministers and National Aboriginal Leaders developed a 10-year action plan to close the gap in living standards between Aboriginal peoples and other Canadians.

February 2006

Council of the Federation Meeting with the Prime Minister: This was an informal meeting to provide Premiers an early opportunity to establish a positive working relationship with the Prime Minister. First Ministers discussed their respective priorities and how they can work together to improve the lives of Canadians.

PERFORMANCE MEASURES FOR GOAL 1

The Ministry has two performance measures for Goal 1 for 2005-06. The Client Satisfaction measure is intended to assess client satisfaction with services provided by the Canadian Intergovernmental Relations Section. Narrative records and reports from First Ministers' and Premiers' intergovernmental meetings describe further progress to Goal 1.

1.a Client Satisfaction

A key element of the Ministry's success is the quality of relationships built with clients and partners, including other Alberta government ministries, other Canadian provincial and territorial governments and the private sector. To help advance Alberta's interests, these relationships must be developed and fostered over the long term. The Ministry's biennial client satisfaction survey is a key instrument for assessing the quality and effectiveness of these relationships. The last survey was conducted in January 2005. The next survey will be conducted in January 2007.

Clients are asked to rate service performance on a five-point scale, ranging from 1=very dissatisfied to 5=very satisfied.

The Ministry's target in 2005, and again in 2007, is to achieve a high satisfaction rating of 4.0 out of a 5.0 scale from the Ministry's key clients. In 2005, the Ministry exceeded its target with a 4.2 client satisfaction rating for services provided by Canadian Intergovernmental Relations.

Client satisfaction ratings are shown below. Results for all areas polled in the 2005 client satisfaction survey are detailed in Appendix 1. Comparisons to previous years' results are also shown.

The Ministry finds the semi-annual client survey useful in evaluating the satisfaction of key clients, both within and outside the Alberta government. While very positive results are evident throughout each of the six surveys completed to date, there are minor variations that generate internal review. Staff makes use of the information and feedback to consider their interaction with clients for the future.

1.b Narrative Records for Canadian Intergovernmental Relations

The Ministry documents its performance on key initiatives through publicly released reports or communiqués issued at the conclusion of major conferences led by the Premier or Minister. Communiqués from major intergovernmental meetings reflect the discussion and decisions made by Premiers. These reports assess how the province achieved its objectives.

The Ministry met its target of reporting 100 per cent of reports/narrative records from First Ministers' or Premiers' intergovernmental meetings.

Listed below are the narrative records for Goal 1:

Western Premiers' Conference (Lloydminster, Alberta, May 4-6, 2005)

At this conference, Premiers released two news releases. The releases focused on the top immediate economic priorities for the West, which included major improvements in transportation infrastructure, trade, energy, training and post-secondary education, and the importance of the northern territories in promoting trade in western Canada. Premiers also called for a national response to the devastation caused by the mountain pine and spruce bark beetles, gave special attention to the alarming spread of crystal methamphetamine across the country, and provided the location of the 2006 conference in Gimli, Manitoba.

Council of the Federation Meeting (Banff, Alberta, August 10-12, 2005)

This meeting resulted in three news releases:

One announced progress on a number of issues, such as the development of a National Transportation Strategy and a pan-Canadian Energy Strategy, creating and improving ties with new and emerging economies, and continued work with the federal government to address issues of national importance (e.g., Canada-U.S. relations, softwood lumber dispute).

Another identified several key initiatives, including a Summit on Post-Secondary Education as a first step to improve skills training and post-secondary education, expediting key elements of its National Pharmaceutical Strategy and a request for the federal government to appropriately meet its financial responsibility for funding catastrophic drugs, a three-step integrated and collaborative approach to address the increased use of crystal methamphetamine and other addictions, and key steps to tackle the fiscal imbalance.

The third set the location of the 2006 meeting in St. John's, Newfoundland and Labrador.

Meeting of First Ministers and National Aboriginal Leaders (Kelowna, British Columbia, November 24-25, 2005)

At this meeting, First Ministers and national Aboriginal leaders announced a 10-year dedicated effort to closing the gap in living standards between Aboriginal peoples and other Canadians. The proposal commits the federal/provincial/ territorial governments to address the serious conditions that contribute to poverty among Aboriginal peoples and to ensure that they can more fully benefit from and contribute to Canada's prosperity, while still recognizing and respecting the diverse and unique history, traditions, cultures and rights of the Aboriginal people. First Ministers and national Aboriginal leaders agreed that broad

indicators in education, housing and health will be used to assess progress. In addition, more specific measures and targets will be developed at regional and sub-regional levels.

Council of the Federation Presents New Vision for Transportation (December 8, 2005)

Premiers Gordon Campbell of British Columbia, John Hamm of Nova Scotia and Joe Handley of the Northwest Territories announced the Council of the Federation's call for a new partnership with Ottawa to ensure that Canada's transportation system is safe, secure and supportive to the global trading network. The Council outlined its plan with the release of the national transportation strategy document, Looking to the Future: A Plan for Investing in Canada's Transportation System. The strategy proposes a new transportation funding partnership, identifies a strategic transportation network, describes preliminary provincial and territorial priorities, and recommends changes to the policy framework.

CORE BUSINESS 2 – International Relations

GOAL 2:

PROMOTING THE INTERESTS OF, AND SECURING BENEFITS FOR, ALBERTA FROM STRENGTHENED INTERNATIONAL RELATIONS.

PREMIER'S MISSIONS

Premier's Mission to Germany, South Africa, and Ireland (September 22-October 4, 2005)

In Germany, Premier Klein met with the Frankfurt Economic Development Corporation and German businesses to discuss opportunities for further building Alberta-Germany ties. He also received first-hand information about the outcome of Germany's September 18, 2005, election and discussed the implications for Alberta-Germany trade and investment ties.

In South Africa, Premier Klein promoted Alberta's energy industry at the World Petroleum Congress (WPC) in Johannesburg. Premier Klein, joined by the Honourable Greg Melchin, Minister of Energy, promoted Alberta as a key supplier in meeting world energy demands and as a prime location for energy investment. They supported Alberta companies exhibiting and receiving awards at the WPC, and met with energy ministers and decision makers of key countries (e.g., India) to advance Alberta's bilateral interests. As a result of these meetings, the Indian Secretary of Petroleum and Natural Gas has encouraged Indian companies to consider investment in Alberta.

Premier Klein also undertook the first Premier's mission to Mpumalanga, Alberta's South African sister province. The Premier discussed with Mpumalanga's Premier, Thabang Makwetla, opportunities for further cooperation between Alberta and Mpumalanga (e.g., environmental management, agricultural processing and tourism) and renewed the Alberta-Mpumalanga twinning agreement. Premier Klein also toured a community centre in the municipality of Nkomazi that was based on an Alberta service delivery model.

In Ireland, Premier Klein met with the Irish health minister and visited a health facility. Ireland is an acknowledged leader in health infrastructure, where improved access to electronic health records has enhanced patient safety, delivered more timely treatment and streamlined billing. Premier Klein reviewed Ireland's health records management system with a view to assessing best practices for Alberta

Premier's Mission to Colorado and New York (June 10-17, 2005)

Premier Klein participated in the 2005 annual meeting of the Western Governors' Association in Breckenridge, Colorado. The meeting provided an opportunity to discuss Canada-U.S. relations and to raise awareness among governors of the issues and priorities important to western provinces. During a plenary session in which Premier Klein enquired about the impact of the BSE border closure on the U.S., U.S. Agriculture Secretary, Mike Johanns, revealed that thousands of jobs had been lost in the U.S. beef-processing sector. The Agriculture Secretary went on to urge the reopening of the border, indicating that the rest of the world was watching how the U.S. was treating its number one trading partner on BSE.

During a meeting with U.S. Energy Secretary, Samuel Bodman, Premier Klein highlighted Alberta's success in oil sands production and advised of Alberta's interest in partnering with the U.S. in clean coal technology. Premier Klein met with Governor Schweitzer of Montana, reiterating Alberta's goals of opening the border to Canadian beef and improving relations with Montana. A meeting with Governor Murkowski of Alaska confirmed their joint commitment to the Alaska pipeline and the importance of North American energy security.

In New York, Premier Klein focused on marketing Alberta via targeted meetings and events with Wall Street investors, analysts and business media. The Premier emphasized Alberta's growing importance to the U.S. as a safe, secure and reliable source of energy. Alberta's film and tourism industries also were promoted.

MAJOR INTERNATIONAL INITIATIVES

Planning for Alberta at the Smithsonian

Alberta International and Intergovernmental Relations, in collaboration with Alberta Community Development, led planning for Alberta's participation at *Alberta at the Smithsonian*. *Alberta at the Smithsonian* would mark the first time a Canadian jurisdiction is featured at the 10-day Smithsonian Folklife Festival (June 30-July 11).

While Alberta Community Development, in conjunction with Smithsonian curators, was responsible for developing the program for on-site events for the 10-day festival, the Ministry was responsible for organizing Alberta Week in Washington by developing a week-long series of off-site events (starting June 26), targeted at high-level decision makers, leading up to the festival. The Ministry planned sector-specific economic forums on energy, agriculture and technology; a gala dinner for a broad cross-section of Washington's political, cultural and business community; a forum at the Centre for Strategic and International Studies on the new leadership in U.S.-Canada relations; a congressional reception; and Canada Day and July 4 events. As well, the Ministry worked with partners, including Alberta universities and the cities of Edmonton and Calgary, as they developed their promotional events for Alberta Week in Washington. The Ministry also developed a partnership program and led a sponsorship drive to work with Alberta corporations, municipalities, institutions and organizations in support of Alberta at the Smithsonian

Centennial Celebrations and Alberta's Special Relationships (August 29-September 1, 2005)

Over the past 30 years, Alberta has entered into special relationships with 15 provinces and states around the world. Premier Klein invited the leaders of each of these special relationship provinces and states to visit Alberta in August to take part in the province's centennial celebrations. Seven jurisdictions (Heilongjiang, China; Hokkaido, Japan; Khanty-Mansii, Russia; Lviv, Ukraine; Montana, U.S.; Mpumalanga, South Africa; and Saxony, Germany) accepted the invitation and joined the Premier and Albertans for the centennial celebrations.

The Ministry developed a five-day program that showcased Alberta's strengths and culminated in the province's centennial celebrations on September 1. Key aspects of the program included a tour of oil sands operations in Fort McMurray hosted by the Minister of Economic Development, and the unveiling of a monument on the Legislature grounds by the Minister of International and Intergovernmental Relations to commemorate Alberta's twinning relationships.

In addition to the centennial celebrations, the visit also provided an opportunity to strengthen bilateral relations:

- Premier Klein and Governor Olyinyk signed a Memorandum of Understanding establishing a new sister province relationship between Alberta and Lviv, Ukraine;
- Premier Klein and Governor Zhang renewed the Alberta-Heilongjiang twinning agreement;
- Premier Klein and Governor Schweitzer of Montana discussed BSE and energy matters;

- Premier Klein and Premier Makwetla of Mpumalanga discussed possible governance projects; and
- Premier Klein and Vice-Governor Novitski discussed Khanty-Mansii's proposal for enhanced cooperation.

International Missions to Alberta

The Ministry worked with partners in Protocol; Alberta Economic Development; Alberta Agriculture, Food and Rural Development; and other ministries to develop strategically focused programs for 52 incoming delegations. Some of the visitors to Alberta were:

- Chairman of the Yamal-Nenets state legislature in Russia, the Honourable Sergey Kharyuchi and a 31-member delegation;
- Seven delegations (Hokkaido, Heilongjiang, Khanty-Mansii, Lviv, Montana, Mpumalanga, and Saxony) for Alberta's centennial celebrations;
- Governor of Gangwon, Korea, the Honourable Jin-Sun Kim and an 11-member delegation;
- Vice-Governor of Hokkaido, Japan, the Honourable Yoshinobu Yoshizawa and a five-member delegation; and
- Ambassadors and High Commissioners to Canada from Algeria, Cuba, the European Union, Israel, Kenya, Kuwait, Thailand and Tunisia.

UNITED STATES AND AMERICAS INITIATIVES

Alberta Office in Washington, D.C.

The Alberta Office in Washington is primarily policy-oriented, setting it apart from the other Alberta international offices that have a trade and investment mandate. The Alberta Office focuses on advancing Alberta's interests and views at the highest levels of government, including the U.S. Administration and Congress, and with business associations, think-tanks and Washington media that help shape U.S. policy and public opinion.

The office works with Alberta ministers, officials and the private sector in partnership with the Canadian Embassy to:

- provide information and analysis to Alberta on political and economic developments in Washington;
- contribute to the development of Alberta's
 U.S. energy, trade, agricultural and investment
 strategies;
- ensure Alberta's views and priorities are understood and factored into Canadian policies and initiatives;
- build Alberta's profile in the U.S. as a secure, safe and reliable supplier of energy, agricultural products and other goods and services; and
- promote the sale of Alberta products and services in the U.S., in cooperation with Alberta businesses and government.

In its first full year of operation, the Alberta Office was instrumental in securing meetings with key decision makers in Washington and played a significant role in several favourable developments in U.S. policy. The advocacy efforts of the office directly resulted in a reference to Alberta in the recently passed U.S. Energy Policy Act. The Alberta Office also prepared a written submission about Alberta's vast energy resources for a hearing by the House Sub-Committee on Energy and Air Quality. The Alberta Office regularly meets with stakeholders to maintain its effective advocacy efforts. For example, consultations were undertaken with the Canadian Cattleman's Association regarding the BSE issue and the anticipated rule for cattle over 30-months of age entering the United

The Alberta Office organized several notable missions to Washington, D.C. by Alberta's Ministers of Energy, Community Development, Restructuring and Government Efficiency, Solicitor General and Minister for Public Security. Of particular note were meetings the office arranged during missions by Alberta's Energy Minister, including meetings with the Secretary of Energy, Chief of Staff to Vice-President Cheney, Chairman of the Federal Energy Regulatory Commission (FERC), members of the Senate National Security Council, and assistant secretaries in the Departments of Energy and State.

One of the major goals of the Alberta Office in Washington is to encourage influential individuals to visit Alberta to gain a better understanding of the province. The Alberta Office successfully coordinated oil sands tours for Congressional staffers, the Canadian Ambassador to the U.S., and prominent members of the U.S. energy media. The office also arranged a tour of Alberta (Edmonton, Calgary and Fort McMurray) for senior officials from the International Monetary Fund, as well as a tour of Alberta (including some feedlots) for the Chair of the U.S. House Agriculture Committee and eight Congressmen.

The Alberta Office's location allows Alberta to regularly attend significant U.S. events such as the National Governor's Association reception at the Canadian Embassy and to present at events such as the World Energy Council's North American Forum. Alberta's established presence in Washington, D.C., also has been invaluable to Alberta's Smithsonian project team as they prepared for the 2006 Smithsonian Folklife Festival.

The office has generated unparalleled U.S. media coverage of Alberta and its key role in North American energy supply and security. News articles have appeared in major U.S. dailies, including *The New York Times, Wall Street Journal, Washington Times,* and *Washington Post*. The oil sands also were featured on the CBS newsmagazine, *60 Minutes*.

Pacific NorthWest Economic Region

The annual meeting of the Pacific NorthWest Economic Region (PNWER) was held in Seattle, Washington from July 14-18, 2005. The Ministry provided strategic coordination for Alberta's participation and promoted cooperation in key areas such as energy, agriculture, workforce development, transportation and border issues. At the conclusion of the meeting, the PNWER executive agreed to hold their next annual meeting in Edmonton in July 2006.

Alaska-Alberta Bilateral Council

The March 2006 meeting of the Alaska Alberta Bilateral Council (AABC) was held in Juneau, Alaska. Although energy and the gas pipeline were a key focus, the Council also examined other issues of common interest including transportation, Aboriginal issues and workforce development. Each of the four working groups developed work plans and were encouraged to maintain on-going dialogue. The Ministry coordinated Alberta's participation, which included private and public sector involvement.

Bilateral Meetings with Key Governors

The Premiers of Alberta, British Columbia and the Yukon met with Governor Murkowski of Alaska on two separate occasions (October 31, 2005 in Vancouver and March 28, 2006 in Anchorage) to discuss the Alaska natural gas pipeline. These meetings provided an opportunity to review the latest developments on the pipeline and share information regarding the priorities and objectives of each jurisdiction. A strategic action plan was developed to move the project forward.

Visit by President Fox of Mexico

In September 2005, Alberta welcomed President Vicente Fox of Mexico. The President's visit provided an opportunity to showcase the strong relationship between Alberta and Mexico, which is the province's fourth largest trading partner. Agriculture, energy and environment were among the key sectors highlighted at a lunch event hosted by the Minister of International and Intergovernmental Relations.

ASIA PACIFIC INITIATIVES

Alberta-Hokkaido Relations

To celebrate the 25th anniversary of the Alberta-Hokkaido sister province relationship, the Ministry planned and delivered a program for two anniversary missions.

From June 29-July 7, 2005, the Honourable Rob Renner, Minister of Municipal Affairs, on behalf of the Premier, led Alberta's official delegation to Japan to commemorate the 25th anniversary of the Alberta-Hokkaido sister province relationship and to celebrate the 35th anniversary of Alberta's Japan office. During the mission, Minister Renner renewed the Alberta-Hokkaido Volunteerism Exchange Agreement on behalf of the Alberta Wild Rose Foundation, promoted Alberta food products at a Canada food fair in Sapporo, represented Alberta at the Canada Day reception at the World Exposition in Aichi, and explored best practices in Japan's municipal governance model and emergency preparedness measures.

The Ministry also worked with the Alberta-Japan Twinned Municipalities Association to include a 22-member group from four Alberta municipalities (Stony Plain, Wetaskiwin, Bon Accord and Barrhead) as part of Minister Renner's delegation. The Ministry also continued its annual support to the Alberta-Japan Twinned Municipalities Association.

Minister Renner's mission was reciprocated by a Hokkaido delegation to Alberta from October 16-19, 2005, capping off the 25th anniversary of the Alberta-Hokkaido twinning. Hokkaido Vice-Governor Yoshinobu Yoshizawa and a five-member government delegation were accompanied by a 26-member group representing towns, schools and other areas involved in Alberta's twinning with Hokkaido. Highlights of the visit included a tree planting ceremony on the Legislature grounds by Vice-Governor Yoshizawa and Speaker Ken Kowalski, the signing of a renewed Alberta-Hokkaido twinning agreement and a new museum agreement by Vice-Governor Yoshizawa and Premier Klein.

Alberta-Gangwon Relations

From October 9-12, 2005, the Ministry hosted the visit of Gangwon Governor Jin-sun Kim and an 11-member delegation to mark the 30th anniversary of the Alberta-Gangwon sister province relationship and to celebrate Alberta's centennial. While 2004 marked the 30th anniversary, Governor Kim's visit was delayed until this year to coincide with the completion of a Korean-style pavilion. As a centennial gift to Alberta and to mark the 30th anniversary, Gangwon undertook the construction of an impressive and colourful pavilion on the grounds of the Royal Alberta Museum, overlooking the North Saskatchewan River. Highlights of the governor's visit included a tree planting ceremony on the Legislature grounds by Governor Kim and Mr. Wayne Cao, MLA Calgary Fort, and Governor Kim's presentation of the pavilion to Premier Klein in a dedication ceremony at the Royal Alberta Museum.

EUROPE INITIATIVES

Alberta-Germany Relations

The Ministry continued to work with various Alberta departments to raise Alberta's profile and strengthen relations with Germany. The Ministry provided support to Alberta Education as it hosted in March a visit from a 20-member Bavarian parliamentary delegation examining Alberta's performance on international education testing, and welcomed the Canadian Deputy Ambassador to Germany, Robert Vanderloo.

Alberta-Ukraine Relations

Alberta remained committed to the advancement of democracy in Ukraine, particularly as the people of Ukraine moved forward from the "Orange Revolution" of 2004 to the parliamentary elections of March 2006. The Ministry supplemented the work of the Canadian federal government and Ukrainian-Canadians by providing funding for election monitors to travel from Alberta to Ukraine for the March 26 elections.

One of the highlights of the visit of Alberta's special relationship provinces and states to Alberta's centennial was the signing of a Memorandum of Understanding (MOU) establishing a new sister province relationship with Lviv in western Ukraine by Premier Klein and Governor Olyinyk. The MOU focuses on strengthening ties in education, culture, farm management and reform, and education.

The Ministry continued to serve as the Secretariat for the Advisory Council on Alberta-Ukraine Relations (ACAUR), which held three meetings on August 11, 2005; September 26, 2005; and January 26, 2006. Priorities for the ACAUR include election monitoring in Ukraine and advancing cooperation between Alberta and Ukraine in intergovernmental cooperation, education, culture and agriculture.

Alberta-Russia Relations

From July 21-31, 2005, the Ministry welcomed a 32-member delegation from Yamal-Nenets, Alberta's sister province on the Arctic Circle in western Siberia, Russia. As a gift to Alberta on the occasion of its centennial, Yamal-Nenets mounted an impressive exhibition at the Klondike Days Exhibition in Edmonton. The delegation, led by the Honourable Sergey Kharyuchi, chairman of the Yamal-Nenets state legislature, included senior government officials, performers and craftsmen. As a part of the Klondike Days Exhibition, performers showcased the dancing and singing traditions of northern Russia's indigenous peoples and craftsmen conducted carving and beadwork technique master classes. The delegation also participated in a business roundtable hosted by the Leduc-Nisku Economic Development Authority, met with government officials, and jointly performed with local Aboriginal groups at the Canadian Native Friendship Centre.

INTERNATIONAL GOVERNANCE OFFICE

International Projects

Alberta's International Governance Office (IGO) worked with private sector and education institution partners on nine incoming delegations for the year (e.g., China, South Africa, Russia, Ukraine and Mexico). The office also participated in the negotiations of an agreement with the province of Shandong and the University of Alberta for future governance training.

Indian Institute of Public Administration MOU (September 22-October 9, 2005)

The IGO oversaw the planning and execution of MLA Shiraz Shariff's mission to India that resulted in the signing of a MOU with the Indian Institute of Public Administration. During the India mission, Mr. Shariff, as chair of Alberta's IGO Advisory Committee, promoted its services, explored potential partnerships with Indian organizations and state and municipal governments, and discussed Alberta's Emergency Management Response Centre and the technology used for provincial and municipal disaster management.

International Financial Institutions (IFI) Bootcamp (October 16-21, 2005)

The Ministry directed the development and execution of Canada's first-ever Workshop on IFI Proposal Development aimed at companies interested in bidding on contracts with International Financial Institutions. The workshop was designed to provide participants with the tools needed to bid successfully on contracts. The IFI Bootcamp pulled together 23 participants from across Canada and featured speakers from the World Bank, the Asian Development Bank, the European Bank for Reconstruction and Development, and the Inter-American Development Bank. The Ministry and Alberta Economic Development organized seminars on various aspects of the contract bidding process and arranged one-on-one coaching sessions.

PROGRESS ON STRATEGIC PRIORITY 2:

Successfully Promoting Alberta by Strengthened International Relations

U.S. Relations

The Ministry continued to strengthen relations with the U.S., Alberta's closest and largest trading partner. The key focus of discussions by the Premier and the Minister of International and Intergovernmental Relations in 2005-06 was raising awareness about the security of Alberta's energy supply and the reopening of the border to live cattle.

IIR Minister and Agriculture, Food and Rural Development Minister met with Canadian Embassy officials, U.S. Department of Energy officials, and officials from Montana and Alaska (Alberta Office in Washington, D.C., BSE, energy supply).

Premier met with U.S. Energy Secretary Bodman, Governor of Massachusetts, and Canada's new Ambassador to the U.S. McKenna (energy supply and security, expanded trade/investment, BSE, softwood lumber, Alberta Office opening).

Premier also promoted investment opportunities in New York with investors, analysts and business media.

Premier met with Governor Murkowski of Alaska, Minister of State for Intergovernmental Affairs van Dongen of British Columbia, and Premier Fentie of the Yukon in Anchorage, Alaska to discuss the construction of the Canadian segment of the proposed Alaska Pipeline.

Bilateral Relations with Other World Regions

Bilateral relations between Alberta and other world regions were initiated or enhanced through missions to and from Alberta. These missions paved the way for increased activity between Alberta and other world regions, including the signing of several MOUs.

PERFORMANCE MEASURES FOR GOAL 2

The Ministry has four performance measures for Goal 2 for 2005-06. The Client Satisfaction measure is intended to assess client satisfaction with services provided by the International Relations Section. The number of significant events/opportunities that advance Alberta's interests through the Washington, D.C. office are recorded, with a Ministry target of 75 events/opportunities in 2005-06. The Ministry also has a target of posting 100 per cent of the Premier's and Minister's international mission expenses on the Ministry's website within two months of the mission's conclusion. Narrative records and reports from major international meetings and missions describe further progress to Business Plan Goal 2.

2.a Client Satisfaction

A key element of the Ministry's success is the quality of relationships built with clients and partners, including other Alberta government ministries, and other Canadian provincial and territorial governments. To help advance Alberta's interests, these relationships must be developed and fostered over the long term. The Ministry's biennial client satisfaction survey is a key instrument for assessing the quality and effectiveness of these relationships. The last survey was conducted in January 2005. The next survey will be conducted in January 2007.

Clients are asked to rate service performance on a five-point scale, ranging from 1=very dissatisfied to 5=very satisfied.

The Ministry's target in 2005, and again in 2007, is to achieve a high satisfaction rating of 4.0 out of a 5.0 scale from the Ministry's key clients. In 2005, the Ministry exceeded its target with a 4.5 client satisfaction rating for services provided by International Relations.

Client satisfaction ratings are shown below. Results for all areas polled in the 2005 client satisfaction survey are detailed in Appendix 1. Comparisons to previous years' results are also shown.

The Ministry finds the semi-annual client survey useful in evaluating the satisfaction of key clients, both within and outside the Alberta government. While very positive results are evident throughout each of the six surveys to date, there are minor variations that generate internal review. Staff make use of the information and feedback to consider their interaction with clients for the future.

2.b Washington Events/Opportunities

(Target = 75 significant events/opportunities)

The Ministry exceeded its target of the Alberta Office in Washington (AWO) undertaking 78 significant events/opportunities. The AWO communicates with the department on an ongoing basis, reporting on its activities and highlighting significant events/opportunities, which are subsequently reported in the Annual Report. The term "significant" applies to an event or opportunity that advances Alberta's profile or interests in the United States in a meaningful way, with a particular focus on promoting strong Alberta-U.S. relations, relationship-building and establishing policy contacts in the U.S.

The list of significant events and/or opportunities during 2005-06 includes:

- Securing national American media coverage for Alberta energy in the New York Times, Wall Street Journal, Washington Times, Washington Post and 60 Minutes.
- Helping plan Alberta's participation in the 2006 Smithsonian Folklife Festival, including assisting with Alberta missions, liaising with the Smithsonian Institution, securing sponsorships, and planning complementary economic and policy initiatives.

- Establishing high level contacts and providing briefings on Alberta energy with U.S. government leaders, including the Senate and Senate committees, U.S. Governors, the Department of Energy, the House Committee on Resources, the House Subcommittee on Energy and Air Quality.
- Establishing numerous contacts with U.S. government officials to represent Alberta's concerns with the Western Hemisphere Travel Initiative.
- Promoting Alberta to New York's financial community by supporting a mission by Premier Klein.
- Supporting Canadian beef interests by helping monitor potential R-CALF supplementary legal action, by including Alberta views in a Canadian response to proposed additional cross-border cattle inspections, and by securing Alberta beef to demonstrate its safety and quality to over 1500 Canada Day guests at the Canadian Embassy.
- Helping organize separate oil sands tours by the U.S. Treasury Secretary, Congressional staffers, Ambassador McKenna, and key U.S. media that resulted in better understanding of Alberta's oil sands and major American media coverage.
- Arranging meetings between Alberta Ministers and U.S. government leaders, including the Secretary of Energy, the Senior Director of Border Security and Transportation Security, the Vice-President, and former President George Bush, Sr.

- Raising Alberta issues in a discussion on Canada-U.S. agriculture and forestry with the former U.S. Trade Representative and former U.S. Secretary of Agriculture.
- Helping Albertans stranded in the U.S. after Hurricane Katrina, and helping arrange and present Alberta's \$5 million donation to the Bush-Clinton Katrina Relief Fund.
- Working with the office of a senior Senator resulting in a U.S. bill on oil sands and oil shale development that proposed an Alberta-U.S. partnership. This bill became part of the 2005 U.S. Energy Policy Act.
- Making presentations on Canada-U.S. relations at forums and conferences, at a Canadian federal/provincial/territorial meeting, and at several American universities.
- Delivering keynote speeches on Alberta's energy industry, Canada/U.S. relations and American energy policy at a range of American and Canadian industry and government forums and conferences.
- Attracting senior U.S. politicians and officials to several Alberta forums and meetings, including the Global Business Forum in Banff.
- Helping plan and coordinate a visit to Alberta for International Monetary Fund officials to prepare the Canada chapter of the upcoming issue of World Economic Outlook.

CORE BUSINESS 3 – Trade Policy

GOAL 3:

PROMOTING THE INTERESTS OF, AND SECURING BENEFITS FOR, ALBERTA FROM GREATER TRADE AND INVESTMENT LIBERALIZATION, INTERNATIONALLY AND DOMESTICALLY.

Provincial Role in International Negotiations

In March 2004, the Council of the Federation directed provincial ministers to undertake efforts to develop a mechanism for full provincial/territorial participation in international trade negotiations, agreements and fora. Alberta and New Brunswick were designated as lead provinces for the exercise. Following consultation, a consensus provincial/ territorial framework document was concluded in May 2004, and sent to the federal government. No further federal/provincial/territorial meetings have been held since May 2004. In March 2006, the Ministry developed a consensus provincial/ territorial letter to the new federal government, outlining provincial/territorial concern with lack of progress on this initiative and proposing to start discussions from the basis of the May 2004 provincial/territorial framework. Provinces and territories continue to pursue federal re-engagement.

World Trade Organization (WTO)

Alberta pursued its interests in the current round of trade liberalization negotiations (the Doha Development Agenda) taking place under the World Trade Organization (WTO). A key outcome this year was the December 2005 Ministerial Meeting, which Alberta attended, and which set the parameters for what hopefully will be the final push to conclude the Doha round negotiations. Alberta further promoted its interests in a November meeting of federal/provincial/territorial ministers to discuss Canada's approaches to the WTO Ministerial Conference. As well, during the vear, the Minister forwarded letters on Alberta's agricultural and other trade interests. In July 2005, Alberta prepared a compilation of its many detailed submissions regarding trade remedy reform in the WTO. Alberta has provided extensive input to the Government of Canada as it prepares submissions for the WTO Rules negotiating group. Alberta also forwarded a paper on Alberta's non-agricultural market access priorities in November 2005. Alberta followed up on the December ministerial meeting with substantive commentary on its interests in the areas of agriculture, trade remedy reform, trade in goods, and trade in services. Alberta officials attended the WTO Public Symposium in April 2005 and had the opportunity to meet with WTO Secretariat staff and representatives of other WTO members.

Softwood Lumber

The Ministry continued to work with Sustainable Resource Development in ongoing efforts to resolve the softwood lumber dispute. Since May 2002, the U.S. has been collecting countervailing and anti-dumping duties on imports of lumber from Canada. At the end of the reporting period, the combined duty rate was approximately 10 per cent.

Canada has initiated several distinct legal challenges in the WTO and under the North American Free Trade Agreement (NAFTA) against U.S. rulings made in anti-dumping and countervailing duty investigations. Both the Ministry and Sustainable Resource Development have worked closely with Washington D.C.-based legal counsel to defend Alberta programs and to ensure that Alberta positions were reflected in overall Canadian legal arguments.

In August 2005, an Extraordinary Challenge Committee established under the NAFTA upheld the decision of a NAFTA dispute resolution panel that compelled the U.S. International Trade Commission to reverse its finding that imports of Canadian softwood lumber posed a threat of "material injury" to U.S. producers. This should have led to the revocation of the U.S. countervailing and anti-dumping duty orders, and a refund of all duties collected. The U.S.'s unwillingness to abide by the NAFTA decision resulted in a suspension of Canada-U.S. discussions. Near the end of the reporting period, efforts resumed to find a basis for the resumption of discussions between Canada and the U.S.

The Ministry and Sustainable Resource Development have also continued to conduct extensive consultations with industry, and have solicited input on issues related to the management of this dispute.

North American Free Trade Agreement (NAFTA)

The Ministry supported a number of NAFTArelated initiatives over the course of the year. In anticipation of the March 2006 NAFTA commission meeting, the Ministry developed and forwarded further proposals to the federal government on improving the North American relationship and NAFTA's institutions, focusing on trade remedy law reform and the more effective resolution of disputes. In June 2005, the Ministry forwarded its views regarding the Security and Prosperity Partnership of North America (SPP) and its relationship to the working groups and committees established under NAFTA. The SPP deals with practical steps to improve the economic relationship in North America to complement and enhance what has been achieved in the NAFTA.

Bilateral and Regional Free Trade Initiatives

The Ministry worked to ensure that Alberta's priorities were incorporated into Canada's sectoral, regional and bilateral trade initiatives during the year. Key initiatives included:

• Canada-Korea Free Trade Agreement

The Governments of Canada and South Korea announced the launch of bilateral free trade negotiations in July 2005. Alberta forwarded its preliminary views on these negotiations in March 2005. During the fiscal year, the Ministry continued follow the status of, and to represent Alberta's interests in, these negotiations.

Canada-European Union (EU) Trade Initiatives

These negotiations were launched in May 2005, following agreement on a framework In March 2004. During the reporting period, the Ministry met with officials from the European Union in February 2006, to discuss the Canada-European Union *Trade and Investment Enhancement Agreement* negotiations. The Ministry also continued to press for greater provincial involvement in the negotiations, since many of the issues under consideration involve provincial jurisdiction.

• Potential Canada-Japan Trade Initiative

Canada and Japan announced the development of a cooperative Joint Economic Framework in November 2005. One key element of this framework is a joint study on the facilitation of bilateral trade and investment. This study is to be submitted to Prime Ministers in November 2006. Alberta outlined its preliminary interests in this initiative in March 2005, and continued to monitor developments and represent Alberta's views, throughout the fiscal year.

Canada-U.S. Wheat Dispute

The U.S. imposed anti-dumping and countervailing duties on imports of hard red spring wheat from Canada in October 2003. The Ministry worked with Agriculture, Food and Rural Development and Washington, D.C.-based legal counsel, as well as other Canadian governments, to challenge a U.S. Department of Commerce subsidy ruling made with respect to the provision of governmentowned railcars. While a NAFTA panel upheld the Department of Commerce's ruling on this issue, the railcar subsidy was very small. During the reporting period, as a result of a ruling from another NAFTA panel, the U.S. International Trade Commission reversed its ruling that imports of Canadian hard red spring wheat were causing "material injury" to U.S. producers. As a result, the anti-dumping and countervailing duty orders were revoked in January 2006. However, by the end of the reporting period, the U.S. had not yet refunded the duties collected.

Canada-U.S. Live Swine Dispute

In April 2004, the U.S. Department of Commerce initiated countervailing and anti-dumping duty investigations against imports of live swine from Canada. In March 2005, the U.S. Department of Commerce ruled that Canadian federal and provincial governments were providing minimal subsidies to Canadian swine producers and the countervailing duty investigation was terminated. However, at the same time U.S. Department of Commerce found that Canadian exporters were dumping their product into the U.S. market.

In early April 2005, the U.S. International Trade Commission ruled that Canadian swine did not cause, or pose a threat of material injury to, U.S. producers. This effectively terminated the dispute and removed any risk of U.S. duties. The Ministry worked with Agriculture, Food and Rural Development and Washington, D.C.-based legal counsel to defend Alberta programs in the countervailing duty investigation. No Alberta programs were found to provide countervailable subsidies.

Aircraft Convention

In August 2004, the Ministry was requested to lead Alberta's involvement with the federal government on the *Convention on International Interests in Mobile Equipment as Applied to Aircraft Equipment*. Following a review of the convention, the Minister outlined Alberta's concerns in a letter sent to the Government of Canada in December. Following consultations with industry and affected government departments, a Bill to implement the convention was developed and introduced into the Legislature during the spring 2006 session. The Bill will come into force on proclamation to allow for consistent implementation of the convention across Canada.

UNESCO Draft International Convention on Cultural Diversity

In 2004, member countries of the United Nations Educational, Scientific and Cultural Organization (UNESCO) began negotiating an International Convention on Cultural Diversity. During the reporting year, the Ministry continued to coordinate the provincial review of this draft convention, corresponding with the federal government in May and November. The Ministry noted Alberta's support for cultural diversity, but noted the province's continued concern with the potential effect of the convention on Canada's existing international trade policy commitments and on areas of provincial jurisdictional responsibility. In January 2006, Alberta received formal written assurances from the federal government regarding the scope of the convention.

Research Studies

The Ministry contracted with the Western Centre for Economic Research at the University of Alberta to conduct a number of research studies on trade policy issues. These studies on Western Canadian export performance under free trade agreements and the effect of NAFTA tariff reduction harmonization on Alberta provide quantitative and qualitative information used to develop Alberta's priorities for trade negotiations and initiatives.

British Columbia-Alberta *Trade, Investment and Labour Mobility Agreement* (TILMA)

Following the direction of the joint Alberta and B.C. Cabinet in March of 2005, Alberta and B.C. continued negotiations towards a comprehensive Trade, Investment and Labour Mobility Agreement (TILMA) based upon the 2004 internal trade framework agreement. When completed, the TILMA will open new opportunities in the trade of goods and services between the two provinces, and will also open new investment opportunities and improve labour mobility. The agreement is a significant improvement upon the national Agreement on Internal Trade (AIT) in terms of trade liberalization. Both Alberta and B.C. support using it as a model in the work to improve the AIT. Negotiations were concluded in April 2006, at which time the agreement was signed at the joint Alberta-B.C. Cabinet meeting.

Council of the Federation Internal Trade Workplan Initiatives

Premiers at the February 2004 Council of the Federation (COF) meeting approved a workplan to improve the *Agreement on Internal Trade* (AIT). Alberta continues to lead the energy chapter negotiations, and is working with B.C. to address gaps in the AIT's coverage. The COF approved an internal trade workplan progress report in August 2005. Additionally, the Ministry prepared a proposal on enforcement mechanisms that will be discussed at the next meeting of the Committee on Internal Trade.

Committee on Internal Trade (CIT) Meeting

In June 2005, a ministerial meeting of the Committee on Internal Trade (CIT) was held. The Ministry ensured that Alberta's priorities, including the removal of local hiring restrictions in federal public service hiring practices, were identified and presented at the meeting. Ministers approved additional changes to the AIT's procurement chapter, further work to explore the harmonization of standards, and changes to how business subsidies are addressed under the AIT.

Alberta put forward recommendations to ensure that the scope and coverage of the Energy Chapter will focus on market access provisions for all energy goods and services. These recommendations were accepted by the CIT. Alberta and B.C. also received the committee's approval to review the AIT's general rules and sector-specific chapters in order to provide recommendations to broaden and streamline the AIT. The CIT also approved recommendations for improving the AIT's dispute settlement mechanism, including Alberta's proposals for a default mechanism for appointing panellists and a provision for reconvening the original panel to determine if a party has fully complied with its recommendations.

Disputes and Complaints under the Agreement on Internal Trade (AIT)

Alberta participated in a number of disputes concerning the internal trade practices of other jurisdictions in Canada.

· Edible Oils

In May 2004, the province started formal dispute procedures against the Ontario Edible Oils Products Act. This legislation protects Ontario's provincial dairy industry by prohibiting the sale in Ontario of a number of imitation dairy products, some of which are produced in Alberta. The AIT panel report was released in November 2004. The panel fully supported the Alberta position and determined that Ontario was not meeting its AIT obligations. Ontario repealed its Edible Oils Products Act in January 2005, but immediately introduced similar measures through amendments to its Milk Act. The Minister wrote to his Ontario counterpart in October 2005 to encourage full compliance with the AIT panel's report. As Ontario has not yet fully complied, the Ministry, in conjunction with Agriculture, Food and Rural Development, is considering all options available to address this ongoing problem.

Coloured Margarine

In July 2004, Alberta initiated formal AIT dispute procedures against Quebec's ban on the sale of margarine coloured the same pale yellow hue as butter. This restriction has caused economic injury for Alberta canola producers and processors and butter-coloured margarine producers. A dispute resolution panel was convened to hear this issue in May of 2005. The panel found that Quebec's regulation restricting the sale of butter-coloured margarine was in contravention of its AIT obligations and recommended that the regulation be repealed.

To date Quebec has not complied with the panel's recommendation and therefore the Ministry, in conjunction with Agriculture, Food and Rural Development, is considering all options available to Alberta.

Public Service Commission Hiring Practices

Alberta continued to express its concern over the federal Public Service Commission's use of geographic hiring criteria, a practice that prevents qualified candidates from applying for federal jobs solely on the basis of their geographic location. This matter was raised by Alberta at the most recent meeting of the Committee on Internal Trade, where Alberta's position received support from almost all jurisdictions. The Ministry, in collaboration with Human Resources and Employment as well as B.C., entered into consultations with the federal government on this issue in May of 2005. While a mutually satisfactory conclusion was not reached through consultations, the federal government has announced a program that will see the Public Service Commission use a national area of selection in the Ottawa region starting April 1, 2006, for all officer-level jobs. The federal government intends to expand the national area of selection to all officer-level jobs across Canada on April 1, 2007, following an impact assessment, and to all federal government job categories in December 2007, following a second impact assessment. Alberta will monitor the results of this plan and advocate for the Public Service Commission's hiring practices to become fully AIT compliant sooner than scheduled.

PROGRESS ON STRATEGIC PRIORITY 3:

Successfully Participating in International Negotiations to Advance Alberta's Interests with Important Trading Partners

The Ministry promotes Alberta's interests and priorities in international trade negotiations to which Canada is a party. Currently the most significant is the "Doha Development Agenda" round of trade liberalization negotiations, taking place under the World Trade Organization (WTO). These negotiations provide the opportunity to reduce barriers to Alberta's worldwide exports of agricultural and non-agricultural goods and services, and to reduce the impact of defensive trade remedy actions taken by other countries against Canada (such as U.S. actions against softwood lumber).

In 2005-06, the federal Minister of International Trade hosted a federal/provincial/territorial meeting to discuss Canada's approaches to the WTO Ministerial Conference, which the Alberta Minister attended. The Minister also attended the sixth WTO Ministerial Conference in Hong Kong, China as a part of the official Canadian delegation. These events allowed Alberta to press our key priorities in these negotiations directly with federal ministers and negotiators.

Minister participated in a federal/provincial/territorial meeting in preparation for the WTO Ministerial Conference and, separately, forwarded Alberta's views on key WTO issues and priorities for Alberta.

December 2005

Minister attended WTO Honk Kong Ministerial Conference.

PROGRESS ON STRATEGIC PRIORITY 4:

Building Upon and Enhancing the Benefits from the Agreement On Internal Trade with Like-minded Canadian Jurisdictions

The Ministry also pursues its trade and investment liberalization goals domestically, working to reduce trade barriers within Canada. The primary vehicle through which these efforts are made is the *Agreement on Internal Trade* (AIT).

The Minister of International and Intergovernmental Relations works with other Canadian ministers responsible for internal trade through meetings of the Committee on Internal Trade (CIT) and, more recently, through the provincial/territorial Council of the Federation (COF). The Ministry also consults with provincial stakeholders in internal trade promotion and expansion. Alberta is prepared to work bilaterally or regionally to improve trade and investment opportunities, as evidenced by the *Trade*, *Investment and Labour Mobility Agreement* Alberta entered into with British Columbia. The Ministry also defends Alberta's AIT interests and manages its involvement in disputes.

In 2005-06 under the direction of the COF, efforts focused on completing the provincial/territorial work plan to improve the operation of the AIT. Additional detail regarding domestic trade initiatives identified below can be found in corresponding Ministry annual reports at:

Minister co-chaired the Committee on Internal Trade meeting. Agreement reached on investment incentives and government procurement.

November 2002

Minister forwarded a proposal to B.C. on a bilateral trade enhancement agreement dealing with energy.

2003-04

October 2003

Alberta-B.C. Protocol of Cooperation signed; the provinces agree to work on a bilateral trade enhancement agreement.

November 2003

Alberta requested a dispute resolution panel on federal cost of credit provisions.

January 2004

Minister attended a Council of the Federation meeting on the AIT. Alberta proposed to improve the AIT and was designated lead jurisdiction for new negotiations.

2004-05

May 2004

Alberta and B.C. signed a Framework Agreement for the negotiation of bilateral trade enhancement. Alberta requested a dispute resolution panel on Ontario's *Edible Oil Products Act*.

June 2004

Panel ruled in Alberta's favour on discriminatory federal cost of credit provisions.

July 2004

Council of the Federation accepted the AIT work plan. Alberta requested a dispute resolution panel on Quebec's ban on coloured margarine sales.

November 2004

Panel ruled in Alberta's favour on the Ontario *Edible Oil Products Act*.

December 2004

Committee on Internal Trade (CIT) meeting held. Agreement reached on coverage of Crown corporations.

2005-06

May 2005

Alberta and B.C. began consultations with Canada over the federal Public Service Commission's use of geographic criteria in its hiring practices.

June 2005

Committee on Internal Trade meeting held. Panel ruled in Alberta's favour in challenge of Quebec margarine colouring regulation.

September 2005

Consultations with Canada over the federal Public Service Commission's hiring practices ended without a mutually satisfactory solution.

March 2006

Negotiations concluded on a comprehensive bilateral *Trade, Investment and Labour Mobility Agreement* with B.C., the results of which were presented for adoption at the April 2006 Alberta-B.C. joint Cabinet meeting.

PERFORMANCE MEASURES FOR GOAL 3

The Ministry has two performance measures for Goal 3 for 2005-06. The Client Satisfaction measure is intended to assess client satisfaction with services provided by the Trade Policy section. Narrative records and reports major trade policy meetings describe further progress to Business Plan Goal 3

3.a Client Satisfaction

A key element of the Ministry's success is the quality of relationships built with clients and partners, including other Alberta government ministries, other Canadian provincial and territorial governments, and the private sector. To help advance Alberta's interests, these relationships must be developed and fostered over the long term. The Ministry's biennial client satisfaction survey is a key instrument for assessing the quality and effectiveness of these relationships. The last survey was conducted in January 2005. The next survey will be conducted in January 2007.

Clients are asked to rate service performance on a five-point scale, ranging from 1=very dissatisfied to 5=very satisfied

The Ministry's target in 2005, and again in 2007, is to achieve a high satisfaction rating of 4.0 out of a 5.0 scale from the Ministry's key clients. In 2005, the Ministry exceeded its target with a 4.3 client satisfaction rating for services provided by Trade Policy.

Client satisfaction ratings are shown below, relating to each of the Ministry's goals (referred to as Program or Service Areas in the survey). Results for all areas polled in the 2005 client satisfaction survey are detailed in Appendix 1. Comparisons to previous years' results are also shown.

The Ministry finds the semi-annual client survey useful in evaluating the satisfaction of key clients, both within the Alberta government and outside of the Alberta government. While very positive results are evident throughout each of the six surveys, there are minor variations that generate internal review. Staff makes use of the information and feedback to consider their interaction with clients for the future.

3.b Narrative Records for Trade Policy

The Ministry documents its performance on key initiatives in support of Goal 3 through publicly released reports or communiqués issued at the conclusion of major trade policy meetings. These reports assess how the province achieved its objectives.

Publicly available status reports of meeting outcomes allow the public to track complex, long term issues. The mode of preparation for each report varies, and is explained with each example identified, but is generally prepared by the Ministry in consultation with others.

The Ministry met its target of reporting 100 per cent of reports/narrative records from major trade policy meetings.

Listed below are narrative records identified for Goal 3:

WTO Hong Kong Ministerial Meeting (December 13 – 18, 2005)

At the conclusion of this meeting, the Ministries of International and Intergovernmental Relations, and Agriculture, Food and Rural Development jointly issued a news release summarizing its outcome. Ministers recognized the modest progress that had been made, which included a commitment to end agricultural export subsidies by 2013 and to engage in sectoral negotiations on industrial goods. Countries also agreed to work towards further commitments in agriculture, nonagricultural market access, and services by April 2006. Alberta's Ministers attended the Hong Kong Conference to ensure that Alberta's priorities were reflected in Canada's approach to the negotiations.

Federal/Provincial/Territorial Committee of Ministers on Internal Trade (Quebec City, Quebec, June 6, 2005)

At this meeting, ministers renewed their commitment for federal/provincial/territorial cooperation on internal trade. They agreed to continue discussions on the energy chapter, approved the terms of an in-depth review of the AIT's dispute settlement procedures, and directed officials to prepare a report on the harmonization of regulations and standards for consideration at their next meeting.

NOTES TO THE FINANCIAL STATEMENTS

Year Ended March 31, 2006

NOTE 1

AUTHORITY AND PURPOSE

The Minister of International and Intergovernmental Relations operates under the authority of the *Government Organization Act, Chapter G-10, Revised Statutes of Alberta 2000.*

The purpose of the Ministry of International and Intergovernmental Relations is to lead in the development of government-wide strategies and policies for Alberta's relations with international governments and organizations; and federal, provincial and territorial governments in Canada.

NOTE 2

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND REPORTING PRACTICES

The recommendations of the Public Sector Accounting Board of the Canadian Institute of Chartered Accountants are the primary source for the disclosed basis of accounting. These financial statements are prepared in accordance with the following accounting policies that have been established by government for all ministries.

(a) Reporting Entity

The reporting entity is the Ministry of International and Intergovernmental Relations for which the Minister of International and Intergovernmental Relations is accountable. The Ministry Annual Report provides a more comprehensive accounting of the financial position and results of the Ministry's operations for which the Minister is accountable.

All departments of the Government of Alberta operate within the General Revenue Fund (the Fund). The Fund is administered by the Minister of Finance. All cash receipts of departments are deposited into the Fund and all cash disbursements made by departments are paid from the Fund. Net transfer (to) from General Revenues is the difference between all cash receipts and all cash disbursements made.

(b) Basis of Financial Reporting

Revenues

All revenues are reported on the accrual basis of accounting.

Expenses

Directly Incurred

Directly incurred expenses are those costs the Ministry has primary responsibility and accountability for, as reflected in the Government's budget documents.

In addition to program operating expenses such as salaries, supplies, etc., directly incurred expenses also include:

- amortization of tangible capital assets.
- pension costs which comprise the cost of employer contributions for current service of employees during the year.
- valuation adjustments which include changes in the valuation allowances used to reflect financial assets at their net recoverable or other appropriate value. Valuation adjustments also represent the change in management's estimate of future payments arising from obligations relating to vacation pay, guarantees and indemnities.
- grants are recognized when authorized and eligibility criteria are met.

Incurred by Others

Services contributed by other entities in support of the Ministry operations are disclosed in Schedule 5.

Assets

Financial assets of the Ministry are limited to financial claims, such as advances to and receivables from other organizations, employees and other individuals. The fair values of the cash and accounts receivable are estimated to approximate their carrying values because of the short term nature of these instruments. Fair value is the amount of consideration agreed upon in an arm's length transaction between knowledgeable, willing parties who are under no compulsion to act.

Assets acquired by right are not included. Tangible capital assets of the Ministry are recorded at historical cost and amortized on a straight-line basis over the estimated useful lives of the assets. The threshold for capitalizing new systems development is \$100,000 and the threshold for all other tangible capital assets is \$5.000.

Liabilities

Liabilities are recorded to the extent that they represent present obligations as a result of events and transactions occurring prior to the end of the fiscal year. The fair value of accounts payable and accrued liabilities is estimated to approximate their carrying value because of the short term nature of these instruments.

Net Liabilities

Net liabilities represent the difference between the carrying value of assets held by the Ministry and its liabilities.

NOTE 3

ACCOUNTS RECEIVABLE

Accounts receivable are unsecured and non-interest bearing.

NOTE 4

ADVANCES

Advances represent amounts provided to Ministry employees for travel expenses and are non-interest bearing and recoverable on demand.

NOTE 9

DEFINED BENEFIT PLANS

(in thousands)

The Ministry participates in the multi-employer pension plans, Management Employees Pension Plan and Public Service Pension Plan. The Ministry also participates in the multi-employer Supplementary Retirement Plan for Public Service Managers. The expense for these pension plans is equivalent to the annual contributions of \$541 for the year ended March 31, 2006 (2005 - \$402).

At December 31, 2005, the Management Employees Pension Plan reported a deficiency of \$165,895 (2004 - \$268,101) and the Public Service Pension Plan reported a deficiency of \$187,704 (2004 - \$450,068). At December 31, 2005, the Supplementary Retirement Plan for Public Service Managers had a surplus of \$10,018 (2004 - \$9,404).

The Ministry also participates in two multi-employer Long Term Disability Income Continuance Plans. At March 31, 2006, the Bargaining Unit Plan reported an actuarial deficiency of \$8,699 (2005 - \$11,817) and the Management, Opted Out and Excluded Plan an actuarial surplus of \$8,309 (2005 - \$3,208). The expense for these two plans is limited to the employer's annual contributions for the year.

APPENDIX 1: 2005 IIR Client Satisfaction Survey Results

Client Satisfaction Survey Results & Methodology

Objective

The objective of the Ministry is to keep the client satisfaction survey precise and succinct. The 2005 survey differed from the 2003 survey in that the survey was administered over the Internet. As a result, a question was added about the efficacy of the Internet survey process. The 2003 survey differed from the 2001 survey in that it did not include questions asked about Aboriginal relations. The government at that time had created a separate Ministry, Aboriginal Affairs and Northern Development (as of March 2001). Questions related to intergovernmental relations remained part of the 2003 survey to facilitate comparison between the results of previous surveys.

Given the scope of the survey and the demands it places on respondents, surveys are conducted every two years. The 2005 survey is the sixth such survey conducted since this performance measure was initiated in 1995.

To ensure useful and credible data, the Ministry follows these principles when conducting the survey:

- Surveys are conducted by a third party with the anonymity of respondents guaranteed.
- Selection of surveyed clients is inclusive (known critics are included).
- Questions are probing and related to Ministry goals and strategies.
- Survey results are used internally to improve business practices.

Target

The Ministry's target is to achieve a high satisfaction rating of 4.0 out of a 5.0 scale from the Ministry's key clients.

Methodology

The Ministry retained a consultant to coordinate the 2005 survey. The survey and mailing list were put together by the consultant with input from Ministry staff. The consultant directly contacted potential respondents through electronic mail or follow-up telephone call to seek responses.

A total of 342 clients were contacted by electronic mail on January 6, 2005, with a request to complete the survey by January 24, 2005. Of those notified, 281 were internal clients (provincial government) and 61 were external clients (non-government). Seventeen clients indicated they did not use the Ministry's services, resulting in an adjusted client base of 325.

Completed surveys were accepted up to and including January 26, 2005. By that date, 197 surveys had been received for an overall response rate of 61% (the 2003 response rate was 53% and the 2001 response rate was 54%).

The survey aims to collect feedback on client satisfaction in three areas described below. For each area, respondents are asked to rate service performance on a five-point scale, ranging from 1=very dissatisfied to 5=very satisfied.

1. Ministry Services

Clients are asked a series of questions about their satisfaction in four services areas: advancing Alberta's interests, coordination, strategic advice, and information. Responses to questions result in ratings on overall client satisfaction with these services.

2. Ministry Program Areas

Respondents are asked about their satisfaction with each of the three program areas of the Ministry (Canadian Intergovernmental Relations; International Relations; Trade Policy). This question was first added in 1999. Responses to questions result in ratings on overall client satisfaction with these program areas.

3. Overall Client Satisfaction

Respondents are asked a series of questions to assess their overall satisfaction with staff effectiveness and accessibility. Responses to questions result in ratings on overall client satisfaction of staff effectiveness/accessibility.
