On behalf of the Access Advisory Council, I am pleased to provide its 2007-2008 annual report. This report summarizes the Council's activities, as well as the development of the Access to the Future Fund in its second year of operations.

The Access to the Future Fund was created to enhance and expand opportunities for Albertans to participate in accessible, affordable and high quality advanced learning opportunities. In developing our advice and recommendations, Council members focused on ensuring the Access to the Future Fund assists adult learning providers in responding to the needs of learners, the economy and society in the most effective ways possible.

A key step in furthering our mandate was accomplished in 2007-2008 with the launch of the Innovation Fund program. This project-based program supports the Campus Alberta vision by funding innovative and collaborative approaches to increasing participation in advanced learning opportunities. Funding was provided for fifteen projects across Alberta, enabling publicly funded post-secondary institutions, community-based learning providers, Aboriginal colleges and other partners to begin implementing leading-edge initiatives.

The Access to the Future Fund continued to match donations through its Renaissance Fund program. Matching funding enhanced the sustainability of the advanced learning system by encouraging philanthropic contributions to post-secondary institutions. Additionally, the Renaissance Fund made its first matching payments in support of the Alberta Apprenticeship and Industry Training Board Family of Scholarships.

Over the past year, the Council has been aware of the development of the ministry's *Roles and Mandates Policy Framework for Alberta's Publicly Funded Advanced Education System* and the *Alberta Access Planning Framework*. These evolving directions have and will continue to inform discussions of the Council, including the development of its mandated third year review of the Access to the Future Fund. The Council is dedicated to continue working in a manner that is consistent with the evolving needs of the advanced learning system and that demonstrates that further investment in the Access to the Future Fund is a sound way to promote the principles of Campus Alberta.

# ACCESS TO THE FUTURE FUND OVERVIEW

The Government of Alberta created the Access to the Future Fund to enhance and expand accessible, affordable and high quality learning opportunities within the advanced learning system.

The Fund focuses on fostering collaborative and innovative approaches to increasing participation in advanced learning, as well as leveraging increased private-sector donations to post-secondary institutions. It provides matching grants and funds innovative projects focused on helping advanced education providers respond to the needs of learners, the economy and society in the most effective ways possible.

The Access to the Future Fund consists of two programs: the Renaissance Fund matching program and the project-based Innovation Fund.

Established in 2005 by the *Access to the Future Act*, the Access to the Future Fund receives income from an endowment currently valued at \$1 billion that is held within the Alberta Heritage Savings Trust Fund.

The Minister of Advanced Education and Technology administers the Access to the Future Fund based on advice and recommendations from the Access Advisory Council. Financial reporting, including the Access to the Future Fund audited financial statements, is incorporated into the ministry's annual report.

## ACCESS ADVISORY COUNCIL OVERVIEW

The Access Advisory Council provides strategic advice and recommendations to the Minister of Advanced Education and Technology regarding the Access to the Future Fund's objectives, operation and reporting.

The Council was tasked with the following deliverables when it was appointed in July 2006:

- developing application, evaluation and accountability processes;
- reviewing proposals and identifying projects to be funded;
- monitoring successes and outcomes of the Fund; and
- reporting on the Fund's activities.

In 2007-2008, the Council held quarterly meetings and met with a variety of stakeholders to accomplish the following:

- launch the Innovation Fund program, including developing recommendations to the Minister on projects to be funded;
- oversee the continued operation of the Renaissance Fund matching program;
- build relationships with stakeholders, including publicly funded post-secondary institutions, Aboriginal colleges, student organizations and others; and
- provide input for and increase understanding of government directions, including the *Roles and Mandates Policy Framework* and the *Public Agencies Governance Framework*.

# PROGRAM HIGHLIGHTS

## *Renaissance Fund*

A total of \$42.5 million was disbursed through the Renaissance Fund matching program in 2007-2008. Over two years, this program has provided \$85 million in matching payments to the advanced learning system. Eligible recipients, who receive an annual allocation from the Renaissance Fund, have the autonomy to identify specific uses for their grants.

## *Innovation Fund*

The project-based Innovation Fund was launched in 2007-2008 to support innovative and collaborative ways to increase participation in advanced learning. A total of \$7.9 million was provided to fifteen projects across the province to:

- leverage technology to facilitate collaborative efforts that will increase access to and the quality of advanced learning opportunities, including establishing standardized technological capacity for community-based learning providers;
- engage and support learners from groups typically underrepresented in advanced learning opportunities through increased supports, preparation and tailoring of programming;
- enhance learner pathways by piloting and evaluating initiatives focused on facilitating the transitions between various levels of learning and the world of work; and
- explore new ways to increase the availability of health care training through collaborative approaches that enhance instruction and make training more readily available to learners.

## PROGRAM DETAILS ~ RENAISSANCE FUND

The Renaissance Fund provides matching grants designed to stimulate donations to the advanced learning system.

Eligible grant recipients include public post-secondary institutions, private university colleges, Aboriginal colleges and the Alberta Apprenticeship and Industry Training Board.

Each year, these eligible organizations are allocated a proportion of the total available funding and are given the flexibility to identify priority donations for matching.

In 2007-2008, \$45 million in new funding was allocated to the Renaissance Fund matching program. A total of \$42.5 million was disbursed following the review of submitted documentation. The remaining funds will be paid to eligible recipients in future years.

Minor amendments to the *Access to the Future Act* were made to facilitate the first matching payments in support of the Alberta Apprenticeship and Industry Training Family of Scholarships. Together with donations from industry, this grant resulted in the creation of 72 new apprenticeship scholarships.

# PROGRAM DETAILS ~ INNOVATION FUND

The Innovation Fund provides targeted investments aimed at boosting the creativity and innovative practices of advanced learning providers, motivating a spirit of collaboration throughout Alberta's advanced learning system and increasing Albertans' participation in advanced learning.

Launched in 2007-2008, the Innovation Fund provides project-based funding to initiatives selected through a competitive application process. Eligible organizations are invited to submit project proposals for review by the Access Advisory Council.

Nearly fifty proposals were submitted via the Innovation Fund application process in its inaugural year. The Council assessed these proposals based on the extent to which they would further the Innovation Fund's objectives related to innovation, collaboration and participation.

Following its review, the Council made recommendations to the Minister on projects to be funded. The Minister accepted these recommendations and \$7.9 million was provided to support fifteen projects across the province.
