Responsible Association:	Rocky Mountain House Grazing Association (privatized April 1, 1999) Looks after livestock and maintains the developed pastures in good, productive condition. Maintains all fence lines, dugouts, corrals and the buildings at the headquarters site. Provides bulls for the breeding program.
Grazing Season:	Mid-May to end of October
Cattle:	Approximately 4,900 Animal Unit Months (AUMs)

Within the reserve 5,594 acres (2,263.8 hectares) have been developed into tame pasture. There are several areas of muskeg in the middle section of the reserve; swamp spruce and poplar are the main trees.

The reserve features a unique design of irregular shaped developed pastures, intermixed with large treed areas that provide excellent wildlife habitat. The completed development was based on a multi-agency approved integrated resource plan. Only the developed fields are fenced, leaving a portion of the reserve that sees no livestock grazing.
