BEING CHAPTER W-3, RSA 2000 ("the Act")

WHEREAS Enforcement Order No. WA-EO-2018/06-UAR (the "EO") was issued to the Parties on May 7, 2018;

WHEREAS the EO required the Parties to, by June 30, 2018, submit to the Director a written Water Act Remedial Plan, which was to have completion dates of:

- July 31, 2018 for returning the Vegetation Removal Area to pre-disturbance conditions, and rendering Ditches A, B and C ineffective, including soil and revegetation remedial work; and
- September 30, 2018 for conducting remedial work related to the nine End Pit Lakes;

WHEREAS on June 19, 2018, the Parties' consultant sent to the Director a letter requesting that the:

- June 30, 2018 deadline for submitting the Water Act Remedial Plan be extended to July 13, 2018, to allow for additional time needed for assessment, planning and design work;
- (b) July 31, 2018 implementation date be extended to August 31, 2018, and
- (c) September 30, 2018 implementation date be extended to November 15, 2018;

WHEREAS the Director is of the opinion that the requests for extensions of the dates identified are reasonable to accommodate the work necessary to complete the requirements of the EO;

WHEREAS Todd Letwin, Regional Compliance Manager, Upper Athabasca Region, has been appointed a Director for the purposes of issuing and amending enforcement orders under the *Act* (the "Director");

THEREFORE, I, Todd Letwin, pursuant to section 135(1) and 136(1) of the Act, DO HEREBY ORDER THAT:

- 1. In Clause III of the EO, the date "June 30, 2018" be deleted and replaced by "July 13, 2018".
- 2. In Clause VII(A) of the EO, the date "July 31, 2018" be deleted and replaced by "August 31, 2018".
- 3. In Clause VII(B) of the EO, the date September 30, 2018" be deleted and replaced by "November 15, 2018".
