Re: Deciduous Pulp Dues Rates for the Period August 1 to August 31, 2014

This letter provides notice of Crown Timber and Forest Resource Improvement Association of Alberta (FRIAA) dues for deciduous pulpwood as established in the *Timber Management Regulation* and the *Forest Resources Improvement Regulation*.

Please submit your timber returns for the period August 1 to August 31, 2014 using the following rates:
