To be completed by a Certified Agency for applicants who are 18 years of age or older who are currently or recently homeless.

INSTRUCTIONS

- Complete all mandatory fields on the form. Please type or print all information legibly;
- Print the form double-sided and on the Certified Agency's letterhead;
- The applicant, the Certifier and the Certified Agency's Chief Executive Officer or designate must read and sign the form;
- Check off the applicable Certified Agency on the back page of the form;
- Retain a copy of the form for the Certified Agency's records;
- The applicant must bring the completed form and the appropriate fee to a Registry Agent when applying for an Alberta Identification Card. The Certifier must attend the registry agent office with the applicant and must present government-issued photo identification and proof of employment with a Certified Agency. The completed Identity Certification Form will serve as proof of the applicant's identity and residency in Alberta and proof of their legal entitlement to be in Canada.

Please note:

- The Identity Certification Form cannot be used to apply for an Alberta Operator's License.
- Acceptable forms of 'Proof of Employment' are: employee ID from the Certified Agency and a letter from the Certified Agency's CEO confirming the Certifier's employment.

ELIGIBLE APPLICANTS

Eligibility for the Identity Certification Form is limited to applicants who are: 1) residents of Alberta, 2) 18 years or older and 3) currently or recently homeless and 4) who have resided in Alberta for at least 90 days.

A resident of Alberta is a person who: is lawfully entitled to be or to remain in Canada; and makes his or her home in, and is ordinarily present in Alberta.

For the purpose of the Identity Certification Form someone is considered recently homeless if he or she was homeless at some time within the past six months.
