ENVIRONMENTAL PROTECTION ORDER NO. EPO-2014/04-SSR

WHEREAS Westar Landfill Ltd. ("Westar") is the owner and operator of the Westar Landfill located on the lands legally described as SE 31-12-4-W4M in Cypress County, Alberta (the "Landfill");

WHEREAS Environmental Protection Order No. EPO-2014/04-SSR (the "EPO") was issued to Westar Landfill Ltd. on April 8, 2014, and Amendment No. 1 to the EPO was issued on July 28, 2014;

WHEREAS Darren Bourget, Regional Compliance Manager, South Saskatchewan Region, has been appointed a Director for the purposes of issuing and amending environmental protection and enforcement orders under the Act (the "Director");

THEREFORE, I, Darren Bourget, the Director, pursuant to section 243 of the *Environmental Protection and Enhancement Act*, DO HEREBY AMEND the EPO AS FOLLOWS:

1. In Clause 2, repeal sub-clause d.
2. Insert new clause 2.1 which reads as follows:

2.1 On or before **July 31, 2015**, submit to the Director a management plan for the Removed Wastes (the "Removed Wastes Management Plan"). The Removed Wastes Management Plan must address the following:

- i. Whether the Removed Wastes are a potential source of windblown debris and any measures to prevent the offsite movement of any of the Removed Wastes,
- ii. Whether the Removed Wastes are suitable for use as daily cover at the Landfill,
- iii. A plan for the management or disposal of the Removed Wastes back into the Landfill or at an approved waste management facility, and
- iv. A proposed timeline for completing the actions described in the Plan.

3. In Clause 6, substitute "**August 31, 2015**" for "**June 30, 2014**".
4. In Clause 6d., substitute "**November 30, 2015**" for "**October 31, 2014**".
5. In Clause 8, substitute "**December 31, 2015**" for "**December 31, 2014**".
