These entities are part of the Alberta Government for GST purposes and therefore immune from payment of GST as set out in section 125 of the *Constitution Act of Canada*. These entities are also not required to pay the Harmonized Sales Tax (HST) on their purchases in HST-participating provinces. The list is maintained by Alberta Treasury Board and Finance, Tax and Revenue Administration.
